Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the financial statements of Indium Corporation of America Employees' Profit Sharing and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

1. Description of Plan

The following description of the Indium Corporation of America Employees' Profit Sharing and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of the Indium Corporation of America (the Company) who have met certain age and service requirements. A participant is eligible to make salary deferrals to the Plan upon reaching 18 years of age. In order to be eligible profit sharing contributions, participants must complete 1,000 hours of service during the service period as defined in the Plan Agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

Effective March 1, 2022 the Plan adopted and operates under the Empower Trust Company, LLC Defined Contribution Pre-Approved Plan. Empower Retirement, LLC serves as custodian of the Plan. The Plan is administered by Indium Corporation of America, which acts as the Plan Sponsor and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year participants may contribute up to 100% of their salary on a pre-tax, after-tax basis, or a combination of the two, subject to the maximum allowed by the Internal Revenue Service and as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at an initial rate of 6% of eligible compensation, increased annually until deferral rate reaches 10%, and their contributions are invested in a designated balanced fund until changed by the participant. For participants who elect to defer a percentage of their salary, a discretionary percentage of the participant's eligible salary is contributed by the Company. The Company matches the first 6% of employee contributions on a sliding scale up to 3.5% of eligible compensation.

The Company may also elect to make a discretionary profit sharing contribution. Participants are not required to make elective deferrals to participate in the profit sharing provision of the Plan. Employees must be employed on the last day of the Plan Year and have completed at least 182 consecutive days of employment during the Plan Year to be eligible for the profit sharing contribution. The profit sharing contribution made by the Company is credited to each participant's account based on the same proportion that the participant's compensation for the year bears to the total compensation of all participants for such a year. Discretionary profit sharing contributions to the Plan amounted to approximately \$1,754,000 for 2024.

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contributions, as well as allocations of the Company's profit sharing contributions, if eligible, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately on their elective deferrals plus actual earnings thereon. Vesting in the Company matching and profit sharing contributions, plus actual earnings thereon, is based on years of continuous service. For the Company matching contribution, the participant becomes 100% vested after three years of continuous service. For the Company profit sharing contributions, a participant's vested percentage increases by 20% of each year after the second year of employment, reaching 100% after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% above the prime rate, as defined. Only one loan may be outstanding for each participant at any given time. The loans must be repaid over a period not to exceed 5 years, unless it is used to acquire a personal residence, in which case the loan may exceed 5 years. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Participants or their beneficiaries are eligible to receive benefits under the Plan upon normal retirement, death, total and permanent disability, or termination for any reason other than those previously mentioned. Benefits are payable as a lump-sum amount or annual installments equal to the value of the participant's vested interest in his or her account. In service withdrawals are also permitted for certain financial hardships or when a participant attains age 59 ½, subject to the specific criteria set forth in the Plan Document.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$242,000 and \$140,000, respectively. These accounts are used to reduce future employer matching and profit sharing contributions or the Plan's administrative expenses. During 2024, approximately \$45,400 was utilized to reduce the 2023 profit-sharing contribution.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Risk and Uncertainties

The Plan invests in various investment securities. These investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants during 2024. There were no excess contributions payable at December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the US Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

- *Fixed Annuities*: Valued daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.
- *Variable Annuities*: Valued daily by the annuity provider according to the methods described in the annuity contract.
- *Collective Trust Funds*: Share Prices/NAV's reported on the Plan Summary Reports for Collective Trust Funds are generally obtained directly from the fund house or other investment provider.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

6. Related Party Transactions and Party-in-Interest Transactions

Empower Retirement funds a revenue credit account with revenue it receives from fund service providers. The Company may direct Empower to use the revenue credits to pay for the Plan's service providers, including Empower. During 2024, the Plan utilized approximately \$180,000 to offset administrative expenses of the Plan. Fees paid by the Plan to Empower, net of revenue credits, for investment management services and recordkeeping fees amounted to approximately \$332,000 for the year ended December 31, 2024.

8. Tax Status

The Plan is structured and follows a Defined Contribution Pre-Approved Plan, pre-approved by the Internal Revenue Service (IRS). The IRS issued an opinion letter dated November 14, 2022, indicating that the Defined Contribution Pre-Approved Plan is acceptable in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure within these financial statements.
