## **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Fulton Financial Corporation Employee Benefit Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

### **General**

The Plan is an employee welfare benefit plan covering substantially all eligible employees of Fulton Financial Corporation (the "Corporation" or the "Company") and its subsidiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

### **Benefits**

The Plan provides medical, vision, dental, and prescription drug benefits; flexible spending accounts, health savings accounts, life insurance benefits, long-term disability benefits, an employee assistance program, an adoption assistance program and a wellness program covering all full and part-time employees of the Corporation scheduled to work at least 30 hours per week and their dependents, as of the first of the month following completion of 30 days of active service.

The Plan also provides medical, prescription drug, and death benefits to certain retired employees who were full-time employees of the Corporation prior to January 1, 1998. The Postretirement Medical and Prescription Drug benefits for retirees were discontinued as of February 1, 2014 for any eligible employee who had not yet retired as of January 31, 2014.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes rebates to the Plan based on the Plan's actual utilization pattern of specific drugs.

### **Contributions**

The Corporation periodically contributes to the Plan amounts necessary for timely payment of all claims and reasonable administrative expenses of the Plan. The Corporation provides for stop-loss insurance over a specified amount as per agreement with the reinsurance carrier, with the premiums being paid by funds deposited in the Plan by the Corporation. Employee contributions represent a percentage of employee and dependent costs.

### **Retiree Contributions**

Retirees, if eligible, are covered by a fully insured plan. The premiums of the postretirement benefits under the Plan are shared by the Corporation and retirees and vary based upon many factors such as date of retirement and years of service.

### **Consolidated Omnibus Budget Reconciliation Act ("COBRA")**

The Plan is required to offer continuation of benefits for a specified period of time to qualified employees and their dependents who would not otherwise be eligible for continued coverage because of a particular qualifying event as required by law. Each qualifying individual pays his/her premium directly to the Plan. COBRA claims and other COBRA expenses are paid by the third-party administrator.

### **Administrative Expenses**

Certain expenses incurred in the administration of the Plan are paid from the assets of the Plan. The Company also pays certain expenses on behalf of the Plan. Expenses that are paid by the Company are excluded from these financial statements.

### **Stop-Loss Insurance**

The Company purchased stop-loss policies insuring the Plan, to a specific limit, in the event that claims relating to medical and prescription drugs benefits paid exceed approximately \$600,000 per individual case for both years ending 2024 and 2023. Benefits that exceed these amounts, if any, will be paid by the insurance company.

## **NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

### **Basis of Accounting**

The Plan presents its financial statements in accordance with the modified cash basis of accounting, which is a basis of accounting other than generally accepted accounting principles in the United States ("GAAP"). Under the modified cash basis of accounting, only contributions collected, costs and expenses paid, and assets and liabilities arising as a result of cash transactions or from the recognition of income due from insurance companies for claims are recognized. Therefore, accrued income and expenses, payables, and deferred expenses, which may be material in amount, are not reflected in the accompanying financial statements.

### **Cash**

For the purposes of the statements of net assets available for benefits - modified cash basis, cash is defined as demand deposits at a bank. Cash is a cash advance deposit account held by the claims processor. Plan management considers investments with a maturity date of 90 days or less to be cash equivalents.

### **Investment Valuation**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisers and custodians. The fair market value of the Plan's money market fund investment is based on quoted market prices at December 31, 2024 and 2023. See Note 6 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

### **Use of Estimates**

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results could differ from those amounts. The estimates of the Plan's post-retirement benefit obligation and incurred but not reported claims obligation are particularly subject to change in the near term. The post-retirement benefit obligation is heavily dependent upon the discount rate used to value the liability. Given that the discount rate determination is based on current bond rates that fluctuate daily, the estimated liability will be subject to fluctuation as of any valuation date.

### **Contributions**

Contributions are recorded when received by the trustee.

### **Benefit Payments**

Benefit claims and insurance premiums are recorded when paid; benefit claims are reported net of rebates received, which totaled \$5,179,411 and \$2,578,464 for the years ended December 31, 2024 and 2023, respectively.

## **NOTE 3 - RISKS AND UNCERTAINTIES**

Investments are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of postretirement benefit obligations are reported based on certain assumptions pertaining to interest rates, health care cost inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements. The Plan maintains a cash account, which, at times, may exceed federally insured limits. The amounts are in a custodial account and the Plan has not experienced any losses from maintaining cash accounts in excess of insured limits. Plan management does not believe that the Plan is exposed to any significant credit risks on its cash account.

#### **NOTE 4 - RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, modify the benefits provided to participants under the Plan, and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, any assets of the Plan will be used for the exclusive benefit of the plan participants.

#### **NOTE 5 - CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and interest income for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fulton Financial Advisors, N.A., the trustee of the Plan, and a qualified institution. The Plan's independent accountants did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedules.

The Plan was invested in a Money Market Mutual Fund with a fair value of \$1,731,301 and \$933,794 as of December 31, 2024 and 2023, respectively. Interest income for the years ended December 31, 2024 and 2023, totaled \$66,397 and \$48,998, respectively.

#### **NOTE 6 - FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs that represent quoted prices for identical instruments in active markets.
- Level 2 - Inputs that represent quoted prices for similar instruments in active markets, or quoted prices for identical instruments in non-active markets. Also includes valuation techniques whose inputs are derived principally from observable market data other than quoted prices, such as interest rates or other market-corroborated means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs that are largely unobservable, as little or no market data exists for the instrument being valued.

The Plan's investments in Money Market Mutual Fund is valued based on quoted prices on nationally recognized securities exchanges and is considered a Level 1 investment. There have been no changes in the methodologies used as of and for the Plan years ended December 31, 2024 and 2023.

The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023 relates primarily to the claims incurred but not reported to the Plan. Payment of future benefit obligation in excess of plan assets will be dependent upon future contributions from the Corporation.

Benefit obligations for claims incurred but not reported and claims payable are estimated by using methods that take into consideration prior claim experience, the expected time period from the date claims are incurred to the date the claims are submitted and paid.

Postretirement benefits include future benefits expected to be paid to or for currently retired or terminated employees and their beneficiaries and dependents. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Corporation and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service to the Company rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The discount rate used in determining the accumulated postretirement benefit obligation was 5.38% and 4.73% at December 31, 2024 and 2023, respectively. The average retirement age as of December 31, 2024 and 2023, ranging from 3% at age 55 to 100% at age 65. The mortality tables used in determining the accumulated postretirement benefit obligation was the Pri-2012 White Collar Table including rates for contingent survivors at both December 31, 2024 and 2023 with generational projection using scale MP-2021 at both December 31, 2024 and 2023. The changes in the aforementioned assumptions caused the decrease in the "Change in Actuarial Assumptions" for the year ended December 31, 2024 compared to December 31, 2023. Disability benefits were not assumed in the postretirement benefit obligation as the participants covered are retired.

The Plan was amended to a fixed cost/premium plan in 2015 thus there is no assumed future increase in health care costs incorporated into the actuarial present value of the expected postretirement benefit obligation. The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 (the "Act") for employers that sponsor postretirement healthcare plans that provide prescription drug benefits included a prescription drug benefit under Medicare as well as a federal subsidy to sponsors of retiree healthcare benefit plans that provide a benefit that is at least actuarially equivalent to Medicare Part D.1. Under the Act, the Medicare subsidy amount is received directly by the Company, and not the Plan. Further, the Company is not required to use the subsidy amount to fund postretirement benefits and may use the subsidy for any valid business purpose. As such, the Plan's accumulated postretirement benefit obligation and the changes in the benefit obligation do not reflect any amount associated with the Medicare subsidy. However, the amount of the accumulated postretirement benefit obligation related to the Plan is reported net of the Medicare subsidy in the Company's financial statements, resulting in a difference between the two measurements.

#### **NOTE 8 - TAX STATUS**

The trust established under the Plan to hold the Plan's net assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 and 2023 for unrelated business taxable income. The Corporation received a determination letter from the Internal Revenue Service on December 20, 2012. The Corporation believes the trust, as amended, is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 9 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Amounts paid by the Plan to parties in interest included fees paid for plan administration, investment management and actuarial services. The Plan's trust account is with Fulton Financial Advisors, N.A., the trustee of the Plan which is considered a party-in-interest. No fees were paid to Fulton Financial Advisors, N.A. by the Plan. Various administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### **NOTE 10 - SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 14, 2025, which represents the date the financial statements were available to be issued and there have been no material events that would require recognition in the financial statements or disclosures to the financial statements.
