Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan of APT Foundation, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the 403(b) Thrift Plan of APT Foundation, Inc. (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering employee of APT Foundation, Inc. (the "Foundation") as of their date of hire. The Plan was established effective January 1, 1987, in accordance with Section 403(b) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year, participants may contribute up to 100% of eligible compensation, as defined by the Plan, subject to Internal Revenue Service limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants may also contribute amounts representing distributions from other qualified plans.

The Foundation makes a matching contribution equal to 100% of each participant's elective deferrals, up to a certain percentage of their eligible compensation, determined based on the participant's age. In order to receive a matching contribution, participants must have attained age 18 and completed one year of service. The matching contribution is determined using the following table:

<u>Age</u>	<u>Percentage of Elective Deferrals Matched</u>	<u>Maximum Percentage of Compensation</u>
Less than age 40	100%	2%
Age 40 to 49	100%	4%
Age 50 and over	100%	6%

Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Foundation's contributions, and (b) Plan earnings, and is charged with their withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of their account to any of the investment options available under the Plan.

Vesting: Participants are immediately vested in their individual accounts at all times. participant is entitled to 100% of their vested account balance upon retirement, death or disability.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loans are secured by the balance in the participants' account and bear interest at rates commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

Plan Loans: Participants with funds held with Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF), collectively known as TIAA and CREF, were permitted to obtain plan loans. Plan loans were issued as separate contracts by TIAA and CREF as contemplated under IRC section 72(p)(5) and, accordingly, do not represent Plan assets. Loans are collateralized, if taken through TIAA and CREF, using a participant's TIAA Traditional Non-Benefit Responsive account balance in an amount equal to 110% of the outstanding loan balance. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's account balance, subject to an annuity contract and Plan provisions. Loan terms range from one to five years in one-year increments. Principal and interest are paid ratably by the participant to TIAA and CREF, with each payment reducing the amounts collateralized by the borrowing participant's TIAA Traditional Non-Benefit Responsive account balance. Plan loan balances outstanding from participants are not considered plan assets. The total plan loans outstanding as of December 31, 2024 and 2023 amounted to \$42,599 and \$40,916, respectively.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of their vested interest in their account. Benefit amounts under \$1,000 are automatically distributed to participants. Participants, or their beneficiaries in the event death, may elect to receive their vested account balances as an annuity, single lump sum, or in installment payments over a 10-year period. In certain circumstances, participants may make hardship withdrawals as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Administrative and Investment Management Expenses: Certain administrative expenses of the Plan are paid directly by the Foundation and are excluded from these financial statements. Fees related to the administration of participant-directed transactions are charged directly to the applicable participant's account and are included in administrative expenses. Investment management fees are reflected in the net depreciation in fair value of investments.

Plan Termination: Although it has not expressed any intent to do so, the Foundation reserves the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA and the Plan agreement.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than the fully benefit-responsive investment contract, are reported at fair value. Fair value represents the price that would be received by the Plan to sell an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date in the Plan's principal or most advantageous market for the asset or liability. The fully benefit-responsive investment contract is reported at contract value, as contract value is the amount Plan participants would generally receive when executing transactions under the terms of the contract and Plan provisions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes both realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at year-end.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments, that are exposed to various risks such as interest rate, market, liquidity and risks pertaining to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events: Subsequent events were evaluated for recognition and disclosure through October 10, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF and Charles Schwab Trust Bank, the custodians of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The fair value hierarchy prioritizes the inputs used to measure fair value, giving the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following represents the valuation methods and assumptions used by the Plan to estimate the fair values of investments. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Traditional Investment Contracts (Not Fully Benefit-Responsive): The TIAA Traditional Annuity Account consists of individual guaranteed fixed annuity investment contracts issued by TIAA ("Issuer"). Due to certain liquidity restriction provisions, some of the individual annuity contracts within the TIAA Traditional Annuity Account held by the Plan are not fully benefit-responsive and, accordingly, are measured at fair value.

TIAA and Plan management have determined contract value to be the most reasonable estimate of fair value for these contracts. Contract value represents contributions deposited into the contracts, plus interest credited to the contracts, less contract withdrawals, and reflects the value at which participant transactions are executed under the contracts. The contract value reflects the theoretical transfer (exit) value available to the Plan and plan participants. The fair values of the Plan's investment contracts have been estimated by TIAA by discounting the projected cash flows using risk-adjusted market discount rates which correlate closely with TIAA Traditional Annuity's historical interest crediting rates (generally 3% for current premiums on accumulating annuities, but in some recent contracts between 1% and 3% and provide the potential for additional interest as declared by TIAA's discretion).

The contract values are guaranteed by TIAA. Based upon recent credit ratings for TIAA, management believes no adjustment to contract value is required related to credit quality. Since investment contracts are not transferable, there is no market from which to obtain observable market prices for the contracts held by the Plan or comparable contracts (Level 3 inputs).

The Plan administrator is responsible for the review of the fair value estimates of Plan assets. The Plan administrator and management, or its designee, evaluates the fair value pricing methodology employed by TIAA and CREF for the Plan's guaranteed investment contracts to ensure a reasonable measure of market valuation has been utilized. The valuation approach is reviewed on an ongoing basis to confirm that the market values reported represent a reasonable exit price.

Variable Annuity Contracts: The fair value of the Plan's investments held in TIAA and CREF variable annuities is determined by obtaining quoted prices on the NASDAQ Stock Market (Level 1 inputs).

The fair value of the Plan's investments held in various annuities are valued at the net asset value of shares held by the Plan at year-end, where net asset values are based on the fair values of the underlying assets in each fund. Each variable annuity account permits daily redemptions by the Plan without advance notice requirements and has redemption prices that are determined by the accounts' net asset value per unit.

The underlying investment composition of the variable annuity accounts as of December 31, 2024, was 86% US equity funds, 7% balanced funds, 4% foreign equity funds, and 3% fixed income funds. The underlying investment composition of the variable annuity accounts as of December 31, 2023, was 82% US equity funds, 6% fixed income funds, 6% foreign equity funds, and 6% balanced funds.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The valuation methods described above may produce fair value estimates that are not necessarily indicative of net realizable value or reflective of future fair values. While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Plan investments measured at fair value on a recurring basis using significant observable inputs (Level 3) during the years ended December 31, 2024 and 2023 included \$116,339 and \$286,174 of purchases, respectively, and \$276,729 and \$257,724 of sales, respectively.

NOTE 5 - INVESTMENT IN STANDARD STABLE VALUE FUND

The Plan has an investment in a stable value fund, which is a group annuity contract with Standard Insurance Company that is fully benefit-responsive. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Under the terms of the contract, the issuer is contractually obligated to repay the principal plus interest at a specified guaranteed rate to the Plan.

NOTE 5 - INVESTMENT IN STANDARD STABLE VALUE FUND (Continued)

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the contract, as reported to the Plan by Charles Schwab Trust Bank. The contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily withdraw or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or for any other reason. The crediting interest rate is based on a formula agreed upon with the issuer. The contract value of the guaranteed investment contract amounted to \$2,427,662 and \$2,687,617 as of December 31, 2024 and 2023, respectively. The crediting interest rate for the contract, which will not be less than zero, is determined periodically by the issuer and was 2.60% and 2.45% as of December 31, 2024 and 2023, respectively.

Generally, there are not any events that could limit the ability of the Plan or its participants to transact at contract value. However, the Plan's investment contract with Standard Insurance Company specified certain conditions under which distributions may be postponed for up to six months. Such circumstances would be total withdrawal of the funds due to termination of the contract for any reason.

NOTE 6 - TAX STATUS

Effective October 1, 2023, the Plan was amended and restated from a volume submitter plan document to a pre-approved defined contribution plan document. There were no changes to the operations of the Plan as a result of this amendment.

The IRS issued an opinion letter to the pre-approved defined contribution plan sponsor dated March 31, 2017, as to the acceptability of the form of the pre-approved defined contribution plan under Section 401 of the IRC, pursuant to which the Company is entitled to rely to the extent set forth in applicable IRS guidance. The Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024, and 2023, that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan, the employer, and certain other related parties. Certain administrative functions are performed by officers or employees of the Foundation; however, no such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Foundation.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS (Continued)

The Plan's investments are all issued by TIAA and CREF or Charles Schwab Trust Bank, which are service providers to the Plan. Accordingly, these transactions with these entities, including the payment of fees, qualify as party-in-interest transactions. For the year ended December 31, 2024, the Plan paid fees and expenses to the Plan's recordkeeper and investment advisor, which also qualify as party-in-interest transactions. Notes receivable from participants also qualifies as exempt party-in-interest transactions.
