The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTE A - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AND GENERAL DESCRIPTION OF THE PLAN

#### **Significant Accounting Policies**

The significant accounting policies employed in the preparation of the accompanying financial statements are described below.

**Investments** - Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds with various investment strategies as well as a pooled separate account and insurance contracts as investment options for participants.

#### **Investment Valuation and Income Recognition**

Investments, other than fully benefit-responsive investment contracts, are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investments in certain TIAA Traditional Benefit Responsive, TIAA Plan Loan Default Fund and the Lincoln Stable Value Account are fully benefit-responsive investment contracts and are reported at contract value in the statement of net assets available for benefits.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments in the accompanying statement of changes in net assets available for benefits includes realized gains (losses) and unrealized appreciation (depreciation).

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Plan Expenses** - All expenses of the Plan were paid from the participants' individual accounts.

**Payment of Benefits** - Benefits are recorded when paid.

#### **Date of Management's Review**

Management has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.

#### **General Description of the Plan**

A general description of the WHYY, Inc. Defined Contribution Retirement Plan (the "Plan") follows. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering substantially all employees of the WHYY Inc, (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Each participant may contribute up to the lesser of \$23,000 in 2024 and \$22,500 in 2023, or 100% of the participant's compensation. Employer matching contributions equal 5% of compensation, up to a maximum participant compensation of \$345,000 in 2024 and \$330,000 in 2023, providing the participant makes elective deferrals equal to or exceeding 2.5% of their compensation. Participants who reach age 50 or older and contribute the maximum permitted under the Plan may elect an additional pre-tax contribution (a "catch-up contribution") of up to \$7,500 in 2024 and \$7,500 in 2023. In addition, special 403(b) catch-up contributions, not to exceed \$3,000 per year and a \$15,000 lifetime maximum, can be made by participants who have worked at least 15 years for the Company. Roth contribution are also allowed. Participants may also contribute amounts representing distributions from other qualified benefit plans via a rollover into the Plan. Eligibility for deferral and employer match for employees that are members of a collective bargaining unit are determined by the current negotiated agreement.

The Plan has automatic deferral of 2.5% effective 3/30/21.

**Notes Receivable From Participants** - A participant may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the participant's vested account balance and bear interest at a reasonable rate of interest. Loan term may not exceed five years, unless the loan is for the purchase of a participant's primary residence in which case the loan repayment period may not exceed 30 years.

**Participation** - An employee may become a participant of the Plan immediately after the start of service. To be eligible for employer matching contributions, an employee must have completed one year of service and have 1,000 hours of service during the plan year.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and the employer matching contribution, as well as an allocation of Plan earnings (losses). Participants have access to their accounts 24 hours a day/7days per week via a toll-free telephone number and a website. Fund transfers and investment election changes may be elected daily. A participant may stop, start, or change their 403(b) salary deferral rate at will.

**Vesting** - Participants are always 100% vested in their own salary deferral contributions, as well as the employer matching contributions.

**Payment of Benefits** - Upon termination of service due to death, disability, or retirement, a participant or their beneficiary, may elect to receive either an amount equal to the value of the participant's account or in periodic installments. For termination of service due to other reasons, a participant may receive the value of their account balance as a lump-sum distribution. In the event of a "financial hardship," an active employee may elect a withdrawal from their elective deferral contributions and matching contributions in annuity contracts.

**Plan Termination** - The Plan may be terminated at any time by the Company. In the event of Plan termination, distribution of participant accounts shall be in accordance with the Plan document.

**Forfeited Accounts** - Forfeitures of terminated participants' nonvested accounts may first be used to pay any administrative expenses. Any remaining forfeitures will be used to reduce the amount of future contributions required to be made to the Plan by the Company. At December 31, 2024 and 2023, there were no forfeited nonvested accounts. During 2024 and 2023, \$1,267 and \$0 of forfeitures were used to reduce employer contributions.

### NOTE B - ADMINISTRATION OF THE PLAN

The Plan is administered by a written plan and trust agreement, and the trustees of that agreement are responsible for management of the Plan's assets. All other matters concerning the operation of the Plan are the responsibility of the Administrator. The Administrator of the Plan is WHYY, Inc.

### NOTE C - TAX STATUS OF THE PLAN

The Plan participates in a Non-Standardized Pre-Approved 403(b) Plan sponsored by the Lincoln Retirement Services Company LLC. The Lincoln Retirement Services Company LLC has received a favorable opinion letter on November 29, 2024, from the Internal Revenue Service for the Non-Standardized Pre-Approved 403(b) Plan. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of Section 403(b) of the Internal Revenue Code and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the letter, but still in compliance with IRS requirements. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator is not aware of any action or series of events that have occurred that might adversely affect the Plan's qualified status.

### NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchased and sales) may occur daily.

Financial instruments that potentially subject the Plan to a concentration of credit risk consist primarily of temporary cash investments, a money market fund, registered investment companies, pooled separate accounts, and a guaranteed investment contract. The Plan maintains all of its cash investments with an investment company. The Plan has not experienced any losses in these situations.

### NOTE F - FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACTS

The Plan holds an investment in a guaranteed fixed annuity, specifically the TIAA Traditional Annuity. It is reported at contract value and segregated into a fully benefit responsive category.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by TIAA, represents the accumulated cash contributions, interest credited to the plan's contracts, and transfers, less any withdrawals or transfers.

### NOTE G - STABLE VALUE ANNUITY CONTRACT

The Plan invests in a fully benefit responsive guaranteed investment contract, the Lincoln Financial Group Annuity Contract, which is valued at contract value as estimated by The Lincoln National Life Insurance Company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The Lincoln National Life Insurance Company maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The value of the group fixed annuity contract is derived from the underlying contract provisions and contract value is assumed to approximate fair value. Assets in the Lincoln Financial Group Annuity Contract are held for the exclusive benefit of contract owners and are not subject to the claims of creditors or other general account policyholders.

#### **Limitations on the Ability of the Group Annuity Contract to Transact at Contract Value.**

The contract does not specify any events that would limit the ability of the Plan to transact at the full contract value. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The Lincoln National Life Insurance Company and TIAA may not terminate the contract at any amount less than the contract value.

### **NOTE H - PARTY IN INTEREST TRANSACTIONS**

Certain investments of the Plan are managed by the trustee, and, therefore, all transactions involving these investments qualify as party in interest transactions. In addition, the Plan issues loans to participants, which are secured by the balances in the participants' accounts. These transactions are exempt from the prohibited transaction rules.

### **NOTE I - SUBSEQUENT EVENTS**

Effective July 1, 2025, the plan was amended to change the employer match calculation. The participant must defer at least 2.5% of Plan compensation and the employer will match their deferral 100% up to 5% of compensation.

### **NOTE J - RELIANCE ON TRUSTEE'S REPORT**

The administration of the Plan chose the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Under that section, no auditing procedures are required to be performed with respect to the investment information certified by the trustees of the Plan, TIAA-CREF and Lincoln Financial Group, other than comparing such information to that contained in the financial statements and supplemental schedule.
