INDEPENDENT AUDITORS' REPORT

To the Board of Trustees and Members
Tallman Eye Associates, P.C. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tallman Eye Associates, P.C. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tallman Eye Associates, P.C. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Tallman Eye Associates, P.C. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Adoption Agreement and related Contract Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees who meet the eligibility requirements. Generally, employees are eligible to participate in the plan upon attaining age 21 and completing 12 months of service in which the employee works at least 1,000 hours for the Company. As defined by the plan, employees not eligible to participate are any residents of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Plan is administered by a written plan and trust agreement and the trustees of that agreement are responsible for management of the Plan’s assets. All other matters regarding the operation of the Plan are the responsibility of the Administrator. The Administrator of the Plan is Tallman Eye Associates, P.C.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the close of the taxable year are permitted to make catch-up contributions to the Plan. Employer contributions consist of a safe harbor matching contribution equal to a percentage of the amount of the salary reduction elected by the employee. Participants direct the investments of all contributions into various investment options offered by the Plan. The Plan currently offers twenty mutual funds as investment options. Contributions are subject to certain limitations.

Vesting

Participants are immediately and fully (100%) vested in the total contributions and actual earnings thereon allocated to their “elective deferral account.” Safe harbor matching contributions are 100% vested when made.

The vested interest in each participant’s “profit sharing contribution account” at any time prior to normal or early retirement age, death or disability, is determined by a six-year graded vesting schedule, as follows:

1.....	0%
2.....	20%
3.....	40%
4.....	60%
5.....	80%
6.....	100%

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant’s vested interest in his or her account and bear interest at a rate established by the Administrator in a nondiscriminatory manner. Principal and interest is paid ratably through bi-weekly payroll deductions. Interest on participant loans is recognized when received. Generally, the term of the loan may not exceed five years, unless it is for the purchase of a primary residence, in which case the term may not exceed twenty years. The maximum number of Plan loans outstanding at any given time is one.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant is to receive a lump-sum amount equal to the value of the participant's vested account balance upon participant or Beneficiaries request. The Plan allows hardship distributions subject to limits established by the Department of Labor. The Plan also provides for pre-retirement, in-service distributions to those participants who have reached age 59 1/2. If the participant meets this age requirement, a withdrawal in a lump-sum up to 100% of the vested interest in all available accounts is permitted.

Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified or 401(k) plans.

Forfeitures

Forfeitures are to be used to reduce future employer contributions when they exist. At December 31, 2024, there were no forfeitures of employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan have been prepared in conformance with accounting principles generally accepted in the United States of America. The following is a summary of its significant accounting policies:

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America. Investments held by a defined contribution plan are required to be reported at fair value.

Use of Accounting Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Accordingly, the actual amounts could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when received. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

At December 31, 2024, the Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold.

Contributions

Contributions from employees and the employer are recorded in the period in which the employer makes the payroll deductions from participant earnings.

Payment of Benefits

Benefits are recorded when paid. At December 31, 2024, there were no benefits processed and approved for payment, but not paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Operating Expenses

Administrative maintenance fees and other related charges are billed to and paid by the Plan, except for asset charges, which are charged against and deducted from participant accounts from their contract assets. Accordingly, only those administrative costs billed to the Plan are reflected as expenses in the Plan's financial statements.

NOTE 3 – INVESTMENTS AND INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan's investments were held and administered by Ascensus, except for participant loans. All investment information presented in the accompanying financial statements and supplemental schedule, excluding notes receivable from participants, including net appreciation/(depreciation) in fair value of investments and interest and dividends, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Ascensus.

The following table presents fair value of investments at December 31, 2024 and 2023. Investments that represent 5% or more of the Plan's net assets are separately identified.

NOTE 4 – FAIR VALUE MEASUREMENT

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

- *Level 1 Fair Value Measurements-* The fair value of money market is valued at the closing price reported. The fair value of mutual funds is based on the quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

NOTE 5 – RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds (registered investment companies) managed by John Hancock. John Hancock is the custodian of plan assets as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Certain Plan expenses, such as auditing, accounting and account fees, are paid by the Plan’s participating employer. These payments are considered related party transactions under SFAS No.57, since the Plan receives services from the plan sponsor and no accounting recognition is made. However, these transactions are not prohibited transactions under ERISA.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

NOTE 7 – TAX STATUS

The trustees adopted a prototype standardized profit sharing plan with a deferral arrangement which received a favorable opinion letter from the Internal Revenue Service, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the prototype plan's opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 – SUBSEQUENT EVENTS

In preparing these financial statements, the Company has evaluated events and transactions for potential recognition or disclosure through October 7, 2025, the date the financial statements were available to be used.
