Opinion

(1) PLAN DESCRIPTION

The following brief description of the LeFiell Manufacturing Company Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

The LeFiell Manufacturing Company (Company or Sponsor Company) established the Plan effective as of January 1, 1987 as a restatement of the LeFiell Manufacturing Company Profit Sharing Employee Stock Ownership Plan. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (the Code) of 1986, as amended and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by an Employee Stock Ownership Plan Committee comprising of up to three individuals appointed by LeFiell Manufacturing Company's Board of Directors.

The investment by the Plan in the Company's common stock was substantially financed through loans to the Plan by the Company and selling shareholders. Principal and interest payments due on the Plan loans were financed by contributions received from the Company. As the Plan made payments of principal and interest, an appropriate percentage of stock was allocated to eligible employees' accounts in accordance with applicable regulations under the Code. The notes payable were paid off in full during the year ended December 31, 2018. As of December 31, 2018, all shares have been allocated.

Eligibility

Employees of the Company are generally eligible to participate in the Plan after one year of service providing that they have worked at least 1,000 hours during such Plan year. Participants who have less than 1,000 hours of service during such Plan year or are not employed on the last working day of a plan year are not eligible for an allocation of Company contributions for such year.

Contributions

The amount of contributions to the Plan is at the discretion of the Company's Board of Directors, limited to the maximum amount deductible under Section 404 of the Code. Employees are not permitted to make contributions.

Benefits Paid to Participants

Distributions from the Plan will not be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. Distributions are made in cash, or, if a participant elects, in the form of Company common shares plus cash for any fractional share. At the Company's discretion, distributions may be paid in a single lump sum; equal, annual installments over a period not exceeding five years; or a combination of the foregoing. Installment period may be extended up to an additional five years for participants with Plan Benefits exceeding \$1,080,000.

(1) PLAN DESCRIPTION (Continued)

Benefits Paid to Participants (Continued)

Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan. During 2024, the Company repurchased from participants 34,062 shares at prices determined from the independent appraisal.

At December 31, 2024, \$2,305,176 is owed to participants who have separated from the Plan as of year-end, but for which disbursement of their funds from the Plan have not been made.

Voting Rights

Each participant and or beneficiary is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. Upon such termination of the Plan, participants will become 100% vested in their accounts and the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Employee Stock Ownership Plan Committee shall direct the Trustee to pay all liabilities and expenses of the trust fund.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Sponsor Company common stock released by the Trustee from the unallocated account, the Company's discretionary contribution, and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The Company can pay for the purchases with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash. There are no repurchases of shares as of December 31, 2024.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Sponsor Company common stock into investments which are more diversified. Participants who are at least 55 years of age with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to the participant's account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. During the year ended December 31, 2024, 6,354 shares of Sponsor Company common stock were redeemed for an aggregate amount of \$497,836 for diversification.

Forfeitures

Employer contributions and Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. Forfeitures of terminated non-vested account balances allocated to remaining participants for the year ended December 31, 2024 totaled \$44,721.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Cash, non-interest bearing

The Plan maintains cash balances at financial institutions that are secured by the Federal Deposit Insurance Corporation up to \$250,000 per institution. As of December 31, 2024 and 2023, the Plan had no uninsured cash balances.

Investment Valuation and Income Recognition

The shares of the Company common stock are valued at fair value as determined an independent appraiser, and in accordance with provisions of the Code and ERISA.

Administrative Expenses

Administrative expenses required to facilitate the Plan and expense to modify the Plan are paid by the Company.

Benefits Paid to Participants

Benefits are recorded when paid or upon distribution of shares.

Non-Participant-Directed Investments

All investments included in these financial statements are considered non-participant-directed investments.

Level 1 - Quoted prices are available in active markets for identical investments as of the reporting date. The type of investments in Level 1 include listed equities and other securities held in the name of the Plan, and exclude listed equities and other securities held indirectly through commingled funds.

Level 2 - Pricing inputs, including broker quotes, are generally those other than exchange quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value is determined through the use of models or other valuation methodologies.

Level 3 - Pricing inputs are unobservable for the investment and include situations where there is little, if any market activity for the investment. The inputs into the determination of fair value require significant management judgment or estimation. Investments that are included in this category generally include privately held investments and partnership interests.

The fair value of the Company common stock is based on an annual independent appraisal. This appraisal was based on a combination of the market and income valuation approaches consistent with prior years. The appraiser took into account historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts and premiums.

The Executive Committee, under the supervision of the trustees of the Plan, determines the fair value measurement policies and procedures in consultation with the Company's Chief Financial Officer. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information. For the income valuation technique, the unobservable inputs consist of EBITDA, net income, free cash flow, weighted average cost of capital and discount rate. For the market valuation technique, the unobservable inputs consist of merger and acquisition comparables, revenue multiple and EBITDA multiple.

Changes in Fair Value of Level 3 Assets

During the year ended December 31, 2024, the plan sponsor company contributed 16,499 shares of its common stock with a fair value of \$1,292,697, which is categorized under Level 3 assets.

The Plan's policy is to recognize transfers into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers into or out of Level 3.

(5) TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated October 30, 2017, that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan takes an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) ADMINISTRATION OF PLAN ASSETS

The Plan's assets, which consist principally of LeFiell Manufacturing Company common stock, are held by the Trustees of the Plan.

Company contributions are held and managed by the Trustees, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses of the Plan are paid directly by the Company.

(7) RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Sponsor Company common stock. As described in Note 2, the Company pays the expenses of the Plan. During the year ended December 31, 2024, the Plan issued 16,499 of additional shares of the Company's common stock. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA. There were no expenses paid to parties-in-interest through Plan assets as of December 31, 2024.

(8) RISKS AND UNCERTAINTIES

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks, including interest rate, market, and credit risks, as well as valuation assumptions based on earnings and cash flows. Due to the level of risk associated with the investment in the Company's common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the Company's common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(9) CONCENTRATION OF INVESTMENTS

Included in investments at December 31, 2024 and 2023 are shares of the Company's common stock amounting to \$28,698,598 and \$28,096,153, respectively. This investment represents 100% of total investments at December 31, 2024 and 2023. A significant increase in redemption of company shares would significantly affect the net assets available for benefits despite the increase in share price and the company issued S distribution to maintain the same total shares of the Company's common stock.

(10) SUBSEQUENT EVENTS

In preparing these financial statements, the Company has evaluated events and transactions for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued.
