### Notes to Financial Statements

#### NOTE 1 DESCRIPTION OF THE PLAN

The following description of the United Group Services 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to their United Group Services 401(k) Profit Sharing Plan agreement for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan. Substantially all employees of United Group Services, Inc. (the "Company") are currently eligible for participation in the Plan as well as employer contributions if they have attained the age of 18 and have completed six months of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

##### ***Contributions***

Participants may contribute up to 60% of annual compensation, as defined in the Plan, on a pre-tax or after-tax (Roth) basis. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code ("IRC") of 1986 as amended (\$23,000 at December 31, 2024). Additionally, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. The Plan provides for automatic enrollment for eligible employees. For those employees who are automatically enrolled, the Company shall make pre-tax contributions on their behalf equal to 3% of their eligible compensation into the Plan, unless the employee elects otherwise. The Company may also make discretionary contributions to the Plan. For the 2024 Plan year, the Company made a discretionary matching contribution equal to 100% of the first 1% and 50% of the next 5% of compensation each eligible participant contributed to the Plan.

##### ***Rollover Contributions***

Participants are eligible to roll over their taxable portion of funds previously held for their account in another qualified retirement plan to the Plan on a tax-free basis. Rollovers on an after-tax basis are not permitted by the Plan.

##### ***Participant Accounts***

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings and expenses. The pro-rata allocation is based upon each participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants become immediately vested at the time of participation in the Plan in their contributions and actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their accounts, plus actual earnings thereon is based on years of continuous service. Participants become partially vested after one year of service with 100% vested after five years of credited service.

### Notes to Financial Statements (Continued)

#### NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Forfeitures*

As of December 31, 2024 and 2023, the balance of unallocated forfeited non-vested accounts totaled \$23,795 and \$2,254, respectively. Forfeited balances of terminated participants' non-vested accounts are first used to pay Plan administrative expenses and reduce employer contributions. During 2024, \$18,500 of forfeitures were allocated to reduce employer contributions. During 2024, no forfeitures were allocated to reduce Plan expenses.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000, or 50% of their vested account balance. Generally, the term of the loan may not exceed five years. However, if the loan is for the purchase of a participant's principal residence, the Plan administrator may permit a longer term. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. For participants employed by the Company, principal and interest is paid ratably through payroll deductions.

##### *Payment of Benefits*

Upon a participant's retirement, death, total and permanent disability, or other termination of employment with the Company, a participant may elect to receive a lump sum amount or periodic payments not exceeding the participant's life expectancy.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2. Participants electing in-service distributions may elect to receive all or a portion of their vested benefit in a lump-sum payment.

In conditions of "financial hardship" a participant may apply to the Plan administrator for approval to withdraw that portion of their elective deferral balance necessary to meet the financial hardship, subject to the limitations of the Plan and the IRC.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

#### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### *Basis of Presentation*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Investment Valuation / Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

### Notes to Financial Statements (Continued)

#### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### *Investment Valuation / Income Recognition (Continued)*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the Plan document.

##### *Related-Party Transactions / Expenses*

Certain Plan investments are investments managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the asset custodian and trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan. All fees and expenses of the Plan, to the extent not paid by the Company, are paid by the Plan. Certain investment related expenses are included in the net appreciation of fair value of investments.

##### *Estimates*

The preparation of financial statements in conformity with U.S. generally accepted accounting principles ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Benefit Payments*

Benefit payments are recorded when paid.

##### *Subsequent Events*

The Company has evaluated all events subsequent to the balance sheet date of December 31, 2024, through October 13, 2025, which is the date these financial statements were available to be issued.

#### NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year end.

*Self-directed brokerage accounts:* Accounts primarily consist of cash and certificates of deposit that are valued based on the basis of market prices.

*Money market fund:* Valued at the net asset value ("NAV") of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 TAX STATUS

The Company has adopted a prototype plan which has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, therefore, no provision for income taxes has been incurred in the Plan's financial statements.

#### NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
