## **Note 1 - Description of Plan**

The following description of the Lumbermens Merchandising Corporation Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

### **General**

The Plan is a defined contribution pension plan covering substantially all employees of Lumbermens Merchandising Corporation (the Company) age 21 or older. The eligibility requirements for the safe harbor contribution is the same as employee deferrals. To be eligible for employer mandatory and discretionary profit-sharing contributions, employees must be age 21 and complete seven consecutive months of service. An employee must also work 500 hours during the year to receive the discretionary profit-sharing contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Contributions**

Each year, participants may contribute up to 50% of annual compensation, as defined in the Plan, as a traditional pre-tax contribution, as an after-tax Roth contribution, or a combination of the two, up to the maximum allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. The Company makes a contribution of 3% of a participant's base salary (as defined) in order to meet the 401(k) safe harbor requirements. The Company also makes a mandatory profit-sharing contribution of 4% of a participant's base salary (as defined). The Company may make a discretionary profit-sharing contribution which the Company, in its sole discretion, determines from year to year. For the years ended December 31, 2024 and 2023, the Company made a discretionary contribution equal to 8% of each participant's base salary (as defined). Contributions are subject to certain IRS limitations.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and the Company's safe harbor contribution, as well as allocations of (a) the Company's profit-sharing contributions, (b) plan earnings, and (c) forfeitures of terminated participants' nonvested accounts, and (d) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their voluntary contributions, the 3% Company safe harbor contribution, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service based on the following vesting schedule:

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the current prime rate, as published in Reuters, plus 1%. Principal and interest are paid ratably through payroll deductions.

##### **Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant will be eligible to receive a lump-sum payment equal to the value of his or her vested interest in his or her account or in equal installments under a systematic withdrawal plan. Upon termination of employment, if a participant's vested interest in their account exceeds \$5,000, no distribution shall be made to the participant before they reach the age of normal retirement or receipt of consent to pay out by the participant and their spouse, if applicable. If the participant's vested balance does not exceed \$5,000, the vested account balance is paid out in the form of a lump-sum distribution.

In addition, the Plan allows for hardship distribution, if certain criteria are met, and in-service withdrawals for participants, who have attained age 59-1/2.

##### **Forfeited Accounts**

The nonvested portion of a participant's discretionary profit-sharing contribution account and mandatory profit-sharing contribution account, if any, shall be forfeited. Upon the date the participant incurs five consecutive one-year breaks in service, the forfeitures may be used to pay plan expenses or will be allocated to the active participants in the same manner as employer contributions.

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$103,911 and \$124,189, respectively. During 2024 and 2023, \$127,993 and \$-0- forfeitures were reallocated to participants from forfeited nonvested accounts, respectively.

### **Note 2 - Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. Investment consulting and recordkeeping fees are paid from plan assets.

### **Note 3 - Information Certified and Provided by Vanguard Fiduciary Trust Company**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Vanguard Fiduciary Trust Company (Vanguard), the trustee of the Plan.

#### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The collective trust fund is valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 5 - Tax Status**

The Company adopted a pre-approved plan document that was sponsored by The Vanguard Group. The pre-approved document has received an opinion letter from the IRS, dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their nonvested employer contributions.

#### **Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 8 - Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments are shares of registered investment companies and units of participation in a collective trust fund managed by Vanguard, the trustee, and; therefore, these transactions qualify as party-in-interest transactions.

Fees paid to the Vanguard Group, a party in interest, for recordkeeping and information management was \$30,000 and \$30,500 for the years ended December 31, 2024 and 2023, respectively.

Vanguard provides certain administrative services to the Plan pursuant to a service agreement with the Company. Vanguard receives revenue from mutual fund service providers for services Vanguard provides to the funds. This revenue is used to offset certain amounts owed to Vanguard for its administrative services to the Plan. If the revenue received by Vanguard from such mutual fund service providers exceeds the amount owed under the service agreement, Vanguard remits the excess to the Plan into a revenue sharing account. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, the Plan received \$50,419 and \$50,312, respectively, in revenue under this arrangement and paid out \$63,500 and \$40,000, respectively, in administrative expenses. At December 31, 2024 and 2023, the revenue sharing account had a balance of \$5,920 and \$18,273, respectively.

### **Note 9 - Subsequent Events**

Plan management has evaluated subsequent events through October 8, 2025. This date is the date the financial statements were available to be issued. The following event subsequent to December 31, 2024 was noted:

Effective January 1, 2025, the Plan will allow active participants between the age of 60 and 63 to increase their catch-up contributions to the greater of \$10,000 or 150% of the regular catch-up limit.

No other material events subsequent to December 31, 2024 were noted.
