NOTE 1 – PLAN DESCRIPTION

The following is a brief description of the NRI Group 401(k) Plan (the “Plan”), which is provided for general information purposes only. The Plan document, related adoption agreement, and individual statements provided to each Plan participant should be referred to for more complete information.

A. GENERAL

The Plan is a qualified defined contribution plan covering eligible employees who are members of a controlled group that includes Nomura Research Institute Holdings America, Inc. and its various affiliated participating employers: NRI Secure Technologies, LTD., Nomura Research Institute IT Solutions America, Inc., Nomura Research Institute America, Inc., Brierley & Partners, Inc. (through March 31, 2023), and Cutter Associates, LLC, (collectively the “Company”). The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Empower is the Plan’s record-keeper. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan document.

The Plan covers all eligible employees of the Company who have completed three months of service and have attained the age of 21. The Plan excludes those employees who are: (1) employees of affiliated employers (other than those who have adopted the Plan as noted above) (2) independent contractors or common-law employees (3) employees covered by a collective bargaining agreement (4) nonresident aliens and (5) interns, trainees and rotational staff members. All employees, unless specified in the plan provisions, are eligible for automatic enrollment in the Plan upon meeting eligibility requirements. For all who are eligible and choose to participate, the entry date is the first day of each month.

B. PARTICIPANT CONTRIBUTIONS

Under the Plan, participants may contribute up to 80% of the participant’s eligible compensation, not to exceed the limits by the Internal Revenue Code (“IRC”). A participant shall be permitted to irrevocably designate a portion of their deferral contributions allowed under the Plan as a Roth deferred contributions. Participants are permitted to make direct rollover contributions to the Plan.

The Plan includes an automatic enrollment feature and contribution arrangement. The automatic deferral amount is 3% of the compensation in the first year of participation which automatically increases by 1% of compensation per year up to a maximum of 5% of compensation. Participants always have the option to opt-out or modify their deferral percentage. In absence of participant’s direction, the contribution will be invested in a default investment account.

C. EMPLOYER CONTRIBUTIONS

Each participating employer may make a discretionary profit-sharing contribution to their employees who are employed on the last day of the Plan year. The profit-sharing contribution for the year ended December 31, 2024, was \$426,917, which is recorded as an employer contribution receivable at December 31, 2024. The profit-sharing contribution for the year ended December 31, 2023, was \$449,924, which was recorded as an employer contribution receivable at December 31, 2023.

The Plan allows for an annual discretionary matching contribution equal to a uniform percentage of participants’ salary deferrals. Each participating employer will determine the amount of their discretionary percentage each year. Cutter Associates, LLC made a discretionary matching contribution in the amount equal to 100% of the employee compensation contributed up to a maximum 1% of the respective employee’s compensation for the Plan year. All other participating employers made a discretionary matching contribution in the amount equal to 100% the employee compensation contributed up to a maximum of 6% of the respective employee’s compensation for the Plan year.

D. PARTICIPANT ACCOUNTS

Each participant account is credited with the participant's contribution and allocations of employer contributions, plan earnings, and distribution and loan fees (if applicable). Allocations are based on participant earnings or account balances, as defined.

E. NOTES RECEIVABLE FROM PARTICIPANTS

The Plan includes a provision allowing eligible participants to borrow from their accounts at a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 minus highest aggregate principal balance of any loan outstanding during the year or 50% of their vested account balance. Loan terms range from one to five years. The loans are repaid, with interest, through equal payroll deductions. The notes shall bear an interest rate equal to 1% above the prime rate. Any such borrowings are to be repaid within five years, unless the note is for the purchase of a principal residence for which the repayment period may not extend beyond thirty years. Principal and interest are to be repaid by payroll deductions or payment by check only for prepayments.

F. VESTING

Participants are immediately 100% vested in their deferrals, rollover contributions and Plan earnings thereon. All participants, unless specified in the plan provisions, are vested in the Company's matching contributions and profit-sharing contributions, if any, plus actual earnings as detailed below.

Upon reaching retirement age, death, or disability while employed, a participant becomes 100% vested.

G. PAYMENT OF BENEFITS

Participants or their beneficiaries can request a distribution if they sever employment, retire, become disabled, die, have a hardship or have attained age 59 ½. Participant account balances less than \$5,000 will be automatically distributed as a lump sum distribution. If the account balance exceeds \$5,000, then the distribution will be made as a lump sum or partial withdrawals or installments subject to minimum required distribution as per the IRC.

H. ERISA BUDGET ACCOUNT

Certain investment options in the Plan pay revenue-sharing amounts to the Trustee. The Trustee credits a portion of these amounts to the Plan's ERISA Budget Account. During the year ended December 31, 2024, the Plan used \$48,995 from the ERISA Budget Account to pay allowable administrative expenses.

Unspent amounts remain in the ERISA Budget Account and may be used to pay future plan expenses or, if directed by the Plan sponsor, be reallocated to participant accounts. The balance of the ERISA Budget Account was \$102,050 and \$51,839, as of December 31, 2024 and 2023, respectively, and is included in investments on the Statements of Net Assets Available for Benefits.

I. TERMINATION PRIORITIES

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or partial termination, each participant would become 100% vested in their account balance.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. FINANCIAL REPORTING FRAMEWORK

The accompanying financial statements are prepared according to accounting principles generally accepted in the United States of America (“GAAP”), as promulgated by the Financial Accounting Standards Board (“FASB”) in the Accounting Standards Codification (“ASC”).

B. BASIS OF ACCOUNTING

The accompanying financial statements of the Plan are prepared under the accrual method of accounting.

C. ESTIMATES

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

D. VALUATION OF INVESTMENTS

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is stated at contract value, see Note 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

E. NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are valued at cost, which approximates fair value. Delinquent participant loans are reclassified as distributions based upon the repayment terms of the loan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

F. ADMINISTRATIVE EXPENSES

Administrative expenses may be paid out of the Plan or by the Company. Administrative expenses that are to be paid from the Plan are first paid from forfeitures, if any, and any remaining amounts are paid from the Plan's trust funds and allocated to all participants on a pro rata basis.

G. PAYMENT OF BENEFITS

Benefit payments to participants or beneficiaries are recorded when paid.

H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

I. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2025, which is the financial statement issuance date. All items which are required for disclosure have been included in the accompanying financials and notes thereto.

NOTE 3 – FORFEITED ACCOUNTS

Upon termination of employment, participants forfeit their non-vested balances. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$309,266 and \$191,931, respectively. Forfeitures may be used to reduce future Company contributions or to pay administrative expenses of the Plan at the discretion of the Company. The forfeited amounts that were used to reduce Plan expenses during the year ended December 31, 2024 was \$48,686.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan's investments are held in a trust fund administered by Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York (the "Investment Custodian" of the Plan or "Trustee"). The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Investment Custodians:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss) and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – PARTY-IN-INTEREST

Certain Plan investments are shares in mutual funds managed by the trustee and, therefore, these transactions qualify as party-in-interest transactions. As of December 31, 2024 and 2023, there were investments in funds managed by the trustee that qualified as party-in-interest transactions totaling \$2,321,020 and \$2,203,895, respectively. The Plan also has notes receivable from participants that qualify as party-in-interest transactions. The total of notes receivable from participants was \$252,374 and \$141,144 as of December 31, 2024 and 2023, respectively.

NOTE 6 – TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – INVESTMENT IN A COMMON AND COLLECTIVE TRUST

The Plan has a fully benefit-responsive group annuity contract with the Investment Custodian whose balance was \$2,321,020 and \$2,203,895 as of December 31, 2024 and 2023, respectively. The contract is a traditional investment contract. The Investment Custodian maintains the contributions in an unallocated fund, which is included in its general account, to which it adds interest. Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance company including plan termination and other events as specified in the group annuity contract. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable as of December 31, 2024. The insurance company may not terminate the contract at any amount less than contract value.

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate is based on a formula established by the contract issue by may not be less than zero. The average interest for the years ended December 31, 2024 and 2023 was 1.56% and 1.34%, respectively.

NOTE 8 – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value.

These levels are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used between December 31, 2024 and December 31, 2023.

- *Mutual Funds*: valued based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
