Opinion

Notes to Financial Statements

1. Description of the Plan

The following description of the Sodexo, Inc. Medical Benefits Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

General

The Plan, which was established on March 28, 1998, provides medical and prescription coverage to all eligible employees of Sodexo, Inc. (Sodexo or the Company), who elect such coverage, and their eligible dependents. To be eligible for the Plan, employees must be one of the following:

- A non-temporary, active exempt employee; or
- A non-temporary, full-time hourly employee working an average of at least 30 hours per week over a 52-week measurement period. Hours will be measured each year to determine whether an employee has maintained an average of at least 30 hours per week and remains eligible for the Plan the following Plan year.

The employee and covered dependents are eligible for retiree coverage if, on the date the employee retires they are under age 65 or they are at least age 55 with ten years of continuous service up to age 65. The employee may elect coverage from a Aetna Open Health Plan, Aetna Network Health Plan, Aetna Savings Health Plan, Aetna Basic Health Plan or under Health Maintenance Organization plans, which are available only in certain states or locations. In addition, the employee may elect coverage under supplemental insurance plans for Accident, Critical Illness and Hospital Indemnity.

The Plan provided for the postretirement benefit obligations earned by the Company's eligible employees for participants who have retired before December 31, 2019. The Plan is administered by the Company's Benefit Operations Department (the Plan Administrator).

Contributions

The Plan is a contributory plan that is funded by both participant and Company contributions. Active employee contributions are withheld through payroll deductions in amounts determined by the participant's elections during the annual enrollment period or date of hire. The Company contributes a percentage of the premium based on the participant's election. Supplemental insurance plans are fully funded by participant contributions, which are also withheld through payroll deductions in accordance with participant's annual enrollment elections.

Retiree and former employee contributions are remitted directly to the Company in amounts determined by the participants' elections during the annual enrollment period. Retirees pay 150% of the gross premium and former employees pay premiums at Consolidated Omnibus Budget Reconciliation Act (COBRA) rates, respectively. Retirees paid 100% of the estimated cost of providing their postretirement benefits at December 31, 2024. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Benefits

The Plan provides certain medical and prescription coverage to the participating employees and their eligible family members based on the type of service rendered and whether an in-network or out-of-network service provider is used. The Plan also provides continuation of certain benefits upon termination of employment through the COBRA.

Insured Benefits

The health maintenance organization (HMO) option is fully insured, and therefore, once the participant and the Company fund the monthly contribution, the Company has no further funding obligations. It is the present intention of the Company to continue obtaining insurance coverage for the HMO option.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions for Aetna Open Health Plan, Aetna Network Health Plan, Aetna Savings Health Plan and Aetna Basic Health Plan options. The Company is not permitted under present tax law to deduct amounts for future benefits (beyond one year).

The supplemental insurance options for Accident, Critical Illness and Hospital Indemnity are fully insured, and therefore, once the participant funds the monthly contribution, the Company has no further funding obligations. It is the present intention of the Company to continue obtaining insurance coverage for these supplemental options.

Self-insured Benefits

The Aetna Open Health Plan, Aetna Network Health Plan, Aetna Savings Health Plan and Aetna Basic Health Plan benefits are self-insured. The claims for self-insured benefits (other than short-term disability) are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the general assets of the Company. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Company.

The Plan has a health savings arrangement (HSA) that is funded solely through participant contributions up to the IRS limits. The HSA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year can generally be carried over and may accumulate without limit. The account cannot be used for anything other than reimbursements for qualified medical expenses. Upon termination of employment, participants have several options for their HSA account. They can retain their HSA account with the Plan administrator, transfer the remaining balance with the Plan administrator to another administrator, request a return of the remaining HSA balance to themselves, or roll over the balance to a new HSA administrator account that the participant chooses.

Administrative Expenses

Administrative expenses, including claims processing and audit fees, are paid from Plan assets. Effective January 1, 2023, Aetna performs the medical and prescription claims processing. For claims incurred prior to fiscal year 2023 but paid in subsequent years, these were processed by CareFirst for medical claims. Aetna and CareFirst receive a fee, based on the number of participating employees in the Plan, which is paid from Plan assets.

2. Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes, in particular the determination of the benefit obligations and changes therein; claims payable, claims incurred but not reported, premiums payable to HMO providers, post-employment benefit obligations, postretirement benefit obligations and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Benefit Obligations

The claims incurred but not reported obligation is determined based on historical claims experience. Claims payable represent claims processed but not paid as of year-end.

Postretirement and Postemployment Benefit Obligations

The postemployment benefit obligations are determined by an actuary and represent the estimated liability for retirees and former employees who have elected continuation of coverage under COBRA.

The Plan provides medical benefits to a limited number of retired employees meeting very restrictive eligibility requirements. Postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to employee services rendered through the Plan's year-end date for each Plan year. Postretirement benefits include future benefits expected to be paid to currently retired employees and their beneficiaries and dependents.

Prior to an active employee's full eligibility date, the postretirement benefit obligation is that portion of the expected postretirement benefit obligation attributed to that employee's service rendered to the valuation date. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Company and from existing Plan assets.

Benefit Claim Payments

Claim payments are recorded when paid by the third-party claim processor in the accompanying statement of changes in net assets available for benefits.

Premium Payments to HMO Providers

Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Refunds and Rebates

Refunds and rebates due from the Plan's pharmacy benefit manager are recognized when they can be reasonably estimated and are probable of collection. As of December 31, 2024 and 2023, management has accrued pharmacy rebates totaling \$3,550,444 and \$4,100,080, respectively. Total rebates of \$33,140,797 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Concentration of Credit Risk

The Plan maintains cash with high quality institutions in amounts that are in excess of Federal Deposit Insurance Corporation limits up to \$250,000. Uninsured balances aggregate to \$5,343,399 and \$6,263,447 at December 31, 2024 and 2023, respectively. The Plan has historically not experienced losses in such accounts and does not believe it is exposed to any significant credit risk.

3. Benefit Obligations and Related Changes

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary, and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment and to reflect the portion of costs expected to be borne by the retired participants, and other providers.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

The health care cost trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements for postretirement benefit obligations. If the assumed rates decrease by one percentage point, the postretirement benefit obligation would decrease by approximately \$1,000 as of December 31, 2024. If the assumed rates increase by one percentage point, the postretirement benefit obligation would increase by approximately \$1,000 as of December 31, 2024.

4. Risks and Uncertainties

The actuarial present value of the postretirement and postemployment benefit obligations are reported on certain assumptions pertaining to interest rates, health care inflation and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is at least reasonably possible that changes in these estimates and assumptions in the near future could materially affect the amounts reported and disclosed in the financial statements.

5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided under the Plan and to terminate the Plan subject to the provisions set forth in ERISA. If the Company terminated the Plan, any assets in the Plan, including funds that participating employees have contributed, will be used to pay outstanding benefit claims as directed by the Company. The Company will pay any benefit claims in excess of the Plan's assets.

6. Income Tax Status

The Plan assets are segregated in a trust which is operating in accordance with the provisions of the Internal Revenue Code (the Code) Section 125 for Cafeteria Plans. The Plan Administrator believes the Plan is operating in conformity with the Code and ERISA.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Parties-in-Interest and Related Party Transactions

There were no prohibited transactions recorded between the parties-in-interest and the Plan. Sodexo is the sponsor of the Plan, and, as such, executes the normal duties associated therewith. The Plan's assets are held at BMO Bank, N.A.; as such, BMO Bank N.A., as a custodian, is a party-in-interest that has engaged in permissible transactions with the Plan. Fees paid by the Plan to the third-party administrators and audit fees amounted to \$301,594 for the year ended December 31, 2024.

8. Reconciliation of the Financial Statements to the Form 5500

Claims payable and claims incurred but not reported are reflected as benefit obligations for financial statement purposes but are presented as liabilities on the Form 5500.
