## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Strategic Insight, Limited 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Strategic Insight, Limited 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Strategic Insight, Limited 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. **1. Plan Description**

The following description of the Strategic Insight, Limited (the Company) 401(k) Plan (the Plan) provides only general information. Participants and interested parties should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. General - The Plan, which became effective on January 1, 1996, is a defined contribution plan that covers all employees. Employees are eligible to participate on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). During 2011, the Plan was amended effective January 1, 2012 to allow Roth 401(k) contributions. During 2019, the Plan was amended to exclude part-time, temporary, seasonal, interns, and summer hires working less than 1,000 hours per year.
- b. Contributions - In accordance with the Plan document, participants may contribute up to 15 percent of their annual eligible compensation, subject to Internal Revenue Code limitations. The Company, at the discretion of its board of directors, may make matching contributions and/or profit-sharing contributions to the Plan. Matching contributions may not exceed four percent of the employee's compensation. The Company also makes non-elective (safe harbor) contributions to eligible employees in the amount equal to three percent of compensation. If necessary to satisfy minimum requirements, the Company may make an additional discretionary employer contribution (Gateway contribution). Employer contributions for the years ended December 31, 2024 and 2023, totaled \$960,069 and \$973,216 respectively.
- c. Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) Company contributions, (b) plan earnings, and (c) forfeitures of terminated participants' non-vested accounts and charged with an allocation of investment expenses. Allocations are based on participant earnings and account balances, as defined. The benefits to which a participant is entitled are those which can be provided from the participant's vested account.
- d. Vesting - Participant's vesting on employer contributions and earnings thereon begin after completing 1,000 hours of service in 12 consecutive months or two years of service, and is 20 percent vested for each continuous year of service such that a participant is fully vested after six years of continuous service. Forfeitures totaling approximately \$56,000 and \$85,000, were used to offset employer contributions in 2024 and 2023, respectively. As of December 31, 2024 and 2023, there was \$91,856 and \$64,315, respectively, of unused forfeitures in the forfeitures holding account.

- e. Notes Receivable from Participants - Participant loans are allowed by the Plan for any purpose, generally limited to a maximum of 50 percent of the participant's vested interest and are subject to a \$1,000 minimum loan amount. Terms and conditions are governed by applicable rules and regulations of the Internal Revenue Code.
- f. Investment Options – The Plan offers a select number of investment vehicles in which participants may invest their funds. Upon enrollment in the Plan, a participant may direct the investment of contributions in any of the available investment options or in a self-directed brokerage account managed by Empower Annuity Insurance Company of America. Participants may change their investment options on a daily basis. At December 31, 2024 and 2023, these investment options consisted of registered investment companies and a guaranteed investment contract.

**2. Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results, including realization of assets, could differ from those estimates.

Investments

Investments in shares of registered investment companies (mutual funds) are stated at their estimated fair value (see Note 3). Investments of the fully benefit-responsive investment contract are reported at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Management has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

**3. Fair Value Measurements**

Financial accounting and reporting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable, usually due to the lack of market activity, and thus involves the judgment of management.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**3. Fair Value Measurements (continued)**

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in *mutual funds*, including participant-directed brokerage accounts, are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported as of the end of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of levels 1, 2, or 3.

**4. Investments and Trustee Certification**

The Trustee, Empower Annuity Insurance Company of America (Empower), is responsible for collecting receipts and handling trust asset transactions. The trustee has certified as complete and accurate all Plan investments, receipts and disbursements included in the accompanying financial statements.

**5. Guaranteed Investment Contract**

The Plan has a benefit-responsive investment contract with Empower. Empower maintains the contribution in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract was \$2,035,193 and \$1,869,888 as of December 31, 2024 and 2023, respectively. The average crediting interest rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The guaranteed investment contract does not allow the crediting interest rate to be below zero percent.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement unless the Plan is not in compliance with the investment agreement. Average yields for 2024 and 2023 were as follows:

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**7. Tax Status**

The Plan is a prototype plan sponsored by Empower Annuity Insurance Company of America which has received a determination letter from the Internal Revenue Service (IRS) that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a separate determination letter from the IRS. However, the Plan administrator and the Plan's tax counsel believe the Plan is currently designed and is being operated in accordance with the applicable IRC.

The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to audit for years prior to 2021.

**8. Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**9. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
