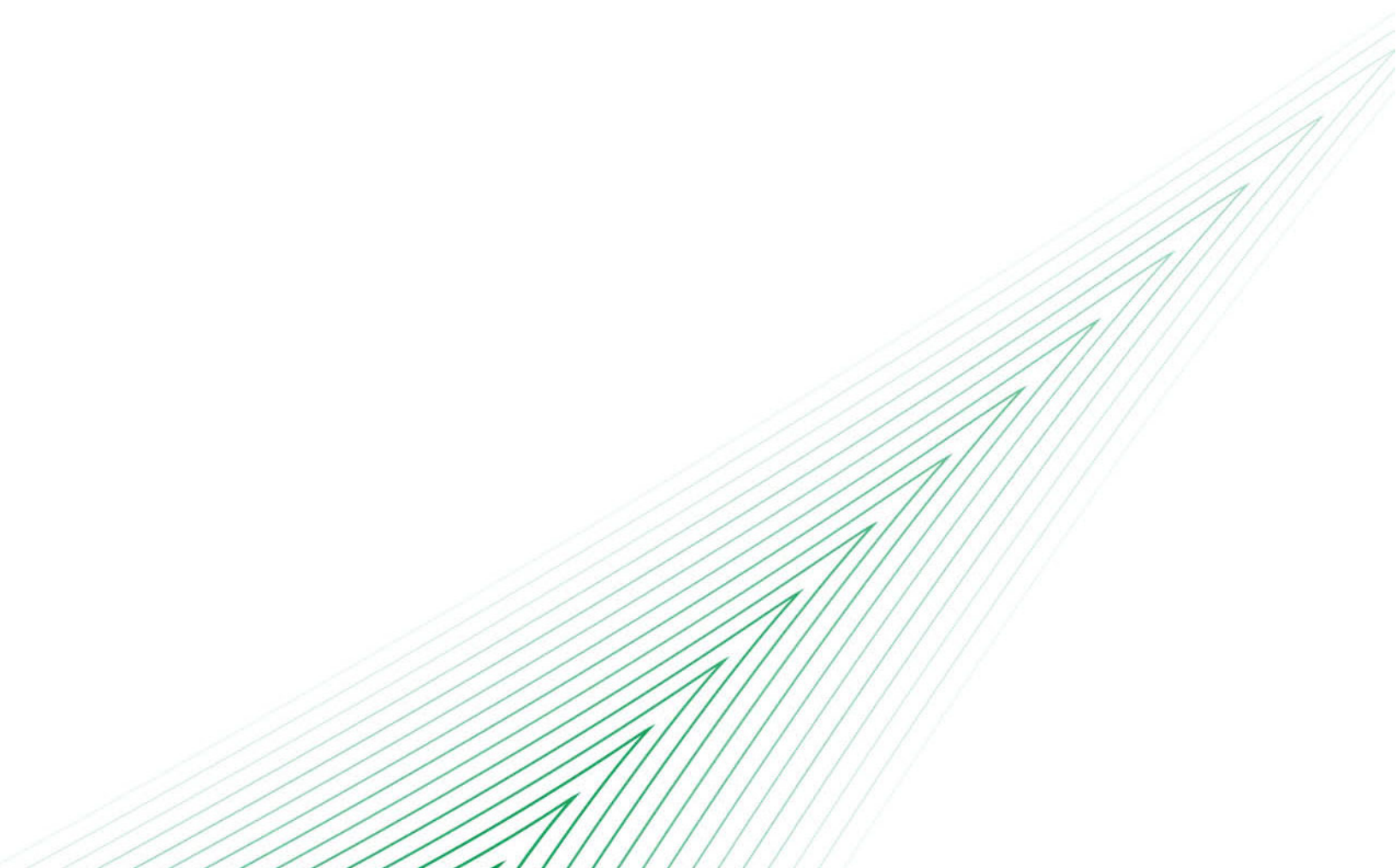

## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
**Whitetail Disposal, Inc. 401(k) Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Whitetail Disposal, Inc. 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (ongoing), the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter - Plan Termination**

As further discussed in Note 1 to the financial statements, the Plan was terminated effective July 31, 2024, and was fully liquidated by June 30, 2025. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors’ Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

( 1 ) **Description of plan**

The following description of the Whitetail Disposal, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** - The Plan was a defined contribution plan sponsored by Whitetail Disposal, Inc. (the "Company") for the benefit of its full-time employees, who were not covered under a collective bargaining agreement or were independent contractors. Additionally, employees must have completed three months of service and attained the age of 18. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Plan termination** - The Company elected to terminate the Plan subject to ERISA provisions effective July 31, 2024. Final benefit payment elections were made from August 2024 through February 2025, and liquidation was determined to be imminent on December 31, 2024. The Plan was in the process of being liquidated on December 31, 2024, and was determined to be fully liquidated on June 30, 2025. As a result, the Plan's 2024 financial statements have been presented using the liquidation basis of accounting, and participants were made 100% vested in their employer contributions.

**Contributions** - Each year, participants could contribute up to 50% of their annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Additionally, participants age 50 or older, who were making contributions to the Plan, were allowed to make catch-up contributions as defined in the Plan.

The Plan allowed for the Company to make discretionary matching contributions on behalf of participants. For the period January 1, 2024 to July 31, 2024, the Company matched 50% of participant contributions up to 9% of compensation, as defined. In addition, the Company could have made discretionary profit-sharing contributions as determined by the Company for eligible participants. No discretionary profit-sharing contributions were made for the year ended December 31, 2024.

Participants directed the investment of all contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Code ("IRC") limitations.

**Participant accounts** - Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations were based on participant contributions and compensation or account balances, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant vested ratably over five years of credited service, as defined, or upon retirement (later of age 59½ or fifth anniversary) or death. Prior to Plan termination, Company contributions and related earnings were subject to the following vesting schedule:

#### ( 1 ) Description of plan (continued)

**Payment of benefits** - Due to termination of service, disability, retirement, or upon qualifying instances of hardship, a participant could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to death, distributions were made in accordance with the Plan, which generally allows for: (1) distributions of the entire account balance to be completed by the first anniversary of the participant's death or (2) distributions to be made over the life of, or over a period no greater than, the life expectancy of the beneficiary(ies).

**Forfeited accounts** - As of December 31, 2024 and 2023, there were forfeited nonvested accounts totaling \$125 and \$16,607, respectively. The Plan allowed for forfeited nonvested accounts to be used to either reduce future employer contributions or pay Plan expenses. For the year ended December 31, 2024, \$27,874 from forfeited nonvested accounts was used to reduce employer contributions or pay Plan expenses.

#### ( 2 ) Summary of significant accounting policies

**Basis of accounting** - The 2024 financial statements of the Plan are prepared on the liquidation basis of accounting. The 2023 financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits - liquidation basis. Investment-related expenses are included in net appreciation in fair value of investments.

#### ( 3 ) Information prepared and certified by the trustee

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company ("Matrix") (the trustee and recordkeeper of the Plan).

**( 4 ) Fair value measurements**

Financial Accounting Standards Board Accounting Standard Codification (“FASB ASC”) Topic 820, “Fair Value Measurements and Disclosures, provides the framework for measuring fair value. This framework includes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2            Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3            Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used for the year ended December 31, 2024.

*Mutual funds, exchange-traded funds, and Money Market fund:* Valued at the daily closing price as reported by the fund. Mutual funds, exchange-traded funds, and the Money Market fund held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds, exchange-traded funds, and the Money Market fund held by the Plan are deemed to be actively traded. All of the Plan’s mutual funds, exchange-traded funds, and Money Market fund investments totaling \$1,817,633 and \$1,858,239 as of December 31, 2024 and 2023, respectively, were Level 1 investments in the fair value hierarchy.

#### ( 6 ) Tax status

The Internal Revenue Service ("IRS") has determined that the volume submitter 401(k) plan adopted by the Plan is designed in accordance with applicable sections of the IRC and informed the recordkeeper of such in a letter dated June 30, 2020. The plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that "more likely than not" would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. See Note 8.

#### ( 7 ) Risks, uncertainties, and concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### ( 8 ) Delinquent participant contributions

Participant contributions remitted during the year ended December 31, 2020, totaling \$45,127, have been corrected outside of the Department of Labor's Voluntary Fiduciary Correction Program ("VFCP") in May 2024. The participant contributions were not statutorily late; however, the delayed remittance of these contributions would be considered delinquent based on the demonstrated timing of contributions made to the Plan during 2020.

During the year ended December 31, 2022, the Plan experienced operational failures, which resulted in delays in the remittance of participant contributions. Delinquent participant contribution amounts totaling \$96,162, plus lost earnings, were fully corrected using the Department of Labor's VFCP calculator in 2024 through self-correction.

During the year ended December 31, 2023, the Plan also experienced operational failures, which resulted in delays in the remittance of participant contributions. Delinquent participant contribution amounts totaling \$12,459, plus lost earnings, were fully corrected using the Department of Labor's VFCP calculator in 2024 through self-correction.

**( 9 ) Subsequent events**

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

In 2023, the Plan Administrator was notified that the IRS intended to examine the Plan for the years ended December 31, 2020, December 31, 2021, and December 31, 2022. The examination was closed on March 13, 2025, and the Plan's financial statements and Forms 5500 were accepted as filed.
