Opinion

We have audited the financial statements of the Nashville Wire Products Manufacturing Company Restated Employee Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits - cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Nashville Wire Products Manufacturing Company Restated Employee Benefit Plan (the "Plan") provides only general information about the Plan's provisions. Participants should refer to the Plan Agreement and subsidiary contracts for a more complete description of the Plan's provisions.

General - The Plan was established to provide health and other benefits for all eligible employees and covered dependents of Nashville Wire Products Manufacturing Company, LLC; Mid-South Wire, LLC; and M-S Logistics, LLC (the "Plan Sponsors" or "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - The Plan Sponsors' policy is to make necessary contributions toward current premiums and claims as allowed by the Internal Revenue Code (the "Code"). In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Plan is not administered through a trust and is funded on a pay-as-you-go basis. Participants pay 100% of the costs for dental, vision, and voluntary life benefits.

Benefits - The Plan provides health benefits (medical, vision, dental, prescription drugs and telemedicine), life insurance, short and long-term disability benefits, and accidental death and dismemberment benefits to full-time employees of the Plan Sponsors. The Plan also provides continuing coverage benefits to "qualified beneficiaries" in accordance with the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits - The Plan fully insures vision, dental, life, short and long-term disability, and accidental death and dismemberment benefits. Employees residing in Alabama receive medical, dental and prescription drug benefits under a fully insured agreement with Blue Cross Blue Shield of Alabama. The Plan purchases annual insurance contracts for the insured benefits. Premiums for the insured benefits are paid to the insurance company from the general assets of the Plan Sponsors and recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Self-Insured Benefits - All other Plan benefits are self-insured. The claims for the self-insured benefits (medical and prescription drugs) are processed by BlueCross BlueShield of Tennessee and CapitalRx, the Plan's third-party claims processors, under an administrative services only (ASO) arrangement. The claims processor pays claims directly to or on behalf of participants and are then reimbursed by the Plan Sponsors. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan. Claim payments are recorded when paid.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Stop Loss Coverage - The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims) for medical claims, including prescription drugs, regarding individual participant claims over \$200,000 effective September 1, 2024.

Administrative Expenses - The Plan Sponsors pay all administrative expenses that consist primarily of administrative fees paid to third-party claims administrators.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The Plan's financial statements have been prepared on the cash basis of accounting, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles. The cash basis of accounting is an acceptable alternative method of reporting under regulations issued by the Department of Labor. Under this accounting basis, additions to net assets are recognized when collected rather than when earned, and deductions from net assets are recognized when paid rather than when incurred.

Use of Estimates - The preparation of financial statements in conformity with the cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain disclosures. Actual results could differ from those estimates.

Plan Assets - The Plan maintains a bank account with a financial institution for cash management of the Plan's transactions. From time to time, the Plan has cash on deposit with the financial institution in excess of the federally insured limit of \$250,000 per legal ownership under the FDIC.

Contributions - Contributions from Plan participants and the Plan Sponsors are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits - Health claims are reported when submitted to the Plan by the claims processors for reimbursement. Premiums are reported when paid. Any refunds due to overpayments, subrogation, or adjustments are recorded in the period received and are shown netted with benefit payments.

Stop Loss - Premiums for stop loss insurance are included in the accompanying statement of changes in net assets available for benefits. There were no stop loss refunds during the year ended December 31, 2024.

Refunds - Refunds due from the Plan's PBM are recorded when received. Pharmacy rebates totaling \$978,164 have been netted with claims paid on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Benefit Obligations - Benefit obligations for incurred but not reported medical claims are estimated by the Plan Sponsors based on historical information.

Subsequent Events - The Plan's management has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure.

NOTE 3 - ADMINISTRATIVE CONTRACTS

Medical and pharmacy claims of the Plan are administered by third-party service providers under the terms of administrative contracts. These contracts require performance of services necessary for the operation and conduct of the day-to-day business of the Plan. The third parties receive a monthly fee based upon the number of participants in the Plan. The Plan Sponsors pay 100% of the administrative fees; therefore, fees are excluded from the accompanying statement of changes in net assets available for benefits.

NOTE 4 - BENEFIT OBLIGATIONS

The liability for claims incurred but not reported is estimated by Plan management based on claims data provided by the Plan’s third-party claims administrators and while the Plan Sponsors believe that the amount is adequate, the ultimate obligation may be in excess or less than the amounts disclosed. Any differences in the amounts estimated and actual amounts paid will be reported in future years. These amounts, which are to be funded by contributions from the Plan Sponsors and participants through future contributions, have not been recorded in the accompanying cash basis financial statements.

NOTE 5 - TAX STATUS

The Plan received an exemption letter from the Internal Revenue Service (IRS) stating that the Plan is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). In addition, the Plan is required to operate in conformity with the IRC to maintain its tax-exempt status. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Plan Sponsors have the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue their contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Plan Sponsors or be used for purposes other than for the exclusive benefit of the Plan’s participants.

NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

The Plan Sponsors provide the Plan with certain accounting and administrative services for which no fees are charged.

NOTE 8 - RISKS AND UNCERTAINTIES

The estimated current benefit obligations incurred but not reported are based on certain assumptions, all of which are subject to change. Due to uncertainties inherent in these estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statement disclosures.
