NOTE A: DESCRIPTION OF PLAN

The following description of the Ritalka, Inc. (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

GENERAL – The Plan is a defined contribution plan covering all employees of the Company who have one hour of service in their first six months of employment, and are age 19 by entry date (January 1 and July 1 of each year). After that, the eligibility reverts to a Plan Year in which a participant must complete 1,000 hours of service. Affiliates include RVI, Inc., SpecSys, Inc., and Integral dx, Inc. The Plan is subject to the provisions of the ERISA. The Plan's Trustees are responsible for oversight of the Plan. The Plan's Trustees determine the appropriateness of the Plan's investment offerings and monitors investment performance.

CONTRIBUTIONS – Each year, participants may elect to contribute a percentage of their eligible compensation, subject to limitations, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company, at its discretion, may elect to make a matching or profit sharing contribution to the Plan. The Company elected to make a discretionary match of 25% on the first \$1,000 of employee deferrals for the year ended December 31, 2024. No profit sharing contributions were made for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

PARTICIPANT ACCOUNTS – Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING – Participants are vested immediately in their contributions, Company discretionary matching contributions, and Company discretionary profit sharing contributions plus actual earnings thereon.

PAYMENT OF BENEFITS – Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or partial withdrawals. The Plan allows for in-service distributions if a participant reaches age 59½ subject to Plan provisions. Benefits, if \$5,000 or less, shall be paid in the form of a lump-sum distribution.

FORFEITED ACCOUNTS – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,011 and \$964, respectively. These accounts will be used to offset plan expenses for the plan year in which the restrictions expire and to reduce future employer contributions. During the year ended December 31 2024, the company used \$0 to pay Plan fees and \$0 to reduce employer contributions from forfeited non-vested accounts.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING – The financial statements of the Plan are prepared on the accrual basis of accounting.

USE OF ESTIMATES – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

INVESTMENT VALUATION AND INCOME RECOGNITION – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Trustees determine the Plan’s valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

CONTRIBUTIONS – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

PAYMENT OF BENEFITS – Benefits are recorded when paid.

EXCESS COTNRIBUTIONS PAYABLE – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions the applicable participants on June 23, 2025.

EXPENSES – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

SUBSEQUENT EVENTS – The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

NOTE C: CERTIFICATION OF INVESTMENT INFORMATION

The Plan’s management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan’s management instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Standard Insurance Company, except for comparing such information certified by the insurance company with information included in the Plan’s financial statements and supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year).

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by the insurance company.

NOTE D: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, Fair Value Measurements are described as follows:

The Plan has investments in various pooled separate accounts which invest in equity and fixed income funds. The objective of those investment vehicles invested in equity investments is to approximate the risk and return characterized by various indexes; to seek long term capital appreciation; provide diversified exposure representative of various segments of the U.S. or foreign equity market; and/or to seek income. The objectives of the investment vehicles invested in fixed income is to provide investment results that approximate the overall performance of certain bond indices and/or to provide a predictable rate of return while preserving the safety of capital and minimizing market risk. The objective of the investment vehicles invested in target date funds is to provide various levels of asset allocations which become more conservative over time so participants can stay with the same fund before and after selected retirement dates. These investment vehicles are generally redeemable at net asset value under agreements with the underlying investment vehicles. However, it is possible that these redemption rights may be restricted by these investment vehicles in the future in accordance with underlying agreements.

Due to the nature of the investments held by the investment vehicles, changes in market conditions and the economic environment may significantly impact the net asset value of the investment vehicles, and consequently, the fair value of the Plan's interest in the investment vehicles. Furthermore, changes in the liquidity provisions of the funds may significantly impact the fair value of the Plan's interest in the investment vehicles.

NOTE E: RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of pooled funds were managed by Standard Insurance Company. Standard Insurance Company is the insurance company as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Fees paid by the Plan for the investment management services amounted to \$32,940 for the year-ended December 31, 2024.

NOTE F: PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE G: TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan is subjected to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H: DELINQUENT EMPLOYEE DEFERRAL TRANSMITTALS

The company erroneously failed to remit certain employee deferrals to the Plan in a timely matter aggregating \$247,310. The Company deposited \$243,844 during the year ended December 31, 2024 and deposited \$3,466 subsequent to year end.

NOTE I: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
