Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Croda Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We have performed audits of the financial statements of Croda Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Plan Description

The following description of Croda Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a contributory, defined contribution plan covering all eligible employees who have one full calendar month of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan adopted the 401(k) Safe Harbor Rules from the year ended December 31, 2006.

In August 2020, Croda International Plc. completed its acquisition of Avanti Polar Lipids. Effective January 1, 2022, Avanti Polar Lipids was added to the Plan as a participating employer.

Eligibility: Effective January 1, 2014, an employee becomes eligible to participate in the Plan on the first day of the month after starting employment at Croda Inc. (the Company) or an employee of an affiliate that has adopted the Plan. If any of the following criteria are met, the employee is ineligible to participate in the Plan: (a) the employee is included in a unit of employees that is covered by a collective bargaining agreement to which an employer is a party and during the negotiation of which retirement benefits were the subject of good faith bargaining, unless (and only to the extent) the participant's participation in the Plan is required by such collective bargaining agreement; (b) the employee is a nonresident alien and receives no earned income from the employer or any related employer which constitutes income from sources within the United States for the purposes of Section 861(a)(3) of the Internal Revenue Code (the Code); (c) the employee is a leased employee or (d) the employee is classified by the employer as an intern.

Contributions: Participants in the Plan may elect to contribute, on a pretax or Roth basis, up to the maximum annual elective contribution established by the Internal Revenue Service (IRS). Effective January 1, 2014, the Plan initiated an automatic enrollment (and escalation) program for new employees. Unless the new participant elects otherwise, this automatic deferral percentage starts at 4% of compensation and increases annually to 10% of compensation for employees with five or more years of service. Effective January 1, 2014, employees were no longer allowed to make after-tax contributions to the Plan (although the Plan still maintained accounts for prior after-tax contributions). Croda Inc. also matches 100% of the employee's pretax contributions up to 4% of covered compensation.

Effective January 1, 2009, the Company began making nonelective contributions (the retirement contribution) to the Plan for eligible employees who are not accruing benefits under any defined benefit pension plan (other than the cash balance portion of the Croda Inc. Retirement Plan) of the Company. The Company contributes 5% of covered compensation for eligible employees who are not receiving pay credits under the cash balance portion of the Croda Inc. Retirement Plan, and 1% of covered compensation for eligible employees who are receiving pay credits under the cash balance portion of the Croda Inc. Retirement Plan. Effective October 1, 2017, in conjunction with the freezing of the Croda Inc. Retirement Plan to new entrants and the merger of the Integrated Coating and Seed Technology, Inc. (INCOTEC) Retirement Plan into the Plan, new participants (and choice participants who elected out of additional pay credits in the cash balanced portion of the Croda Inc. Retirement Plan) will receive a retirement contribution from the Company equal to 4% of covered compensation. A choice employee is a participant with a cash balance accrued benefit on December 31, 2017, who elected during the choice election period to cease receiving future pay credits for the cash balance accrued benefit and active participation in the Croda Inc. Retirement Plan effective December 31, 2017.

Notes to Financial Statements

Note 1. Plan Description (Continued)

Participant accounts: Each participant's account is credited with the participant's contributions and the Company's matching contribution, as well as allocations of the retirement contribution, if applicable, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: All contributions, except certain employer retirement contributions and pre-2006 match contributions are fully vested. These retirement contributions become fully vested after a participant completes three years of service. Those participating in the pre-2006 match contribution will be fully vested if they reach age 65 or complete five years of service.

Notes receivable from participants: The Plan allows participants to borrow funds from their accounts, an amount equal to the lesser of 50% of the participant's account balance or \$50,000, with a minimum loan requirement of \$1,000. The term of the loan should generally not exceed five years. The Plan Administrator may permit repayment over a period of more than five years if such a loan is used for the purpose of purchasing a primary residence. Only one loan can be outstanding at any time. Interest rates on these loans range from 7.75% to 13.00%.

Investment options: The assets of the Plan, which comprise of various investment funds approved by the Company, are allocated to the various funds at the direction of the participants.

Payment of benefits: Vested benefits are payable upon death or termination with the Company. In-service withdrawals of after-tax and rollover contributions are permitted at any time. In-service withdrawals of pretax contributions are permitted in the event of financial hardship and when a participant attains 59½. Limited in-service withdrawals of matching and the retirement contributions that have been in the Plan for two years, or after five years of Plan participation, are permitted for certain former employees of National Starch and Chemical Company. All payments are made in a lump sum. There were no benefits payable at December 31, 2024 and 2023.

Forfeitures: Forfeitures of nonvested Company contributions are used to reduce future Company contributions. Forfeited nonvested accounts totaled \$65,105 and \$9,349 at December 31, 2024 and 2023, respectively. During 2024, \$402,168 of forfeitures were used to reduce employer contributions.

Subsequent events: The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Pension Committee determines the Plan's valuation policies utilizing information provided by the trustee and the investment advisor. See Note 4 for discussion of fair value measurements.

Benefit distributions: Payments to participants and beneficiaries for benefit distributions are recognized when paid by the trustee.

Expenses: All expenses incurred in the administration of the Plan are paid by the Company. However, individual transaction brokerage fees and certain other individually related expenses are paid directly from plan assets.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Risks and uncertainties: The Plan provides for various investment options which may invest in any combination of stocks and bonds, fixed income securities, mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near-term would materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 3. Information Certified or Provided by The Vanguard Group, Inc. (Vanguard) (Trustee)

The Plan Administrator has received from Vanguard a certification of financial information in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The accompanying financial statements and supplemental schedule were prepared from this certified data.

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, that was prepared by or derived from information provided by the Trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the best level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Investments that use the practical expedient are not classified within the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust: Valued at the NAV of shares in each account held by the Plan at year-end. The NAV is not a publicly quoted price in an active market. The NAV, as provided by the Trustee, is used as a practical expedient to estimating fair value.

Note 7. Tax Status

The Plan has received a determination letter from the IRS dated May 22, 2020, stating that the Plan is qualified under Section 401(k) of the Code and, therefore, the related trust is exempt from taxation. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

The Company's management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustments to the financial statements as of and for the year ended December 31, 2024. Therefore, no provision or liability for income taxes has been included in the financial statements.
