**Note 1 - Description of Plan**

The following description of Foster Fuels, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a contributory deferred compensation 401(k) plan covering all employees of Foster Fuels, Inc. (the "Company" or "Employer") who have completed one month of service and have reached age eighteen. The Plan allows the employees of the related employers, Phelps Creek Angus Farm, Inc., Southern VA Land, LLC., WRF Domestic, LLC., and Watt Foster Family Foundation, to participate. It was established January 8, 1995 and amended effective February 22, 2024 for change in eligibility requirement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, eligible participants may contribute pre-tax annual compensation or Roth contributions, as defined by the Plan. Participants may contribute up to the lesser of 90% of their compensation or the maximum allowed by the Internal Revenue Code ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Rollovers of pre-tax contributions and Roth contributions from another plan may also be accepted by the Plan. The Plan allows for auto enrollment for new participants at a starting rate of 2%. Participants auto enrolled are also subject to automatic rate increases of 1% on October 1 of each year to a maximum of 10%.

The Company provides for non-discretionary matching contributions equal to 50% of the first 6% of the participant's compensation contributed as elective deferrals. The Company may also make discretionary nonelective employer contributions. Both participants and employer contributions are subject to the nondiscrimination requirements of the Internal Revenue Code.

**Participant accounts**

Each participant's account is credited with the participant's contribution, including amounts rolled over from other qualified plans, and allocations of (a) the Company's contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment options**

Participants direct the investment of their contributions, employer match contributions, and employer nonelective contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and money market funds as investment options for participants.

**Vesting**

Participants are immediately vested in their elective deferrals and rollover contributions, plus actual earnings thereon. Participants are also immediately vested in the Company's matching and nonelective contributions plus actual earnings thereon.

**Payment of benefits**

On termination of service due to death, disability, retirement, or other termination of employment, a participant may elect to receive a lump-sum amount or rolled into another qualified retirement plan, equal to the value of his or her account. The Plan does allow for in-service distributions at age 59 ½. The Plan allows for hardship distributions from the participant's deferral balance subject to IRS regulations.

Distribution of the vested portion of a participant's account will occur upon the participant's termination due to death, disability or retirement, as defined in the Plan. For termination of service due to other reasons, if a participant's vested account balance is less than \$1,000, the participant will receive a lump-sum amount automatically. If a participant's vested account balance is more than \$1,000, the participant may elect to receive the value of the vested portion of their account as a lump-sum distribution, a partial distribution of their account, or annual installments over a period not to exceed the life expectancy of the participant or the joint and last survivor life expectancy of the participant and their designated beneficiary.

**Forfeitures**

Plan forfeitures may be used to reduce the employer's contributions to the Plan, be reallocated to participants or pay administrative expenses. During the Plan year ending December 31, 2024 and 2023, \$12,977 and \$-0- in forfeitures were reallocated to participants. Forfeitures of \$34 and \$12,167 were available at December 31, 2024 and 2023 to be used to reduce future employer contributions or pay administrative expenses, respectively.

**Note 2 - Summary of Accounting Policies**

**Basis of accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Investment valuation and income recognition**

The Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. If quoted prices are unavailable, estimated fair values are based on comparable investment of other issues with similar credit ratings. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payment of benefits**

Benefits are recorded when paid.

**Expenses**

Although not required by the Plan, a portion of the costs of Plan administration is absorbed by the Company.

**Excess contributions**

Excess contributions represent excess participant deferrals due back to the participant as a result of year-end plan testing.

**Credit risk**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Use of estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Note 3 - Fair Value Measurements**

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered investments* – Valued using quoted prices in active markets for identical assets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4 –Party-In-Interest Transactions**

Certain Plan investments are managed by Fidelity. Fidelity is the custodian/trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments and paid direct. Fees paid to Fidelity for Plan administration totaled \$212 and \$175 for fiscal year ending December 31, 2024 and 2023, respectively.

The Plan sponsors, owners, and key management are also participants in the Plan. Their account balances totaled approximately 16% and 20% of the net assets available for benefits as of December 31, 2024 and 2023, respectively.

**Note 5 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 6 – Income Tax Status**

The Internal Revenue Service has determined by letter dated June 30, 2020, that the adopted prototype plan is qualified under the appropriate sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter, however the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would be sustained upon examination by the Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

**Note 7 – Return of Excess Contributions**

Excess deferral contributions for 2024 and 2023 were \$-0- and \$20,745, respectively. Excess deferral contributions are returned to the participant.

**Note 8 – Financial Information Certified by the Trustee of the Plan**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**Note 9 – Revenue Sharing**

The Plan has entered into a plan expense agreement with the Plan’s trustee and custodian during 2022. Under the agreement, the Plan has moved to a fee levelization method, which allows the Plan Sponsor to equalize fees among all active participants. When revenue sharing with fee adjustment levelization is used, positive or negative fee adjustments are made to each investment option which is applied to the revenue sharing of each investment option to achieve levelization at an agreed upon rate. The Plan received \$5,113 and \$3,259 in revenue sharing income for the years ended December 31, 2024 and 2023, respectively.

**Note 10 – Subsequent events**

The Plan has evaluated subsequent events through October 4, 2025, the date the report is available for issuance. No events requiring disclosure have been noted.
