## Independent Auditor's Report

To the Participants and Administrator of the  
Evans Bank, N.A. Employees Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Evans Bank, N.A. Employees Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Responsibilities of Management for the Financial Statements

#### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Evans Bank, N.A. Employees Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan with salary reduction features as permitted under Section 401(k) of the Internal Revenue Code (IRC) and is sponsored by Evans Bank, N.A. (the Company). The Plan covers substantially all employees of the Company and affiliated companies who have one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

**Contributions:** Each year, participants may contribute up to the maximum amount allowed by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). All participants who are eligible to make elective deferral contributions may elect to designate all or any of their deferral contributions as a Roth elective deferral contribution. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan with salary deferrals of 3% of eligible compensation unless the employee makes an affirmative election to not have contributions made on his or her behalf or have contributions made in a different amount. Participants with a deferral rate greater than zero will have that deferral rate increased annually on March 1 by 1% until a deferral rate of 6% is reached. Participants can elect to decline this feature.

The Company makes a basic safe harbor match contribution equal to 100% of elective deferrals that do not exceed 1% of compensation for the allocation period plus 50% of elective deferrals that exceed 1% of eligible compensation, but do not exceed 6% of eligible compensation, as defined by the Plan. The Company also makes an additional safe harbor match contribution equal to 50% of a participant's elective deferrals which do not exceed 5% of eligible compensation, as defined by the Plan. In addition, the Company may make a discretionary non-safe harbor non-elective contribution. No non-safe harbor non-elective contributions were made for the years ended December 31, 2024 or 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and Company safe harbor contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant is 100% vested in basic safe harbor match contributions after two years of credited service and in additional safe harbor match contributions after six years of credited service.

**Payment of Benefits:** On termination of service due to death, disability, or retirement a participant may elect to receive the value of the vested interest in his or her account as a lump sum distribution. Balances under \$5,000 are automatically distributed and do not require participant consent. Hardship withdrawals are allowable from elective deferral accounts if IRS guidelines are met. Distributions, without penalty, may be made upon the attainment of age 59-1/2.

**Forfeited Accounts:** As of December 31, 2024 and 2023, there were no balances in the forfeiture account. These accounts are used to reduce future safe harbor contributions. Also, in 2024, safe harbor contributions were reduced by approximately \$8,312 from forfeited nonvested accounts (\$138,000 - 2023).

#### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation on investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payments of Benefits:** Benefit payments are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation on investments.

#### NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of registered investment company:** Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV is the closing price reported on the active market on which the securities are traded. Shares of registered investment companies are classified as Level 1.

**Common collective trust funds:** Valued based on the NAV per unit of the fund provided by the trust. The NAV is used as a practical expedient to measure fair value. Unit values are determined by dividing the fund's net assets, which represents the fair value of the underlying investments, by its units outstanding at the valuation date.

#### NOTE 4. PARTY-IN-INTEREST TRANSACTIONS

Administrative fees paid by the Plan to Schwab for administrative services amounted to \$95,194 for the year ended December 31, 2024 (\$83,830 - 2023). The Company pays directly any other fees related to the Plan's operations.

#### NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### NOTE 6. TAX STATUS

Effective January 1, 2022, the Plan adopted a non-standardized pre-approved profit-sharing plan sponsored by Schwab. The non-standardized pre-approved plan has received an opinion letter from the IRS, dated September 21, 2020, as to the Plan's qualified status. The non-standardized pre-approved profit-sharing plan opinion letter has been relied upon by the Plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 8. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets as of December 31, 2024 and 2023, as well as income and transactions for the years then ended, has been derived from information provided by Charles Schwab Trust Bank, the trustee, and has been certified by them as complete and accurate. The incorporation of this financial information in the accompanying financial statements and supplemental schedule is based solely on their certification and has not been audited by independent accountants.

#### **NOTE 9. PARTIAL PLAN TERMINATION**

In 2023, the Company downsized its operations which resulted in a partial plan termination. This affected 128 participants. Approximately \$2,915,000 in distributions were taken from the Plan in the current year (\$1,582,000 - 2023). As of December 31, 2024, approximately \$4,036,000 remains payable to affected participants. All participants affected by the partial plan termination became fully vested in their accounts prior to distributions being taken.

#### **NOTE 10. SUBSEQUENT EVENTS**

On September 9, 2024, it was announced that Evans Bancorp, Inc. was being acquired by NBT Bancorp.. This transaction was effective May 2, 2025. The Retirement Plan Committee voted to terminate the Plan on May 1, 2025, and all assets will be liquidated during 2025. Employers were given the option to distribute their balances out of the Plan. The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.
