INDEPENDENT AUDITORS' REPORT

To the 401(k) Committee of

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of KBF CPAs LLP 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of KBF CPAs LLP 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about KBF CPAs LLP 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of KBF CPAs LLP 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about KBF CPAs LLP 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



### NOTE A - DESCRIPTION OF THE PLAN

The following description of the KBF CPAs LLP 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### 1. General

The Plan was established effective January 1, 2018 and is a contributory plan covering all eligible employees of KBF CPAs LLP (the "Employer" or the "Firm") under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Plan was amended and restated for changes in laws and plan design.

#### 2. Eligibility

An employee, as defined in the plan agreement, is eligible for participation in the Plan upon attainment of age of 18, subject to monthly entry dates. Self-employed owners of the Firm are considered employees for plan purposes and are eligible to participate in the Plan (if at least age 18).

Interns, temporary, and seasonal employees are not eligible to participate in the Plan. Part-time employees, including temporary or seasonal employees, become eligible (if at least age 18) once they complete a Year of Service (1,000 hours during the eligibility computation period).

#### 3. Contributions

Participants may elect to make pre-tax and/or after-tax Roth contributions up to 50% of their compensation not to exceed the maximum deferral limit per Section 402(g)(1) of the IRC. In addition, the Plan provides a qualified automatic contribution arrangement (QACA) whereby eligible participants who otherwise have not made an affirmative deferral election are automatically enrolled in the Plan at a deferral rate of 6%, unless the participant elects a greater or lesser percentage (including zero). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may elect to transfer fully vested amounts from their non-Roth accounts to their Roth account in accordance with certain criteria.

The Employer makes safe harbor non-elective contributions under a QACA equal to 3% of a participant's compensation for all eligible participants except highly compensated employees. In addition, the Employer may make discretionary matching and/or discretionary profit sharing contributions to the Plan. For the year ended December 31, 2024, the Employer made QACA safe harbor contributions totaling \$169,760 (net of applied forfeitures of \$92,393) and discretionary profit sharing contributions totaling \$1,188,953 (net of applied forfeitures of \$92,393). There were no Employer matching contributions to the Plan during the year ended December 31, 2024.

#### 4. Participant Accounts

Each participant's account is credited with the participant's contributions (including rollovers), Employer discretionary matching contributions (if any), and allocations of the Employer QACA safe harbor contributions and discretionary profit sharing contributions, and plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### 5. Investment Options

Participants may elect to invest their accounts in any of the investment options offered by John Hancock Trust Company LLC ("John Hancock"), as approved by the Employer. Participants may change their investment options daily.

#### 6. Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to 50% of their vested account balance not to exceed \$50,000 (reduced by the highest outstanding loan balance during the previous twelve months). Loans shall bear a reasonable rate of interest and shall be secured by the balance of the participant's account. Loans must be repaid within five years, or within a reasonable longer period of time not to exceed ten years if the loan is for the purchase of a primary residence, as determined by the plan administrator. Participants may not have more than one loan outstanding at any time.

#### 7. Benefit Payments

Upon termination of employment, a participant is entitled to receive his or her vested account balance in a single lump sum, a partial lump sum, or in installment payments. When a participant attains normal retirement age or dies while employed, the participant or the participant's beneficiary is entitled to 100% of the participant's account balance. In addition, participants may receive distributions upon attaining age 59 ½ or for financial hardship if certain criteria are met. Effective November 12, 2024, Qualified Birth or Adoption Distributions (QBADs) became available from all contribution sources. Participant accounts with vested balances of \$7,000 or less may be automatically distributed or rolled to an IRA if no distribution election is made.

#### 8. Forfeitures

Forfeitures of terminated participants' non-vested accounts may be used to pay reasonable plan expenses or to reduce future Employer contributions at the Employer's discretion. As of December 31, 2024 and 2023, outstanding forfeitures available were \$184,785 and \$267,172, respectively, and are included in net assets available for benefits.

**9. Vesting**

Participant contributions, rollovers, and actual earnings thereon are fully vested at all times. Employer safe harbor QACA non-elective contributions vest 100% after two years of service. Vesting of the discretionary Employer matching and non-elective contribution portions of accounts is based upon the participant's years of service with the Employer as follows:

**10. Plan Termination**

Although it has not expressed such intent, the Employer reserves the right, at any time, to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all participants would become fully vested and contributions to the Plan would cease. The assets of the Plan would be distributed to the participants based on each individual participant's interest in the Plan.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**1. Basis of Presentation**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**2. Plan Administration**

The Employer is the plan sponsor and the plan administrator. The administrator of the Plan is responsible for carrying out the duties imposed under ERISA. John Hancock is the Plan's trustee.

**3. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

##### 4. Investment Valuation and Income Recognition

The investments of the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### 5. Payment of Benefits

Benefits are recorded when paid.

##### 6. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### 7. Administrative Expenses

Administrative expenses incurred by the trustee in performance of its duties are paid from the assets of the Plan. Substantially all other out-of-pocket administrative expenses of the Plan are paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

##### 8. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### NOTE C - CERTIFIED INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, reinvested gains, and other income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock (the trustee of the Plan), a qualified institution.

#### NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

*Collective investment trust:* The Plan invests in the Morley Stable Value Fund (the "Fund"), a collective investment trust. The Fund is primarily comprised of a diversified portfolio of fully benefit-responsive investment contracts issued by life insurance companies, banks, and other financial institutions and is valued at the NAV of units of the Fund. The Fund's NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

John Hancock is the trustee and John Hancock Retirement Plan Services, LLC is the record-keeper of the Plan. Plan investments are managed and held by the trustee. Transactions with these entities qualify as party-in-interest transactions. Notes receivable from participants and the related interest income are also considered party-in-interest transactions.

**NOTE F - TAX STATUS**

Effective January 1, 2024, the Firm adopted a new non-standardized pre-approved profit sharing plan with CODA (“pre-approved plan”) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. Prior to January 1, 2024, the firm had adopted another pre-approved plan which also received a favorable opinion letter from the IRS dated June 30, 2020. Each plan’s respective letter stated that the pre-approved plan as then designed, was in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
