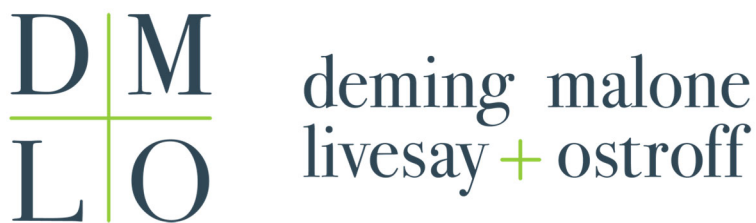

Independent Auditors' Report

To the Plan Administrative Committee

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Beverage Market, LLC 401(k) Retirement Savings Plan (Plan), formerly known as Employee Resource Group, LLC 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Beverage Market, LLC 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Beverage Market, LLC 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Beverage Market, LLC 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of The Beverage Market, LLC 401(k) Retirement Savings Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering certain employees, as defined in the plan document, of The Beverage Market, LLC (the Employer). Prior to January 1, 2022, employees who had attained age twenty-one and completed three months of service were eligible to participate in the Plan, with entry dates on the first day of each calendar quarter. Employees hired after January 1, 2022 must have attained age twenty-one and complete one year of service to participate in the Plan, with entry dates on January 1 and July 1. With regard to the employer matching contribution, participants were previously eligible to receive a contribution provided they had deferred an average of at least 6% of compensation during the plan year, had at least 1,000 hours of service during the plan year, and were employed on the last day of the plan year.

Effective January 1, 2022, the employer matching contribution is based on years of service. In addition, effective May 1, 2023, union employees of Beverage Market will receive a monthly profit sharing contribution ranging from \$100-\$125 for every month that they have completed one hour of service based on their years of service, with entry dates on the first day of the following month.

Thundering Beverage, LLC was added as an adopting employer on April 1, 2024. Atomic Distribution Company, Inc. has a five-year contract under Thundering Beverage, LLC ending in June 2027. The eligibility requirements for profit sharing contributions for the union employees of these employers are six months of service, with entry dates on the first day of the following month. There was also a special entry date on April 24, 2024 for salary deferral contributions for employees with one year of prior service at Atomic Distribution Company, Inc.

The Board of Directors is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions:

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer also makes a discretionary matching contribution each pay period. Effective January 1, 2022, the discretionary matching contribution is using a tiered rate schedule based on years of service. The match tiers are as follows:

Effective January 1, 2025, highly compensated employees will be excluded from receiving the discretionary match contributions.

Effective May 1, 2023, the Employer also makes a monthly profit sharing contribution to Beverage Market union employees for each month that they complete one hour of service, also based on years of service. The profit sharing tiers are as follows:

<u>Years of Service</u>	<u>Profit Sharing Contribution</u>
0-9.99	\$100 per month
10-14.99	\$115 per month
15 years or more	\$125 per month

Effective April 1, 2024, the profit sharing contribution for Thundering Beverage and Atomic Distribution Company union employees is \$225 per month for employees that have at least six months of service.

The total profit sharing contributions for the years ended December 31, 2024 and 2023 were \$79,360 and \$48,945, respectively. Contributions are subject to certain IRS limitations.

Participant accounts:

Each participant's account is credited with the participant's contributions and the Employer's contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer contributions portion of their accounts and earnings on those contributions is based on the years of service as outlined in the following table:

NOTES TO FINANCIAL STATEMENTS

Payment of benefits:

On termination of service due to death, disability, retirement, or termination of employment, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan specifically restricts the timing and method of benefit payments based upon the participant's age, length of service, account value and reason for termination. In the event of financial hardship, the Employer may allow a participant to withdraw from his or her account. The amount may not exceed the amount contributed by the participant, or the participant contribution account balance, if less.

Notes receivable from participants:

Effective May 1, 2023, participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range from 1-5 years. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. Interest rates are currently at 9.50%. Principal and interest is paid ratably through payroll deductions.

Forfeited accounts:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$518 and \$53, respectively. Forfeitures are to be used to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced by \$7,454 and \$3,795, respectively, from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

This summary of significant accounting policies of The Beverage Market, LLC 401(k) Retirement Savings Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTES TO FINANCIAL STATEMENTS

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions:

Contributions from Plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

NOTES TO FINANCIAL STATEMENTS

Note 3. Certified Investments

Certain information related to investments and notes receivable disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Global Investors Trust Company, a qualified institution, and Principal Life Insurance Company, a qualified institution.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active or inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

All assets have been valued using a market approach. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 or 2023.

Common/collective trust funds and pooled separate accounts – valued at the net asset value of units held by the Plan at year end. The net asset value is used as a practical expedient to estimate value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTES TO FINANCIAL STATEMENTS

The Plan held no assets required to be leveled within the fair value hierarchy as of December 31, 2024 or 2023. The following table sets for the Plan's assets measured at net asset value as of December 31, 2024 and 2023:

Investments Measured Using Net Asset Value per Share Practical Expedient:

The pooled separate accounts and common/collective trust funds have no unfunded commitments and can be redeemed daily, with no redemption notice period, without specific terms or conditions at the underlying investments' net asset value (NAV). The NAV is updated daily.

Note 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are guaranteed interest accounts or units of pooled separate accounts and common/collective trust funds managed by Principal Global Investors Trust Company and Principal Life Insurance Company. Principal Global Investors Trust Company and Principal Life Insurance Company are the custodian and insurance company, respectively, as defined by the Plan and, therefore, transactions with these entities qualify as party-in-interest transactions.

Principal Global Investors Trust Company and Principal Life Insurance Company provide certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Employer and Principal Global Investors Trust Company and Principal Life Insurance Company. Fees are asset-based and are netted monthly from the rate of investment return for all investment options, lowering the investment return. Fees paid by the Plan for the administrative services amounted to \$9,073 and \$29,068 for the years ended December 31, 2024 and 2023, respectively.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants are entitled to 100% of the value of their accounts.

Note 7. Tax Status

The Plan is a prototype plan offered by Retirement Management Services, LLC. The prototype plan obtained its latest opinion letter on March 22, 2021, in which the Internal Revenue Service stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTES TO FINANCIAL STATEMENTS

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risk and Uncertainties

The Plan has significant investments in pooled separate accounts and common/collective trust accounts held by Principal Global Investors Trust Company and Principal Life Insurance Company. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Corrective Employer Contributions

The corrective employer contribution for 2024 was required in order for the Plan to pass nondiscrimination testing. As part of this correction, all employees classified as Merchandisers and ERG-O during 2024 received a matching contribution of 50%, regardless of years of service as outlined in Note 1.
