**Note 1 – Plan Description**

---

The following description of the Rockydale Quarries Corporation 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General*

The Plan is a defined contribution plan covering all eligible employees of Rockydale Quarries Corporation and its subsidiaries, Appomattox Lime Company, Charlottesville Stone Company (operations at this subsidiary ceased in February 2018), and Mundy Stone Company, (the “Company”), who have completed sixty days of service and three hundred hours. Employees are automatically enrolled in the Plan at 1% on the first day of the month after satisfying eligibility requirements, unless they elect otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions*

Each year, participants may contribute any percentage up to 100% of pretax annual compensation, as defined by the Plan, up to the maximum allowed by law. Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants may direct their contributions into various investments offered by the Plan. The Plan Sponsor determines the formula for matching contributions annually, based on location. In 2024, participants received a 50% employer match of deferral contributions up to 8% of annual compensation. Additional amounts may be contributed at the option of the Company’s Board of Directors. The profit-sharing contribution was \$157,555 for 2024. Contributions are subject to certain limitations.

*Participant Accounts*

Each participant’s account is credited with the participant’s contributions, the Company’s matching and profit-sharing contributions, and allocations of Plan earnings and administrative fees. Allocations are based on participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary matching and profit-sharing contributions plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

*Payment of Benefits*

Upon attainment of normal retirement at age 65, termination of employment, or in the case of death or disability, a participant or their beneficiary will receive the vested portion of the amount credited to the participant’s account. Employees age 60 or older with at least 15 years of credited service may receive in-service withdrawals from their deferral and employer funded accounts. Employees age 60 or older with less than 15 years of service may receive in-service withdrawals from only their deferral account. Hardship withdrawals are also permitted, subject to the provisions described

in the Plan document. The participant may elect to receive a lump-sum distribution, or periodic payments as defined in the Plan provisions.

*Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$27,113 and \$12,376, respectively. Forfeitures may be used to reduce future employer contributions, reduce Plan expenses, or be allocated to participants in the Plan. In 2024, \$10,887 in forfeitures were used to reduce employer contributions.

**Note 2 – Significant Accounting Policies**

---

*Basis of Accounting*

The financial statements of the Plan are prepared under the accrual method of accounting.

*Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Benefit Payments*

Benefits are recorded when paid.

*Administrative Expenses*

Plan fees and administrative expenses are paid by the Plan or Company on a discretionary basis.

*Subsequent Events*

Subsequent events have been evaluated through October 13, 2025, the date the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The below table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024, and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

#### Note 4 – Related Party Transactions

Certain administrative functions are performed by employees of the Company. These employees are also Plan participants. No such employee receives compensation from the Plan.

#### Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### Note 6 – Tax Status

The Plan is adopted under a prototype plan sponsored by Ascensus, LLC. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
