The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a qualified institution, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note A – Description of Plan

The following description of the Zufall Health Center 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. The Plan established on June 1, 2007 and restated on June 1, 2012, is a defined contribution plan authorized under Section 403(b) of the Internal Revenue Code. All employees of the Company are eligible to make pre-tax contributions beginning on the plan entry date subsequent to when they are hired. The Employer match portion of the plan covers all employees of the company who completed one year of service and worked a minimum of 1,000 hours. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Each year, participants may contribute up to the maximum percentage allowable not to exceed the limits of Code Section 403(b). For 2024, the maximum deferral amount is \$23,000. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the plan. For 2024, the Company matched 100% of a participant’s deferral up to a maximum of 3% of a participant’s annual compensation. Contributions are subject to certain IRS limitations.

Participant Accounts. Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are immediately vested in their contributions and fully vested after six years in the employer contribution.

Notes Receivable from Participants. Effective March 27, 2020, the plan adopted a participant loan policy permitting the issuance of loans under certain circumstances. The administrator would not approve any loan to a participant in an amount which exceeded 50% of his or her nonforfeitable account balance. The maximum aggregate dollar amount of loans outstanding to any participant may not have exceeded \$10,000, reduced by the excess of the participant’s highest outstanding participant loan balance during the 12-month period ending on the date of the loan over the participant’s current outstanding participant loan balance on the date of the loan. Any loan granted or renewed under this program would bear an interest rate equal to 1% above the prime rate. The interest rate was fixed for the duration of the loan. Principal and interest are paid ratably through payroll deductions. The administrator fixed the maximum term for repayment of any loan based on the amount borrowed. The maximum term for plan loans were as follows:

Effective October 1, 2022, the Plan transferred its assets from Nationwide to Principal Trust Company and new loan requests are no longer permitted. All prior loans with Nationwide were carried over to Principal in which employees will continue to make their loan repayments until it is fully satisfied.

Payment of Benefits. On termination of service due to death, disability or retirement, a participant shall receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts. As of December 31, 2024 and 2023, forfeited accounts totaled \$35,422 and \$259,434, respectively.

Note B – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the

accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the trustee of the Plan).

Note D – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year-end.

Insurance co. general accounts: The Principal Guaranteed Option is reported at contract value. Contract value represents the amount participants would receive if they were to initiate a transaction under the terms of the ongoing plan. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate, as shown on the contract. The interest crediting rate is declared on a semi-annual basis. The contract amount maintained in the account is guaranteed against loss of principal, minus all withdrawals, including charges and adjustments. The guarantee is based on Principal's ability to meet its financial obligations from general assets.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following tables sets forth by level, within the fair value hierarchy, the plan's assets at fair value as of December 31, 2024 and 2023:

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

Note E – Principal Guaranteed Option

The Plan invests in the Principal Guaranteed Option (“PGO”), a benefit-responsive group annuity contract issued by Principal Life Insurance Company (“PLIC”) and held in custody by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. The contract provides for stable, competitive interest rates based on current market conditions through investments in fixed income securities of short to intermediate duration held in PLIC’s general account.

The PGO provides fully benefit-responsive features and is recorded at contract value, which approximates fair value, as reported to the Plan by the custodian. Contract value represents contributions made under the contract, plus interest credited, less participant withdrawals and administrative expenses. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Plan participants may withdraw all or a portion of their balances without fees or restrictions for “benefit-responsive events,” including termination of employment, retirement, death, or disability. Participant-directed transactions not resulting from a benefit-responsive event may be subject to restrictions and/or discontinuation charges, as defined in the contract.

The methodology for calculating the interest crediting rate is defined in the contract under the term “Composite Crediting Rate.” Under the terms of the existing contract, the crediting rate is reset on a semiannual basis, subject to a minimum guaranteed interest rate. The net crediting rate is the rate actually credited to participants’ balances, after any applicable fees.

Because the PGO is a single group annuity contract with a fixed rate of interest, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the contract itself, rather than being derived from a portfolio of underlying assets as would be the case with a stable value fund.

At December 31, 2024 (and 2023), the contract value approximated fair value.

The net composite crediting rate history for the contract is as follows:

By definition, the Principal Guaranteed Option (“PGO”) group annuity contract is an insurance contract. Accordingly, the Plan may transact according to the terms defined in the contract at any time. The provisions governing deposits, fees, benefits, payments, and limitations are specified in Article II (Deposits and Ownership – Vintages), Article III (Fees), Article IV (Benefits and Other Payments), and Article V (Limitations; Termination) of the contract.

Plan management should assess the probability of events occurring that could limit the Plan’s ability to transact with participants at contract value.

Article V of the contract defines the circumstances under which the Plan may terminate its interest in the contract, including any associated limitations or charges.

In addition, while PLIC may cease to accept new deposits under Article II, Section 4, any termination of the contract remains subject to the provisions of Article V.

Note G – Related Party and Party in Interest Transactions

Certain plan investments are shares of mutual funds managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the plan's trustee and custodian. Transactions in such investments qualify as party-in-interest transactions, which are exempt from prohibited transactions rules. Participant loans also qualify as party-in-interest transactions.

Note H – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note I – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated September 30, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note J – Plan Amendment

Effective April 1, 2023 the plan was amended to permit Roth deferrals. Effective May 1, 2023, the plan was amended to allow employees who normally work less than 20 hours per week to participate in the plan.

Note K – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits

Note L – ERISA Bond Requirement

The Employee Retirement Income Security Act of 1974 (ERISA) requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total plan assets and is required to be at least equal to the lesser of 10% of the plan's assets at the beginning of the plan year or \$500,000. At December 31, 2024, the Plan's sponsor maintained bond coverage in the amount of \$550,000.

Note M – Subsequent Events

Subsequent events were evaluated through October 7, 2025, which is the date the financial statements were available to be issued.
