Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of JumpCloud, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of JumpCloud, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan. Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, the "Trustee") serve as the plan trustee, and the Trustee's affiliate, Empower Retirement, is the recordkeeper for the Plan.

The Plan is available to employees of JumpCloud, Inc. (the "Company") who are not excluded employees. The entry date for eligible participants is the first day of the month coinciding with or next following the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make contributions of their annual eligible compensation, designated as pretax or after-tax Roth 401(k) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. A participant's pretax and Roth 401(k) contributions cannot exceed the maximum amounts allowed by law. The Plan also permits rollover contributions from other qualified retirement plans. Employee contributions to the Plan are made through regular payroll deductions. Participants may change their elective deferral contributions at any time. Eligible participants are automatically enrolled to participate in the Plan at a deferral rate equal to 6 percent of eligible annual compensation, as specified in the plan document, unless they elect not to participate or have specified a different deferral percentage. Participants who enter the Plan under auto-enrollment will have their contribution increase 1 percent per year until reaching 15 percent of compensation. Participants may change their elective deferral contributions at any time.

The Company may make a discretionary nonelective or discretionary matching contribution equal to a uniform percentage or dollar amount of elective deferrals each plan year to employees throughout the plan year. Each year, the Company will determine the formula for the discretionary matching contribution. The Plan will include catch-up deferrals in the elective deferral amount used to determine the amount of matching contributions. During the year ended December 31, 2024, the Company made discretionary matching contributions of 50 percent of employee deferrals up to 6 percent of compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Participant Notes Receivable

Through December 31, 2023, participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Participants may have only one loan outstanding at any given time. Notes receivable are collateralized by the participant's account balance; bear interest ranging from 7.5 percent to 10.5 percent, which is commensurate with local prevailing rates determined by the plan administrator at note origination; and mature at various dates through January 2029. Notes have a maximum term of five years. Principal and interest are paid ratably through payroll deductions. Upon termination of a participant from employment, the participant's note shall continue to be payable in accordance with the provisions of the participant's note or be due in full. Effective February 14, 2024, the Plan no longer allows for new participant notes receivable, and existing notes will be settled in accordance with the original terms.

Note 1 - Plan Description (Continued)

Benefit Payments

Upon death, disability, retirement, or termination of service, a participant, or his or her beneficiary, may receive, at his or her election, within a reasonable period of time, payment in the amount equal to the participant's vested account balance.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. The Plan also provides for hardship withdrawals for defined hardship events. Furthermore, the Plan allows for terminated participant vested account balances of \$5,000 or more to remain in the Plan; however, balances below will be distributed. The Internal Revenue Service (IRS) has required minimum distributions (RMD) once a participant reaches RMD age during the previous plan year and is no longer employed by the Company.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. If the Plan is terminated for any reason, all participants become 100 percent vested, and the plan administrator is to distribute each participant's interest to the participant or the participant's beneficiary.

During 2023, the Company had a reduction in force that resulted in a partial termination of the Plan. Accordingly, the terminated participants became 100 percent vested in their account balances.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Participants are 100 percent vested on matching contributions after one year of service. Vesting in the Company's nonelective contribution portion of their accounts, plus actual earnings thereon, is based on years of service, according to the following schedule:

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. As of December 31, 2024 and 2023, forfeited account balances totaled \$9, with approximately \$42,500 utilized during the year ended December 31, 2024.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by the Trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. The Plan provides for loans to participants, which are party-in-interest transactions. The aforementioned transactions are exempt from the prohibited transaction rules.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value, excepted as noted below. The Plan's mutual funds are stated at fair value based on quoted market price.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets.

See Note 5 for additional fair value information.

The investment contract is considered fully benefit responsive and is presented at contract value. Contract value represents investments at cost plus accrued interest income less amounts withdrawn to pay benefits.

The net realized and unrealized investment gain or loss (net appreciation or depreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 25, 2025, which is the date the financial statements were available to be issued. Subsequent to the plan year, a partial plan termination occurred due to a significant reduction in workforce. Approximately 20 percent of plan participants were involuntarily terminated. As a result, all affected participants became fully vested in their account balances at the date of termination.

Note 3 - Certified Information

The Trustee holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 6 - Investment Contracts

The Plan has a benefit-responsive investment contract with Empower Annuity Insurance Company of America. The Trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium- to long-term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such significant events are defined in the investment contract and consist of items such as plan termination or premature termination of the contract. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable.
