NOTE 1 - DESCRIPTION OF PLAN

The following description of The Production Hive, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan that covers all eligible employees of The Production Hive, LLC (the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective November 26, 2019, an amendment was filed to change the Plan name from Jupiter Entertainment, LLC 401(k) Plan to The Production Hive, LLC 401(k) Plan. The amendment was filed due to restructuring at the Plan sponsor level. The Production Hive, LLC was formed by Jupiter Entertainment Holdings, LLC, the sole parent of Jupiter Entertainment, LLC (the former Plan sponsor), and is now recognized as the Plan sponsor. No funds were transferred into or out of the Plan as a result of this amendment.

The Plan has entered into an agreement with Great-West Life & Annuity Insurance Company (marketed as "Empower Retirement") and has appointed this company as trustee of the Plan assets. The recordkeeping of the Plan has also been delegated to Empower Retirement.

Eligibility - Employees of the Company become eligible to participate in the Plan after completing three months of service. Employees of the Company become eligible for employer safe harbor matching and profit sharing contributions after completing one year of service and reaching 21 years of age. For the purposes of both employee and employer contributions, employees may participate in the Plan on the date they satisfy eligibility requirements.

Contributions - Participants may defer up to 100% of their eligible compensation into the Plan, up to the maximum amount allowed by the Internal Revenue Code ("IRC"). Contributions are made on a pre-tax basis. Participants who have attained the age of fifty before the end of the Plan year are eligible to make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct allocation of their contributions into various investment options offered by the Plan. The Plan offers multiple registered investment companies and a common/collective trust as investment options for participants.

The Company provides a safe harbor matching contribution equal to 100% of participants' elective deferrals that do not exceed 4% of the participant's compensation. The Company made \$414,584 in safe harbor contributions for the year ended December 31, 2024.

The Company may also make discretionary profit sharing contributions. No such contributions were made for the year ended December 31, 2024.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) Company contributions (if any) and (b) plan earnings (losses), and charged with an allocation of administrative expenses. Allocations to each participant are based upon the ratio of their account balances to the total of all participants' account balances.

Vesting - Participants are immediately vested in their contributions and employer safe harbor matching contributions, plus actual earnings thereon. Participants vest in other Company contributions after three years of service.

Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 for both years then ended. There were no forfeited amounts during 2024. Forfeitures may be used to reduce Company contributions or to pay Plan expenses.

NOTE 1 - DESCRIPTION OF PLAN - (Continued)

Hardship Withdrawals - The Plan allows participants to withdraw a portion of their account balance in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions.

Payment of Benefits - On termination of service due to death, disability, retirement, or separation, participants may receive a lump-sum payment equal to the participant's vested interest in his or her account. Vested account balances less than \$5,000 are automatically distributed without participant consent.

Administrative Expenses - Plan expenses may be paid out of Plan assets unless paid directly by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates - The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Quoted market prices are used to value investments. Shares of registered investment companies are valued at the net asset value of shares held by the Plan at year-end. The common/collective trust is stated at contract value based on the net asset value of the underlying securities.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments held during the year. Employee contributions are recorded when salaries are paid. Employer matching contributions are recorded when authorized.

Benefit Payments - Benefit payments are recorded when paid.

Date of Management's Review - Management has evaluated events and transactions occurring subsequent to the statements of net assets available for benefits date for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through October 13, 2025, which is the date these financial statements were available to be issued.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. A valuation hierarchy has been established for disclosure of the inputs used to measure fair value. This hierarchy prioritizes the inputs into three broad levels. Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities. Level 2 inputs are quoted prices for similar assets and liabilities in active markets or inputs that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. Level 3 inputs are unobservable inputs based on the Plan's assumptions used to measure assets and liabilities at fair value. A financial asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies (Level 1) - The fair value of registered investment companies (mutual funds) is based on quoted net asset values of the shares held by the Plan at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - COMMON/COLLECTIVE TRUST

The Plan sponsor has a trust agreement with Empower Retirement which authorizes participation in the Key Guaranteed Portfolio Fund (the "Fund"), a common/collective trust. As clarified by the Financial Accounting Standards Board (FASB) with the issuance of Accounting Standards Update (ASU) 2015-12, fully benefit-responsive investment contracts are required to be reported at contract value. Because the Fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributed to the Fund because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund's net asset value ("NAV"). Distribution to the Fund's unit holders is declared daily from the net investment income and automatically reinvested in the Fund on a monthly basis, when paid. It is the policy of the Fund to use its best efforts to maintain a stable net asset value, although there is no guarantee that the Fund will be able to maintain this value.

Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value to any other investment option offered under the Plan at any time with no restrictions or penalties. Contract value, as reported to the Plan by Empower Retirement, represents contributions made into the Trust, plus earnings, less participant withdrawals and administrative expenses. The crediting interest rate of the Fund fluctuates. The average yield earned by the Plan (derived by averaging the Fund's quarterly gross interest rates) for 2024 and 2023 was 1.41% and 1.23%, respectively. The actual average yield earned by the Plan (derived by averaging the Plan's quarterly interest rates) was 1.41% and 1.23%, respectively.

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions set forth in ERISA. In the event of a Plan termination, no further contributions would be made to the Plan and participants would become 100% vested in their Company contributions.

NOTE 7 - TAX STATUS OF PLAN

The initial effective date of the Plan was January 1, 2001. Effective July 15, 2021, the Plan was amended and restated and adopted the Tennessee Pension Administrators, LLC Non-Standardized Pre-Approved Profit Sharing Plan with CODA (the "TPA Prototype Plan"). The Internal Revenue Service determined and informed Tennessee Pension Administrators, LLC (the "TPA") by a letter dated June 30, 2020, that the TPA Prototype Plan, as then designed, was in accordance with applicable sections of the IRC. The Plan has not filed for its own determination letter. Although the Plan has been amended since the pre-approved profit-sharing plan determination letter was issued, the Plan administrator and the Plan's tax counsel believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan recognizes tax loss contingencies when it is probable that a liability had been incurred and the amount of the loss could be reasonably estimated. The amount recognized would be subject to estimates and management's judgment with respect to the likely outcome of each uncertain tax position. Although the tax years ending December 31, 2021 through December 31, 2024 remain open for examination by various taxing authorities, it is management's opinion that no significant uncertain tax positions remain open at December 31, 2024.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - PARTY-IN-INTEREST

The Company is the administrator of the Plan and, as such, executes the normal duties associated therewith. Costs incurred for legal and other administrative functions are paid by the Company on behalf of the Plan. There were no financial transactions recorded between the Company and the Plan other than contributions made by the Company to the Plan. Costs for audit are paid by the Plan. The TPA provides certain administrative services to the Plan. The Plan's investment adviser is Proffitt & Goodson, Inc. The Plan invests in funds managed by Empower Retirement. Empower Retirement acts as contract holder and recordkeeper for those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.
