Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of J.C. Cannistraro, LLC 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Plan Description

The following description of J.C. Cannistraro, LLC 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document and trust agreements for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan which incorporates the provision of Section 401(k) of the Internal Revenue Code (IRC). The Plan is sponsored by and covers all eligible employees of J.C. Cannistraro, LLC (the Company or Employer) who meet the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In a prior year the Plan adopted the Cycle 3 Restatement Plan Document in order to be in compliance with current laws and regulations. The Plan was amended effective January 1, 2023, to allow that all compensation is taken into account, including compensation earned while an individual is not a participant and allow a participant a special deferral election on annual bonus pay (the special deferral election does not apply to sign on bonuses and referral bonuses). The Plan was further amended on January 1, 2024 to further amend the definition of compensation.

Eligibility: All employees, except employees covered under a collective bargaining agreement, non-resident aliens who do not receive any compensation from U.S. sources, leased employees, interns and co-ops and temporary seasonal employees, who have reached the minimum age requirement of 18 and completed 30 consecutive days of service are eligible to participate in the Plan. Once a participant has satisfied the eligibility conditions previously described, participants will be eligible to participate under the Plan immediately.

Contributions: Each year, participants may contribute up to 75% of eligible annual compensation, as defined in the Plan up to the maximum amount allowed by the IRC. Participants may also contribute amounts representing distribution from other qualified defined benefits or contribution plans. The Company presently matches 50% of the participant's pretax and Roth contributions up to 6% of the participant's compensation contributed to the Plan. Effective July 1, 2017, for newly hired employees and existing participants that have no salary reduction agreement in effect, an automatic deferral election of 6% will be deemed to have been made unless the participant elects otherwise.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contribution and (b) the Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions or pay plan expenses.

Vesting: Participants are immediately vested in their pretax contributions, Roth contributions and rollover contributions plus actual earnings thereon. Vesting in the Employer's matching portion of their accounts plus actual earnings thereon is based on years of continuous service. Effective July 1, 2017, participants are 50% vested after one year of service, 75% vested after two years of service and 100% vested after three years of service.

Notes receivable from participants: Eligible participants are allowed to apply for loans against a portion of their vested balance in the Plan. Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 reduced by the highest outstanding balance in the previous 12-month period, or 50% of their vested account balance. Participants may only have one loan outstanding at a time. Terms range up to five years for a general purpose loan and up to 30 years the purchase of a primary residence. The notes receivable from participants are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. At December 31, 2024, these rates range from 4.25% to 9.50% on outstanding notes receivable from participants and the loans mature through 2054. Principal and interest are paid ratably through weekly payroll deductions.

Note 1. Plan Description (Continued)

Payment of benefits: On termination of service due to death, disability or retirement, the Plan provides for a participant or beneficiary to receive a lump-sum amount or installment payments equal to the value of the participant's vested balance in his or her account. The Plan allows participants to take full or partial distributions upon termination of employment. If a participant has a balance between \$1,000 and \$7,000 at the time of termination, the balance will be rolled into an individual retirement arrangement (IRA). If the participant has a balance of less than \$1,000, their entire vested benefit will be distributed to them in a lump sum, even if they do not consent to a distribution.

In addition, the Plan allows for in-service distributions due to hardship if certain criteria are met, have reached the age of 59½, have reached normal retirement age (65), have become disabled, or are in certain qualified active military duty (salary deferrals only) and are subject to certain limits per the plan document. Participants may also take in-service distributions from after-tax contributions at any time.

The Plan also allows for required minimum distributions beginning April 1, following the end of the calendar year in which the participant obtained the required age defined in the plan document.

Plan termination: The Company expects to continue the Plan indefinitely but reserves the right to amend or terminate the Plan at any time. In the event of a partial or complete termination of the Plan, each participant's account becomes fully vested.

Forfeited accounts: Forfeitures of terminated participants' nonvested accounts can be used to pay Plan expenses, reduce Employer contributions or reallocate as an additional Employer contribution. The forfeiture balances in 2024 and 2023 were \$33,834 and \$51,124, respectively. During the year ended December 31, 2024, there were \$5,638 in forfeitures and earnings and \$22,928 was used to pay administrative expenses. Employer contributions and plan expenses were not reduced from forfeited accounts for the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Risk and uncertainties: The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the financial statements.

Investment valuation and income recognition: The Plan's investments are stated at fair value except for the fully benefit-responsive group annuity contract, which is reported at contract value, as disclosed in Note 5. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Note 2. Summary of Significant Accounting Policies (Continued)

Purchases and sales of shares of securities are recorded on the trade-date basis. The net appreciation (depreciation) in fair value of investment securities consists of the net change in unrealized appreciation (depreciation) and realized gains (losses) upon sale of investments. The net change in unrealized appreciation (depreciation) and realized gains (losses) upon sale are determined using the fair values as of the beginning of the year or the purchase price, if acquired since that date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Administrative costs associated with participant activity, such as loan and distribution requests, are paid by the related participants. Investment fees are paid out of plan assets and are charged to participant accounts based on their individual transactions. Other administrative expenses related to plan recordkeeping are paid utilizing funds held in the forfeiture account or are paid by the Company.

Income taxes: U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by a tax authority. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2021.

Note 3. Information Prepared and Certified by the Plan's Insurance Company and the Trustee

The following is a summary of the plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified by Empower Annuity Insurance Company of America, the insurance company, and Empower Trust Company, LLC, the trustee of the Plan. The Plan Administrator has obtained certifications from the insurance company and the trustee that information provided to the Plan Administrator by the insurance company and the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets:

Note 4. Fair Value Measurements

The Plan follows the guidance in Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, which defines fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the current period.

Mutual funds: Mutual funds are valued at the quoted market price (Level 1).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Group Annuity Contract

In 2015, the Plan entered into a traditional fully benefit-responsive group annuity contract, called the Key Guaranteed Portfolio Fund, with Great-West Life & Annuity Insurance Company. The insurance company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the group annuity contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The average interest rate credited to participant accounts in 2024 and 2023 was 1.45% and 1.30%, respectively. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the insurance company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include plan termination and certain other sponsor-initiated events. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5. Group Annuity Contract (Continued)

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include if the issuer or the Plan declares a contribution cessation date upon written request to the other. The contribution cessation date should be specified in the request and must be at least 90 days from the date of the request. If a contribution cessation date is not specified in the request, the contribution cessation date shall be the next business day on or after the 90th day after the date the request is received by the Plan. After a contribution cessation date is declared: (a) no further contributions will be made to the group annuity contract and (b) no new participant annuity accounts will be established. The participant annuity account value will be maintained until the payment commencement date.

Note 6. Party-in-Interest

Certain Plan investments are managed by the insurance company, as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Notes receivable from participants held by the Plan are also considered party-in-interest transactions.

As discussed in Note 2, J.C. Cannistraro, LLC (the Plan Sponsor) pays certain expenses in administering the Plan such as audit fees and annual report preparation fees. The Plan Sponsor provides certain accounting, administrative and investment management services to the Plan for which no fees are charged.

Members of the Board of Trustees of the Plan Sponsor are currently active participants in the Plan. Several of the trustees serve as officers of the Plan Sponsor and administrators of the Plan.

Note 7. Nonexempt Transactions

During 2024, 2023 and 2022, the Plan Sponsor inadvertently failed to deposit approximately \$27,000, \$42,000 and \$6,700 of participant contributions and loan repayments within the required timeframe as stated by the United States DOL regulations, respectively. The Plan Sponsor deposited lost earnings to correct the plan year 2023 and 2024 failures in 2025 and 2022 failures in 2024 and filed Form 5330. The plan years 2022, 2023 and 2024 corrections and any excise taxes, if applicable, have been made from the Plan Sponsor's assets and not from assets of the Plan.

Note 8. Income Tax Status

The Plan has adopted a non-standardized form profit share/401(k) plan. The pre-approved plan provider, HUB International Limited, acting as the third-party administrator of the Plan, received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan is designed in accordance with the applicable sections of IRC. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and is tax exempt.

Note 9. Subsequent Events

The Plan Administrator has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
