Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Trib Total Media, LLC & Subsidiary Master Plan for Savings and Investment (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Trib Total Media, LLC & Subsidiary Master Plan for Savings and Investment's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 – Plan Description

The following brief description of Trib Total Media, LLC & Subsidiary Master Plan for Savings and Investment (the Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all eligible employees of Trib Total Media, LLC (the Company), 535 Media, LLC (a related employer), and PrintSource Pittsburgh, LLC (a related employer). Fidelity Management Trust Company (Fidelity) serves as the trustee for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Investment Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Eligibility – The Plan covers all employees 21 years of age or older who have completed six months of service by the end of a twelve month period except for employees covered by a collective bargaining agreement for which benefits have been the subject of good faith negotiations. Unless employees elect otherwise, eligible participants are automatically enrolled in the Plan.

Contributions – Participants – Participants may make salary savings contributions to the Plan up to 60% of pre-tax annual compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Pre-tax and catch-up contributions are limited to the maximum allowable annual contributions as determined by Internal Revenue Service (IRS) limitations. Participants may make deferrals to the Plan on an after-tax basis in accordance with Roth 401(k) provisions of the Economic Growth and Tax Reconciliation Act of 2001. Participants may change their contribution deferral elections each payroll period. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Prior to February 1, 2018, automatically enrolled participants had their deferral rate set at 3% of eligible compensation. Effective February 1, 2018, the automatic enrollment rate was increased to 4% of eligible compensation, which increases 1% each year in January up to a maximum deferral rate of 10% and contributions are invested in a designated balance fund until changed by the participant.

Contributions – Employer – Safe Harbor Matching – The Company and related employers contribute a safe harbor 401(K) matching contribution in an amount equal to 100% of a participants’ elective deferral up to 4% of eligible compensation.

Vesting – Participants are always 100% vested in their contributions, safe harbor matching and qualified nonelective contributions plus actual earnings thereon. Vesting in any top-heavy contributions plus actual earnings thereon is according to the following table:

Participant Accounts – Participant accounts are credited with the participant’s contributions and allocations of the Company and related employers’ contributions and plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants – Participants may borrow from their fund account a minimum of \$1,000 to a maximum equal to the lesser of one-half of their vested account balance, or \$50,000, reduced by the highest outstanding loan balance in their account during the prior twelve month period. Up to 50% of a participant’s vested account balance may be used as collateral for any loan. The loan interest rate, determined at the time of the loan issuance, is set at 1 percent above the prime rate, as defined. Principal and interest are paid ratable through after-tax payroll deductions on at least a quarterly basis over a five year period unless the loan is for the purchase of a principal residence in which case the loan repayment period may not extend beyond 10 years from the date of the loan.

Retirement – Normal retirement occurs on the first day of the month coinciding with or following an employee attaining age 65. A participant may elect to postpone retirement until age 70 ½.

Payment of Benefits – A participant will receive a lump-sum amount equal to his or her vested account balance. Payment is available to a participant only at retirement, termination of employment, the attainment of age 59 ½, or permanent and total disability. Payment is made to a participant’s designated beneficiary upon death. The Plan has provisions for hardship withdrawals under certain circumstances.

Forfeitures – At December 31, 2024 and 2023, forfeited nonvested balances totaled \$4,395 and \$3,794, respectively. Forfeitures may be used to reduce future employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of Presentation – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Valuation of Investments and Investment Transactions – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Directors determines the Plan’s valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Note 2 – Summary of Significant Accounting Policies (continued)

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses on the sale of investments are determined on weighted average cost which includes transaction expense. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Fees related to benefit payments and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Recordkeeping fees are also charged to the participant's account. These fees are reduced by credits received under revenue sharing agreements. Participants may elect to enroll in investment advisory services. These fees are based on a percentage of the participant's assets and are charged directly to the participant's account and are included in administrative expenses. Other investment related expenses are included in net change in fair value of investments. All other expenses incurred by the Plan are paid by the Company.

Note 3 – Financial Information Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity Management Trust Company, except for comparing such information certified by Fidelity to information included in the Plan's financial statements and supplemental schedule.

The trustee certified to the completeness and accuracy of all investment activity reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the supplemental schedule as of December 31, 2024:

Note 4 – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Registered investment companies are valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of registered investment companies managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, there transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Expenses paid by the Plan for investment advisory fees and transaction fees amounted to \$63,466 for the year ended December 31, 2024. This amount was reduced by \$90,963 in fee credits from revenue sharing arrangements.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has reserved the right to terminate the Plan or reduce or cease contributions at the discretion of the Board of Directors, or to amend the Plan at any time and in any respect, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balance.

Note 7 – Tax Status

The Plan uses a prototype plan document sponsored by FMR LLC. The IRS has determined and informed FMR LLC by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Note 7 – Tax Status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan's tax returns for 2021, 2022, and 2023 are subject to examination by the taxing authorities, generally for three years after they were filed.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 – Plan Amendment

On January 1, 2023, the Plan was amended to calculate the employer match on a plan year basis instead of a per payroll period basis.

Effective February 19, 2024, interns and temporary employees are eligible for the plan as long as they meet age and service eligibility requirements.

Note 10 – Subsequent Events

The Plan was amended to add certain withdrawal provisions of the SECURE Act and the SECURE 2.0 Act effective January 1, 2025.

Subsequent to year end, Plan was amended to add PrintSource Pittsburgh, LLC as a participating employer of the Plan.

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.
