## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
Connecticut Laborers' Health Fund

### Opinion

We have audited the financial statements of the Connecticut Laborers' Health Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in its benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. The Schedule of Assets Held at End of Year and Schedule of Reportable Transactions represent supplemental information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Supplemental information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

**NOTE 1. DESCRIPTION OF PLAN**

The Connecticut Laborers’ Health Fund (the Plan) provides health, disability and death benefits for members and their covered dependents working under the terms of the collective bargaining agreement with the Laborers’ Union of Connecticut. The trust established under the Plan is qualified under Section 501(c)(9) of the Internal Revenue Code and, accordingly, the trust’s net investment income is exempt from income taxes.

Members are initially eligible on the first day of the second month after working 300 hours in covered employment, as reported to the Plan, within 3 consecutive months. To maintain eligibility, effective January 1, 2023, members must work 1,000 hours (previously 800 hours) in covered employment, as reported to the Plan, during the preceding 10 months, or 300 hours during the preceding 3 months. Coverage is continued for up to one year for participants who cease to be actively employed because of a disability. If eligibility terminates, participants are offered COBRA continuation privileges and may elect to continue coverage by making direct payments to the Plan.

Coverage may also be extended to employees of participating employers who do not work in covered employment as a laborer by executing a Participation Agreement, which requires approval by the Board of Trustees. A monthly contribution to the Plan is required for all such eligible employees.

Coverage is also available for retired members who are receiving a monthly pension from the Connecticut Laborers’ Pension Fund or who are retired as recognized by the Fund, and have worked 10,000 hours in covered employment during the fifteen (15) consecutive calendar years prior to retirement, and were eligible for active coverage from the Fund at the time of their retirement. A monthly contribution to the Plan is required for all retirees electing coverage.

The Plan participates in the insured Medicare Advantage Plan through Aetna. The Plan pays a monthly premium for each Medicare eligible participant to supplement basic medical and hospitalization. The Plan is self-insured for purposes of providing prescription drug, vision and hearing benefits for these participants.

The Plan also offers prescription drug benefits to Medicare eligible retirees via the Medicare Advantage Plan. The Plan is self-insured for purposes of providing vision and hearing benefits for these participants.

The Plan participates in a stop-loss insurance arrangement to limit its exposure for self-insured benefits. Coverage obtained is for individual participant claims over a specific dollar amount.

**NOTE 1. DESCRIPTION OF PLAN (continued)**

The Plan's Board of Trustees has the authority to terminate, suspend, withdraw, amend, or modify the Plan in whole or in part at any time.

The foregoing description of the Plan provides only general information. Participants should refer to the summary plan description for more complete information.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** – The accompanying financial statements are prepared on the accrual basis of accounting. Employer contributions and investment income are recognized when earned and expenses are recognized when incurred.

**Estimates** - The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

**Reciprocal Agreements** – The Plan is a party to reciprocal agreements with other health and welfare funds of the Laborers International Union of North America.

**Valuation of Investments and Income Recognition** - The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investment bought and sold as well as held during the year.

**Benefits** – Benefits are recorded monthly when paid.

**Property and Equipment** - Property and equipment are stated at cost. Provisions for depreciation are computed by the straight-line method over the estimated useful lives of the assets which range from five to seven years.

Depreciation expense for the years ended December 31, 2024 and 2023 was \$59,636 and \$51,368, respectively.

**Credit Risk** - The Plan maintains its cash with a financial institution deemed to be credit worthy. Cash balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 in a single bank. As of December 31, 2024, cash on deposit with Webster Bank totaling \$5,381,413 exceeded the FDIC coverage in a single bank by \$5,131,413.

**Stop Loss Insurance** - Premiums for stop loss insurance are included in insurance premiums paid in the accompanying statements of changes in net assets available for benefits. Premiums for stop loss insurance for the years ended December 31, 2024 and 2023 were \$848,383 and \$774,817, respectively. Reimbursements received by the Plan under stop loss policies for the years ended December 31, 2024 and 2023 were \$1,194,233 and \$1,164,826, respectively.

**Postretirement Benefit Obligations** - The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to a participant's service rendered to December 31, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated participants and their beneficiaries and dependents, and (2) active participants and their beneficiaries and dependents after retirement from service with the participating employers.

Prior to an active participant's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that participant's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement obligations are determined by an actuary and are the amounts that result from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The tables with the generational projection to the ages of participants as of the measurement date reasonably reflect the mortality experience of the Plan as of the measurement date. These mortality tables were then adjusted to future years using the generational projection to reflect future mortality improvement between the measurement date and those years.

**Other Plan Benefits** - Plan obligations at December 31, 2024 and 2023 for health claims incurred by active participants but not reported at that date and for accumulated eligibility of participants are estimated by the Plan's actuary at their actuarial present value. Health claims incurred by retired participants but not reported at year end are included in the postretirement benefit obligation.

### **NOTE 3. PLAN TERMINATION**

The Trustees expect and intend to continue the plan indefinitely but reserve the right to amend or terminate it. In the event the Plan terminates, the Trustees shall first apply the net assets to any obligations outstanding and any remaining balance in such manner as will best effectuate the purpose of the Plan.

Under no circumstances shall any portion of the Plan, directly or indirectly, revert or accrue to the benefit of any contributing employer or the Union.

### **NOTE 4. TAX STATUS**

The Plan obtained its latest determination letter on November 9, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving this determination letter. However, the Plan's legal counsel believes that the Plan is currently designed, and the Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the trust is tax-exempt under Section 501(c) (9) of the IRC as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

### **NOTE 5. CONTRIBUTIONS FROM CONTRIBUTING EMPLOYERS**

The Plan provides for contributing employers to contribute a specified amount per hour worked by each of their employees who is in covered employment. Contributions from contributing employers are accounted for as exchange transactions. The contribution rate at December 31, 2024 and 2023 was \$12.39 and \$12.14 per hour, respectively. Contributing employers are predominantly construction contractors operating in the State of Connecticut.

Contributions receivable from employers in the amount of \$5,013,943 and \$5,153,556 at December 31, 2024 and 2023, respectively, have been shown on the statements of net assets available for benefits and the changes in these amounts have been reflected in the statements of changes in net assets available for benefits. The balance receivable at December 31, 2024 and 2023 consists of amounts known to be due from employers for work performed through December 31. The balance receivable includes actual collections subsequent to year end and delinquent amounts owed under settlement agreements, net of allowances for credit losses. There was no allowance for credit losses for uncollectible settlement agreements for the years ended December 31, 2024 and 2023. Additional amounts due for unreported hours or disputed amounts are not subject to reasonable estimation and are recorded when collected. Contributing employers are predominately construction contractors operating in the State of Connecticut.

**NOTE 5. CONTRIBUTIONS FROM CONTRIBUTING EMPLOYERS (continued)**

The costs of the postretirement benefit plan are shared by the Plan's participating employers and retirees. In addition to deductibles and co-payments, projected participant contributions in the current and prior year were as follows:

**NOTE 6. BENEFIT OBLIGATIONS**

The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023 relates primarily to the postretirement benefit obligation, the funding of which is not covered by the contribution rate provided by the current bargaining agreement. It is expected that the deficiency will be funded through future increases in the collectively bargained contribution rates.

The health care cost-trend rate assumption, as more fully described in Note 2, has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023 by \$20,630,216 and \$19,332,612, respectively.

**NOTE 7. MULTIEMPLOYER DEFINED BENEFIT PENSION PLAN**

Employees of the Connecticut Laborers' Health Fund (Health Fund) and the Connecticut Laborers' Legal Services Fund participate in one multiemployer defined benefit pension plan under the terms of a participation agreement that covers its non-collectively bargained employees. The Health Fund remits the contributions to this multiemployer defined benefit pension plan for the shared employees on behalf of the Connecticut Laborers' Health, Pension and Annuity Funds. The Pension and Annuity Funds reimburse the Health Fund for their share of the contributions based on a cost allocation study. The risks of participating in this multiemployer defined benefit pension plan are different from a single-employer plan in the following aspects:

**NOTE 7. MULTIEMPLOYER DEFINED BENEFIT PENSION PLAN (continued)**

- a. Assets contributed to the multiemployer defined benefit pension plan by one employer may be used to provide benefits to employees of other participating employers.
- b. If a participating employer stops contributing to the multiemployer defined benefit pension plan, the unfunded obligations of the multiemployer defined benefit pension plan may be borne by the remaining participating employers.
- c. If the employer chooses to stop participating in any of its multiemployer defined benefit pension plans, the employer may be required to pay those multiemployer defined benefit pension plans an amount based on the underfunded status of those multiemployer defined benefit pension plans, referred to as a withdrawal liability.

The Health Fund’s participation in the multiemployer defined benefit pension plan for the annual periods ended December 31, 2024 and 2023, are outlined in the table below. The zone status is based on information that the Plan received from the multiemployer defined benefit pension plan and is certified by the multiemployer defined benefit pension plan’s actuary. Among other factors, pension plans in the red zone are generally less than 65 percent funded, pension plans in the yellow zone are less than 80 percent funded, and pension plans in the green zone are at least 80 percent funded.

## NOTE 8. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

### Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value, as well, as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

*Short-term investments:* Short-term investments consist of cash and money market mutual funds held for investment that are not debt securities and are included in investments on the statements of net assets available for benefits valued at fair-value.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective Trusts:* The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the managers of the investments and are generally based on the fair market value of the underlying investments.

**NOTE 8. FAIR VALUE MEASUREMENTS (continued)**

*Limited Partnerships:* Valued based on net asset value (NAV) as calculated separately for each class and subclass of shares and for each series within a class of shares equal to the value of gross assets less gross liabilities at the date of determination divided by the total number of outstanding shares. Certain investments may not have readily available market values and may be subject to certain withdrawal restrictions. Liquidity can vary based on various factors and may include lock-up periods as well as redemption fees and/or restrictions. Audited financial statements were obtained as of December 31, 2024 and 2023, which reported unmodified opinions.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the tables below are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

**NOTE 9. RELATED PARTY TRANSACTIONS**

The fund office staff employed by the Connecticut Laborers' Health Fund performs administrative services for various other related funds. The most significant of these are the Connecticut Laborers' Pension Fund and the Connecticut Laborers' Annuity Fund. The cost of these services is charged to the related funds. The charge to the Pension Fund and Annuity Fund is shown as a reduction of the administrative expenses of the Health Fund. The charges to other related funds are classified as administrative income. The total charges for the years ended December 31, 2024 and 2023 were \$1,310,337 and \$1,356,243, respectively. Net amounts owed to (by) the Plan for unpaid administrative expenses by the Connecticut Laborers' Pension Fund and the Connecticut Laborers' Annuity Fund at December 31, 2024 and 2023 were (\$45,663) and \$83,757, respectively.

The cost of certain administrative functions is incurred by the Connecticut Laborers' Pension Fund on behalf of other funds. A share of these costs is allocated to the Health Fund. The following professional fees were allocated from the Pension Fund for the years ended December 31, 2024 and 2023:

The Plan rents office space from the Connecticut Laborers' Pension Fund under an operating type lease. The annual rental expense was \$44,544 for the years ended December 31, 2024 and 2023. The lease term is for a three-year period beginning August 1, 2022 and ending July 31, 2025; however, it may be terminated by either the landlord or the tenant upon 60 days' notice. Because the termination rights are symmetrical, the lease term is considered short-term and the Plan has elected not apply Accounting Standards Codification 842, Lease Accounting.

Contributing employers have the option of remitting their contributions to the Connecticut Laborers' Funds in one remittance to the Connecticut Laborers' Health Fund (the Health Fund). The Health Fund then periodically internally transfers the contributions to their intended fund. Contributions received by the Health Fund and due to the other Connecticut Laborers' Funds at December 31 were as follows:

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. The Plan paid fees during the year for legal, accounting, investment management and other services rendered by parties in interest. These transactions are considered exempt party-in-interest transactions under ERISA.

**NOTE 10. RISKS AND UNCERTAINTIES**

The Plan invests in various investments. Investments are exposed to various risks such as economic, interest rate, market and sector risks. Due to the level of risks associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of accumulated plan benefits is reported based on certain assumptions pertaining to investment returns and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.
