Opinion

We have audited the accompanying financial statements of The Broussard Group Employee Benefit Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

(1) DESCRIPTION OF PLAN

The following description of The Broussard Group Employee Benefit Plan & Trust provides health and prescription drug benefits covering qualifying employees of the corporation. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General

The Plan provides health benefits to eligible employees of an affiliated group of plan sponsors (permanent, full-time (32 hours/week) employees of the plan sponsors that choose to participate following the employee waiting period). The employee waiting period for all other employees is satisfied the first day following three months of full-time employment.

Benefits

The Plan provides medical and prescription drug benefits through a funding arrangement that includes a trust, which is funded by the plan sponsor and/or the participating employees. Under the Plan agreement, the corporation contributes in cash to the Plan in a manner and at such times determined by a committee, which is a Plan fiduciary. Employees may or may not be required to contribute to the plan in order to participate. The Plan also provides continuation coverage as required by the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) for qualified beneficiaries who would otherwise have lost coverage under the Plan. Retired owners may elect to continue coverage within certain guidelines established under the Plan. The Plan does not have any post-retirement obligations for benefits offered to retired employees or beneficiaries of retired employees.

Medical benefits are provided on a partially self-insured basis. The Plan has purchased insurance contracts to protect the Plan against excessive or unpredictable claims. The insurance contracts include specific loss provisions that cover claims in excess of \$100,000 for each individual covered under the medical plan. The insurance contracts also include aggregate loss provisions that cover the combined claims for all participants of the Plan when the qualified claims for the Plan year exceed a stated amount. The stated amount under the aggregate loss provisions was approximately \$3,393,205 and \$3,383,997 at December 31, 2024 and 2023, respectively.

Stop Loss Coverage

As mentioned above, the Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

(1) **DESCRIPTION OF PLAN (CONTINUED)**

Self-Insured Benefits

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the general assets of the company sponsors. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections.

(2) **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with the generally accepted accounting principles requires the Plan to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payment of Benefits

Premiums paid by the company sponsors are recorded as premium payments in the accompanying statement of changes in benefit obligations and net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of benefit obligations and net assets available for benefits. Short-term disability payments are processed through the company sponsor's payroll system and paid from the general assets of the company sponsor. These payments are recorded as claims paid in the accompanying statement of changes in benefit obligations and net assets available for benefits.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Stop Loss

Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in benefit obligations and net assets available for benefits. There were \$544,146 of stop loss refunds this year that have been netted with claims paid in the accompanying statement of changes in benefit obligations and net assets available for benefits.

Refunds

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$204,632 have been netted with claims paid in the accompanying statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024.

Date of Management's Review

Management has evaluated subsequent events through September 4, 2025, which is the date the financial statements were available to be issued.

(3) CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at December 31, 2024 for claims incurred but not reported are estimated by the Plan's management based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

(4) FAIR VALUE MEASUREMENTS

The Plan determined the fair value of its assets and liabilities through a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs to the valuation methodology are based on unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are based primarily on quoted prices for similar assets in active or inactive markets and/or based on inputs that are derived principally from or corroborated by observable market data. Level 3 inputs are unobservable and are based on assumptions that market participants would utilize in pricing the asset.

The fair value of financial instruments, including cash, approximates the carrying value, principally because of the short maturity of those items and are considered Level 1 or Level 2.

(5) ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators and the trustee. These expenses are reported on the statement of changes in benefit obligations and net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

(6) CASH

As of December 31, 2024, the Plan had \$258,194 on deposit with a financial institution of which \$8,194 was not insured by the Federal Deposit Insurance Corporation. At December 31, 2023, the Plan had \$25,415 on deposit with a financial institution of which all was insured by the Federal Deposit Insurance Corporation.

Claims and premiums that have been processed and approved for payment at year-end, but not paid and claims incurred but not reported are presented as benefit obligations and are not considered liabilities under GAAP and, therefore, are not presented as liabilities or claims and premiums paid in the accompanying financial statements but are recorded on the Form 5500 as a liability.

(8) RELATED PARTY TRANSACTIONS

The Plan paid IMA, its third-party administrator, administrative fees of \$135,430 and \$128,050 for the year ended December 31, 2024 and 2023, respectively. The Plan also receives certain administrative services and office usage at no charge from Broussard Group. These transactions qualify as party-in-interest transactions. However, these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(9) RISKS AND UNCERTAINTIES

The present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

(10) FIDELITY BOND

ERISA requires every fiduciary of an employee benefit plan and every person who handles funds of the Plan to maintain fidelity bond coverage equal to 10% of the amount of plan assets. The trustee (fiduciary) does not maintain such a bond.

(11) PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

(12) TAX STATUS

The Plan has not applied for tax exempt status. However, taxable income to the trust is defined in such a way that yields no tax liability for the current year. Accordingly, no tax liability or expense is reflected in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. There are three open years in regard to potential audits. The Plan files an annual return and records must be retained for at least six years to support the filing.
