### Scope and Nature of the ERISA 103(a)(3)(C) Audit

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of assets held at end of year is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE A - DESCRIPTION OF THE PLAN:**

The Plan was formed on July 1, 2019. The Winters Group, LLC (hereafter also referred to as “the Company”) sponsors the Crown Seasons Retirement Plan (hereafter referred to as “the Plan”) for the benefit of the employees of the related entities; Crown Hospice, Inc., Crown Hospice of Poplar Bluff, Crown Hospice Cape Girardeau, Crown Hospice St. Louis, Crown Hospice Victoria Texas, Crown Hospice, LLC, MedOk Specialty, LLC, Season’s Hospice, Inc. of Missouri, Season’s Hospice of Muskogee, Inc., Seasons Hospice of Springfield, and Season’s Hospice, Inc. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution, 401(k) plan, covering employees of the Company who are at least twenty-one (21) years of age and have completed at least two (2) months of service, as defined. Months of service need not be contiguous, but there can be no more than a one-year break in service. Plan entrance is available on a monthly basis. The Plan is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (“IRC”) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Trustees is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and for monitoring investment performance.

**Contributions**

Participants may contribute a percentage of compensation, up to the current pre-tax 401(k) contribution limits or after-tax Roth 401(k) contribution limits permissible under the IRC, as defined in the Plan agreement. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make “catch-up” contributions. Participants may also contribute amounts representing distributions or rollovers from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. All participant contributions are invested according to the allocations as determined by each individual Plan participant. Participants are allowed to stop their elective deferrals to the Plan and may change their elective deferral amounts on a monthly basis.

The Plan allows the Company to make matching contributions to the Plan.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, employer matching contributions and allocations of Plan earnings including gains and losses on investments with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

**Vesting**

Participants are immediately 100% vested in their contributions plus earnings or losses thereon. Participants are also immediately 100% vested in the employer matching.

**Notes Receivable from Participants**

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum of \$50,000, not to exceed 50% of their account balance. Participants may not have more than one (1) loan outstanding at any time. Notes receivable are secured by the balance in the participant’s account, evidenced by a promissory note. Notes receivable accrue interest at a reasonable rate that is based on the federal prime rate at the time the notes are issued. The interest rate for new notes receivable as of December 31, 2024, was set at 3.25%. Repayment terms for notes receivable are five years or less. Principal and interest are paid ratably through semi-monthly payroll deductions. Upon termination of employment, outstanding note balances are treated as distributions and are subject to applicable federal and state income taxes, and penalties, if applicable, if they are not paid in full by the end of the quarter following the quarter in which the participant terminated employment.

**NOTE A - DESCRIPTION OF THE PLAN – (Continued):**

Payment of Benefits

On termination of service due to death, disability, hardship or retirement, a participant may elect to receive a lump-sum distribution or periodic installments equal to the vested balance of his or her account, under the terms of the Plan. For termination of service due to other reasons, a participant may receive the value of their account balance as a lump-sum distribution. For participants who have reached age fifty-nine and one half (59 ½), in-service distributions are allowed and for participants who have reached age seventy-three (73), required minimum distribution amounts as required by the Internal Revenue Service must be met.

Forfeitures

For the Year ended December 31, 2024, the Plan had no forfeitures.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from the estimates that were used.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received in the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid. At December 31, 2024, there were no employees who had terminated employment with the Company who had requested distributions from the Plan that had not yet been received.

Hardship Withdrawals

The Plan does not allow hardship withdrawals.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements (See Note F). Fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participant's account and are included in administrative expenses. Administrative expenses for the year ended December 31, 2024, were \$12,031.

Date of Management's Review and Subsequent Events

Management of the Plan has evaluated subsequent events through October 10, 2025, the date that the financial statements were available for issuance, noting certain events that required recognition or disclosure in the accompanying financial statements and footnotes.

**NOTE C – CERTIFIED INVESTMENTS:**

At December 31, 2024, the Plan's investments were held by the trustee, Charles Schwab Trust Bank. The Plan investments that are included in the accompanying financial statements are based on information certified by the trustee as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

During the Year ended December 31, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$264,063, as follows:

**NOTE D – CERTIFIED INVESTMENTS, FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*All of the Plan's investments could be considered to be "Level 1" investments as of the reporting date of the accompanying "independent auditor's report".*

Level 2

Inputs to the valuation methodology include quoted market prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**Explanation of the Fair Value Hierarchy**

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

**Value of Plan’s Interest in Registered Investment Companies:**

Registered investment companies are valued at the net asset value (“NAV”) of units held by the Plan at year end. The NAV is determined by dividing the net assets at fair value of the fund by the number of units outstanding on the day of valuation, the value of the underlying investments held by the fund less its liabilities, and then divided by the number of shares outstanding. The NAV is quoted in an active market.

**NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:**

Plan investments are mutual funds of various registered investment companies which are held in custody and/or managed by Charles Schwab Bank. Charles Schwab Bank is the investment manager as defined by the Plan, therefore transactions involving investments managed by Charles Schwab Bank qualify as party-in-interest transactions. Fees paid by the Plan to Charles Schwab Bank for investment management and contract administration services amounted to \$12,031 for the year ended December 31, 2024.

**NOTE F - EMPLOYER ABSORBED COSTS:**

The Company pays for certain administrative expenses of the Plan, such as professional fees. During the year ended December 31, 2024, the Company paid administrative expenses of the Plan in the amount of \$14,500 for audit fees and \$8,965 for third-party administration fees.

**NOTE G - PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**NOTE H – INCOME TAX STATUS:**

The Plan was formed using a “Volume Submitter” plan document, which is a plan document that has been pre-approved for use by the IRS. The IRS has determined and informed the Company by an advisory letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan’s “Volume Submitter” plan document has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that “more likely than not” would not be sustained upon examination by the Internal Revenue Service. Management of the Plan does not believe they have any uncertain tax positions as of December 31, 2024.

**NOTE I - RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the accompanying “Statements of Net Assets Available for Benefits”.
