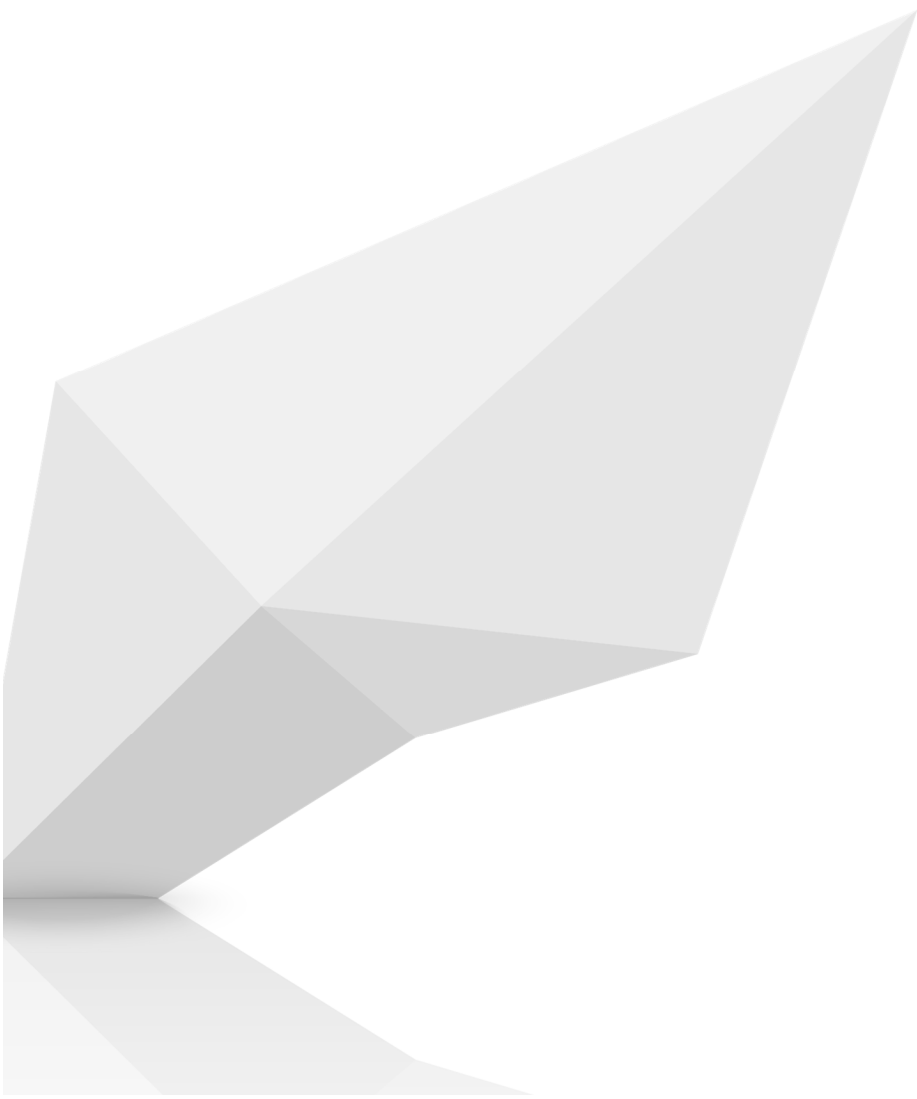

Opinion

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Infiniti of West Chester, Inc. Group Insurance Plan (the "Plan") provides only general information. Participants should refer to the Plan document and trust agreement for a more complete description of the Plan's provisions.

General

The Plan provides health and prescription benefits to employees of Infiniti of West Chester, Inc.; Exton Nissan; and Nissan 422, LLC (the "Company") who have completed 30 days of service and are scheduled to work over 30 hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Plan assets are held in a trust.

Benefits

The Plan provides medical and prescription drug benefits to the Plan's eligible participants and their eligible dependents, as defined by the Plan. The Plan also provides health benefits to individuals covered under the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

The Plan establishes monthly premium rates to be contributed to the Plan. The cost of the premiums is shared by the employees and the Company. The premiums paid by employees are dependent upon the Plan option elected by the employee each year. It is the employer's intent to fund any shortfall through additional contributions.

Insurance Premiums and Self-Insured Benefits

The Plan is "self-insured" for all medical and prescription drug benefits except for premiums paid by the Plan for stop loss, which are included in the accompanying statements of changes in benefit obligations and net assets available for benefits. The Plan has an annual minimum premium requirement. This minimum was met for 2024 and 2023.

Claims for self-insured benefits are processed by the Plan's third-party claims processor under administrative services only (ASO) arrangements. The claims processor pays claims directly to or on behalf of participants, and is then reimbursed by the Plan's 401(a) trust. Despite the Plan's utilization of the third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Estimates and assumptions that affect the assets, liabilities, reported amounts of benefit obligations, and changes therein, and disclosure of contingent assets and liabilities made by management include, but are not limited to, incurred but not reported claims (IBNR). Actual results may differ from these estimates.

Contributions

The Company contributions are recorded when paid as the Company has the obligation to fund all claims regardless of its actual contributions.

Payment of Claims

Claims are recorded when paid.

Incurred But Not Reported Claims (IBNR) and Claims Payable

Plan obligations at December 31 for claims incurred but not reported are estimated through the use of benefit payment history data. Based on this information, an estimate of claims incurred, but not reported is calculated. There is a reasonable possibility that a significant change in this estimate could occur in the near term.

Claims payable represent claims reported at year end to the Plan but are unpaid.

The Company is obligated to contribute amounts necessary to pay for the benefits of the Plan which may ultimately exceed the estimate.

Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The individual attachment point for claims is \$90,000 and \$85,000 for 2024 and 2023, respectively, and the aggregate attachment point is \$1,118,424 and \$958,697 for the twelve months ending December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023 there was \$87,162 and \$73,420, respectively, in claims reimbursement receivables under the arrangement.

Note 3: Cash and Cash Equivalents

Veris Benefits, Inc. maintains an interest-bearing checking account for several medical trusts for which Veris Benefits, Inc. provides services. Each trust held an individual account with a bank in the Plan's name as of December 31, 2024, and 2023.

Note 4: Concentration of Credit Risk

The Plan maintains a cash balance at a financial institution located in Pennsylvania. Accounts at the institutions are insured by the Federal Deposit Insurance Corporation (FDIC). The insured limits are subject to change. At times, the balance may be in excess of FDIC insurance limits.

Note 5: Administrative Expenses and Party-in-Interest Transactions

The Plan has arrangements with various service providers. These transactions are party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA. Insurance premium payments and administrative expenses were paid by the Company and subsequently reimbursed by the Plan. These administrative expenses totaled \$100,497 and \$127,401 for the years ended December 31, 2024 and 2023, respectively.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, payment of full contributions is due to the Plan through the date of termination. All contributions remaining in the Plan will be used to continue to pay claims by the terms of the Plan and will not revert to the employer.

Note 7: Tax Status

The Plan has not received a determination letter, therefore the trust established under the Plan is a taxable trust. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan sponsor believes that the trust does not currently have a tax liability, and that the trust continues to qualify and operate in compliance with applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.
