## Independent Auditors' Report

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of Egis BLN USA Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits - modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report:

**NOTE 1 - PLAN DESCRIPTION**

The following description of the Egis BLN USA Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the Plan administrator.

**General**

The Plan is a defined contribution plan sponsored by EGIS BLN USA Inc. (the “Company”) for the benefit of its full-time employees who have completed three months of service and are age 21 or older. Employees are eligible to enter the Plan on the first day of the month following satisfaction of the Plan’s eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Name Change**

Effective January 31, 2024, the Plan changed its name from “Beam, Longest & Neff, Inc. Profit Sharing Plan” to “Egis BLN USA Inc. Profit Sharing Plan”. This name change was approved in accordance with the Plan’s governing documents and does not affect the provisions, benefits, or operations of the Plan. All references to the Plan in these financial statements refer to the Plan under its new name.

**Contributions**

Each year, participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan has no auto-enrollment provision.

Company contributions consist of a required safe harbor matching contribution and a discretionary profit-sharing contribution. The safe harbor matching contributions are based upon a percentage of each participant’s salary deferral, as defined in the Plan. For the year ended December 31, 2024, the Company matched 100% of the first 4% of compensation contributed by each participant, and 25% of the next 2% of compensation contributed by each participant. During the year ended December 31, 2024, the Company made no discretionary profit-sharing contributions to the Plan. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

The Plan currently offers various pooled separate accounts, stable value, and similar funds as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and Company safe harbor contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**NOTE 1 - PLAN DESCRIPTION (CONTINUED)**

**Vesting**

Participants are immediately vested in their voluntary contributions and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's non-safe harbor matching and profit-sharing contributions plus actual earnings is based on years of service. A participant is 100% vested after five years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive value of the vested interest in his or her account as a lump sum distribution.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 for both years ended. These accounts (if any) will be used to first reduce Plan expenses and, if amounts remain, reduce future employer contributions. Also, for the year ended December 31, 2024, employer contributions were not reduced by any funds from forfeited nonvested accounts.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on a modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America ("GAAP"). Under the modified cash basis of accounting, transactions are recorded in the financial statements on the cash receipts and disbursement basis; however, investments are adjusted to fair value. Accordingly, these financial statements are not intended to present the Plan's financial position or changes in financial position in conformity with GAAP. The principal differences in the Plan's financial statements relate to investment income (loss) and contributions, which are not recorded until received.

**Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Those charged with governance determine the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the modified cash basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, American United Life Insurance Company ("AUL"), the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy Financial Accounting Standards Board ("FASB") Accounting Standards Codification (ASU) Topic are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in valuation methodologies at December 31, 2024 and 2023.

*Pooled separate accounts:* The value of the units in pooled separate accounts are based on quoted market prices of the underlying investments and are based on the net asset value (NAV) as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

*Common collective trusts:* The investments held in common/collective trusts are valued at the NAV per unit of the underlying funds. The NAV is used as the practical expedient to estimate fair value and therefore, investments recorded at NAV are not categorized in the fair value hierarchy. NAV of the collective trust is calculated daily. Participants' redemptions of the common/collective trusts are permitted daily with no other restrictions or notice periods and there are no unfunded commitments.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments include shares of pooled separate accounts and a stable value account managed by American United Life Insurance Company (AUL). AUL is the custodian; therefore, these transactions qualify as party-in-interest transactions.

AUL provides certain administrative services to the Plan pursuant to a Plan Services Agreement between the Company and AUL. AUL receives revenue from pooled separate account service providers for services AUL provides to the funds. This revenue is used to offset certain amounts owed to AUL for its administrative services to the Plan.

If the revenue received by AUL from such pooled separate account service providers exceeds the amount owed under the Service Agreement, AUL remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of participants. During 2024, there was no excess amount.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS (CONTINUED)**

Fees incurred by the Plan for investment management services are reflected in the net appreciation in fair value of the investments, as they are generally paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third-party administrator of \$1,120 for the year ended December 31, 2024. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 7 - TAX STATUS**

The Internal Revenue Service ("IRS") has determined and informed the Company by letter dated August 19, 2020, that the Plan and the related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS, UNCERTAINTIES, AND CONCENTRATIONS**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, approximately 15% of the Plan's investments were invested in the Fidelity 500 Index Fund.

**NOTE 9 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

Effective June 10, 2025, the Plan engaged Fidelity Management Trust Company as its Third-Party Administrator. The change is not expected to have an impact on any plan provisions.
