To the Plan Administrator, Participants and Beneficiaries of  
The Brownstein Group Profit Sharing 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements***

We have performed an audit of the financial statements of The Brownstein Group Profit Sharing 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

## Notes to Financial Statements December 31, 2024 (audited) and 2023 (compiled)

### NOTE A - DESCRIPTION OF THE PLAN

The following description of The Brownstein Group Profit Sharing 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### [1] General:

The Plan is a defined contribution plan covering all full-time employees of Brownstein Group, Inc., as well as all employees of the following affiliates, Nucleus Digital LLC, and Poster Child Social, LLC. Brownstein Group, Inc. and its affiliates are hereafter referred to as the “Company”. Employees are eligible to participate in the Plan upon attaining age 21 for pre-tax and after-tax deferrals and matching contributions, and after completing at least one year of service and attaining age 21 for profit-sharing contributions. An employee will become eligible to enter the Plan on the first day of January or July of the Plan year after the date the participant meets the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Empower Trust Company, LLC (“Empower Trust”) is the custodian of the Plan’s mutual fund investments, and the recordkeeper of the Plan is Empower Annuity Insurance Company of America (“Empower Annuity”). The custodian of the participant-directed brokerage accounts totaling \$4,380,268 and \$4,052,339 on the statements of net assets available for benefits as of December 31, 2024 and 2023, respectively, is Charles Schwab.

#### [2] Contributions:

Participants of the Plan can authorize a payroll deduction of up to 100% of wages for an elective contribution into the Plan; however, total deferrals in any taxable year may not exceed the maximum amount permissible under the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans.

The Company will make a non-elective safe harbor contribution equal to 3% of eligible participant compensation, as defined. Total non-elective safe harbor contributions were \$262,465 for the year ended December 31, 2024.

The Company may make a discretionary profit-sharing contribution for each eligible participant in an amount determined by the Company. Participants must be employed on the last day of the Plan year to be eligible for this contribution. There were no profit-sharing contributions for the year ended December 31, 2024. Participants direct the investment of participant and employer contributions into various investment options offered by the Plan.

#### [3] Participant accounts:

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions, and (b) Plan earnings (losses), and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

#### [4] Vesting:

Participants are vested immediately in their contributions, rollovers, and safe-harbor contributions plus earnings thereon. Participants are vested in the Company's profit-sharing contributions, plus earnings thereon, as follows:

#### [5] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balances, plus any accrued but unpaid interest. A participant may borrow from his or her fund account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. Each loan is secured by the balance in the participant's account and bears interest at a rate of prime plus 1%, as defined. The interest rates on outstanding loan balances range from 4.25% to 9.5% as of December 31, 2024 and 4.25% to 8.50% as of December 31, 2023. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as benefits paid to participants based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### [6] Payment of benefits:

Upon termination of service due to death, disability, retirement or other reasons, a participant or beneficiary may elect to receive his or her vested accrued benefits. If the vested account balance is \$5,000 or less, the participant will be paid in a lump-sum payment. If the vested account balance is greater than \$5,000, the participant may elect to receive his or her payment in a lump sum or if a benefit payment is a required minimum distribution, it may be distributed in installments.

Distribution of a terminated participant's vested account balance will occur as soon as administratively practicable after termination of employment.

#### [7] Forfeitures:

Forfeited nonvested accounts may be utilized to either pay administrative expenses or reduce future employer contributions to the Plan. During the Plan year ended December 31, 2024, forfeitures of \$21,156 were used to reduce employer match and employer profit-sharing contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts available were \$30,833 and \$18,409, respectively.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### [1] Basis of accounting:

The accompanying financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### [2] Use of estimates:

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements, and the changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### [3] Investment valuation and income recognition:

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized/unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### [4] Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

#### [5] Payment of benefits:

Benefits are recorded when paid.

#### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Empower Trust and Empower Annuity have certified to the completeness and accuracy of certain investments and related investment activity and notes receivable from participants, and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024. The certification excludes the participant-directed brokerage accounts and related activity on the statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024 (see Note A[1]). Non-Section 103(a)(3)(c) audit procedures have been performed on the participant-directed brokerage accounts.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; or (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used as of December 31, 2024 or 2023.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

*Participant-directed brokerage accounts* – Valued at the closing price reported on the active market on which the individual securities are traded. Accounts primarily consist of mutual funds, exchange-traded funds, and fixed income funds.

#### NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

#### NOTE E - GUARANTEED INTEREST ACCOUNT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a benefit-responsive guaranteed interest account contract with Empower Annuity. Empower Annuity maintains the contributions in a general account. The contract is reported at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

As described in Note B, because the guaranteed interest account contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account contract. Contract value, as reported to the Plan by Empower Annuity, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2024 and 2023, total contract value on the guaranteed interest account was \$208,072 and \$145,026, respectively.

#### **NOTE E - GUARANTEED INTEREST ACCOUNT CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

The traditional investment contract held by the Plan is a guaranteed interest account contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date unless 60 days' notice is given by either the Plan or Empower Annuity.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code ("IRC"), failure of the trust to be tax-exempt under Section 501(a) of the IRC, contract discontinuance or Plan termination. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

#### **NOTE F - TAX STATUS**

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with Cash or Deferred Arrangement ("CODA") sponsored by My Benefits LLC. On June 30, 2020, the Internal Revenue Service stated in an opinion letter that the Prototype Plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and, therefore, the related trust was exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **NOTE G - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain investments are managed by Empower Trust, Empower Annuity and Charles Schwab and transactions related to those investments qualify as party-in-interest transactions.

The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions are party-in-interest transactions. Fees paid by the Plan to these service providers were \$87,471 for the year ended December 31, 2024.

Empower Trust provides certain administrative services to the Plan and receives revenue from mutual fund providers for services the custodian provides to the funds. This revenue is used to offset certain amounts owed to the custodian for its administrative services to the Plan. If the revenue received by Empower Trust from such mutual fund service providers exceeds the amounts owed, Empower Trust remits the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants, depending on the Plan's provisions. During 2024, \$8,867 was received from Empower Trust and credited against Plan expenses and \$412 of earnings, which is reflected in net realized/unrealized appreciation in the statement of changes in net assets available for benefits. The account balance as of December 31, 2024 and 2023 was \$33,882 and \$24,604, respectively.

#### NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments as of December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### NOTE I - MUTUAL FUND FEES

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

#### NOTE J - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the sponsor shall make no further contributions to the Plan and participants would become 100% vested in their employer profit-sharing contributions.
