**NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

1. DESCRIPTION OF PLAN

The following description of the W.M. Schultz Construction, Inc. Profit Sharing 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of W.M. Schultz Construction, Inc. and its affiliate (Schultz Contracting, LLC) collectively referred to as "Company," who are not covered under a collective bargaining agreement and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions and Contributions Receivable

Contributions to the Plan may include profit sharing, employee 401(k) deferrals, Company matching, and wage rate contributions.

Eligible employees may contribute up to 100% of their pre-tax income (not exceeding dollar limitations set by law) into the Plan under 401(k) provisions. Participants are 100% vested in their 401(k) contributions. The Company makes a safe harbor matching contribution to the Plan on behalf of the participants as a percentage of the employee's contribution. The percentage applied to contributions is 100% match on the first 3% of the participants' eligible compensation and then a 50% match on the next 2% of the participants' eligible compensation.

The Company may make a profit sharing contribution for eligible employees. The amount of the profit sharing contribution, if any, is determined by the Board of Directors at its sole discretion each year.

Wage rate contributions are made for each eligible participant while working on prevailing wage contracts. Participants are 100% vested in their wage rate contributions.

Rollover contributions from other plans and certain IRAs are permitted.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with an allocation of (a) the employee's contributions (b) the Company's contributions, (c) Plan earnings (losses), and (d) charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Vesting in the Company's profit sharing contributions, plus earnings and losses thereon, is based on years of continuous service. A participant is 100 percent vested after six years of credited service. Participants are immediately vested in their voluntary contributions, wage rate contributions, and the Company's 401(k) match contributions, plus actual earnings and losses thereon.

Investment Options

The Plan entered into an agreement with Chemung Canal Trust Company (the custodian of the Plan) whereby the custodian directs new contributions, in accordance with the participant's election, into a choice of eighteen (18) mutual funds, one money market, and one common collective trust fund. Participants may change their investment options daily.

Payment of Benefits

On termination of service, a participant will receive an amount equal to the value of the participant's vested interest in his or her account in a qualified joint and survivor annuity, unless the participant elects to receive the amount in a lump sum, installment arrangement, or life annuity.

Administrative Expenses

Administrative expenses of the Plan (including third party administration and recordkeeping, and investment advisory fees) are generally allocated among the accounts of the plan participants. However, the Plan sponsor may, at its discretion, absorb certain administrative expenses of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Payment of Benefits

Benefits to terminated participants are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Forfeitures

Forfeitures are used to partially fund the employer matching contributions. As of December 31, 2024 and 2023, the balance of forfeited nonvested accounts available to be used to reduce future employer contributions was \$2,522 and \$0, respectively. Also, employer contributions were reduced by \$0 from forfeited nonvested accounts for each of the years ended December 31, 2024 and 2023.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Participants may borrow from their account up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of their account balance. Generally, loan terms range from 0-5 years. If the loan is used to purchase a primary residence, the loan may be repaid over a reasonable period of time that may be longer than 5 years. The loans are secured by the balance in the participant's account and bear interest at The Wall Street Journal's prime rate plus 2 percent determined at the time of the loan. Principal and interest is paid ratably through payroll deductions, which cannot be less frequently than quarterly. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Financial Instruments Measured at Fair Value

The Plan has financial instruments which are recorded at fair value in the accompanying statements of net assets available for benefits. The Plan makes estimates regarding the valuation of assets and liabilities measured at fair value in the financial statements. These assets and liabilities include the investments in mutual funds. The collective investment trust is measured using the net asset value (NAV) per share practical expedient as determined by the issuer based on current fair values of the underlying assets of the fund as of December 31, 2024 and 2023.

Fair Value Measurement - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value and classifies into a three level hierarchy based on the nature of the inputs. Level 1 valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Level 2 valuations are based on inputs, other than quoted prices included within Level 1 that are observable either directly or indirectly. Level 3 valuations are based on inputs that are unobservable and significant to the overall fair value measurement. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Financial Instruments Measured at Fair Value (Continued)

Fair Value Measurement - Definition and Hierarchy (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund and mutual funds: Valued at the net asset value of shares held at year end based on quoted market prices.

Collective investment trust: Valued based on the fair value using the NAV practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In addition, they include guaranteed insurance contracts which aim to provide price stability on a day-to-day basis.

4. PARTY-IN-INTEREST TRANSACTIONS

As of December 31, 2024 and 2023, all of the Plan's assets are held by Chemung Canal Trust Company, the Plan's custodian.

The Plan has allowed employees who are participants to receive loans under specific circumstances. As such, transactions between the notes receivables from participants and the Plan qualify as party-in-interest transactions as well.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN
