Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Argano, LLC 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of the Plan

General

The following description of Argano, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Argano, LLC (Company) for the benefit of its employees who are age 21 or older. Employees must complete one year of service to be eligible to receive employer matching and employer contributions or have at least 1,000 hours of service during a 12-month period. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). John Hancock Trust Company LLC (John Hancock) is the trustee of the Plan.

SES Group and Associates, LLC; Engineering & Software Consultants, Inc.; AGR, LLC; CSS International Inc.; NorthPoint Group, LLC; and ITK Solutions Group, LLC, subsidiaries of the plan sponsor, merged their existing plans into the Argano, LLC 401(k) Plan effective January 1, 2023. Big Compass, LLC and DataBrains, Inc., subsidiaries of the plan sponsor, merged their existing plans into Argano, LLC 401(k) Plan effective July 1, 2023. Intangent USA, Inc., a subsidiary of the plan sponsor, merged its existing plan into Argano, LLC 401(k) Plan effective September 1, 2023.

Contributions

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions of up to 100% of eligible compensation. Participants who had attained age 50 before end of plan year were eligible to make catch-up contributions. During the years ended December 31, 2024 and 2023, the Company made matching contributions of 33% of the employees' salary deferral amounts up to 3% of the employee's eligible compensation. The Company may also make profit-sharing contributions. Such contributions are made at the discretion of the Company's management. No profit-sharing contributions were made during the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and the Company's safe harbor matching contributions plus earnings thereon. Participants are fully vested in the Company's profit-sharing contributions after six years of continuous service. The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce Company contributions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$142,590 and \$68,541, respectively. Forfeitures may be used to reduce Company matching contributions or administrative fees. In 2024 and 2023, employer contributions were reduced by \$0 and \$33,742 from forfeited nonvested accounts, respectively.

Additionally, in 2024 and 2023, administrative fees were reduced by \$30,502 and \$120,976, respectively, from forfeited nonvested accounts.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of their account. If the account balance is less than \$1,000 at the time of termination, a single lump-sum payment, net of taxes, will be made. At December 31, 2024 and 2023, there were no plan assets allocated to accounts of terminated or retired participants who had elected to withdraw from the Plan but were not yet paid.

Note Receivable From Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan is \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and self-directed brokerage accounts are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interest in the collective trusts are valued based on information reported by the investment advisor using the audited financial statements of the collective trusts at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Revisions

Immaterial revisions have been made to the 2023 financial statements related to errors within the fair value hierarchy classifications. These revisions did not have an impact on the total net investments at fair value, or net assets available for benefit.

Note 3. Certification of Plan Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure. Accordingly, John Hancock, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party Transactions and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$175,415 and \$172,410 of record-keeping fees to John Hancock during the years ended December 31, 2024 and 2023, respectively. Individually nonmaterial expenses paid to parties in interest aggregated \$46,517 and \$146,634 during the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Certain plan investments are units of pooled separate accounts managed by John Hancock is the trustee as defined by the plan agreement. Therefore, these transactions qualify as party-in-interest transactions.

Note 5. Transfer of Plan Assets

During 2023, Argano, LLC acquired aMind Solutions, LLC; SCMO2, Inc.; Arbela Technologies Corp.; Echelon Solutions Group, LLC; SES Group and Associates, LLC; Engineering & Software Consultants, Inc.; AGR, LLC; CSS International, Inc.; NorthPoint Group, LLC; ITK Solutions Group, LLC; Big Compass, LLC; DataBrains, Inc.; and Intangent USA, Inc. and subsequently merged the related plans into Argano, LLC 401(k) Plan.

SES Group 401(k) Retirement Plan; Engineering & Software Consultants, Inc. 401(k) Profit Sharing Plan; AGR, LLC - 401(k) Plan; CSS LLC 401(k) Plan; NorthPoint Group LLC 401(k) Plan; and ITK Solutions Group, LLC 401(k) Profit Sharing Plan Trust merged into Argano 401(k) Plan effective January 1, 2023. Big Compass, LLC 401(k) Plan and DataBrains, Inc. 401(k) Profit Sharing Plan Trust merged into Argano 401(k) Plan effective July 1, 2023. Intangent USA, Inc. 401(k) Plan merged into Argano 401(k) Plan effective September 1, 2023.

An aggregate \$55,229,217 was transferred into the Plan during the year ended December 31, 2023 and is included as a transfer on the statements of changes in net assets available for benefits. No plan transfers occurred during the year ended December 31, 2024.

Note 6. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities

Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 8. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 9. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by Armanino, LLP. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$8,377 and \$31,724 were not remitted within the required time period for the years ended December 31, 2024 and 2023, respectively.

Note 11. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Note 12. Subsequent Events

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
