NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the 401(k) Profit Sharing Plan for Employees of P.E.A.C.E., Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of People's Equal Action and Community Effort, Inc. (the Organization) who meet certain eligibility requirements. The Plan is administered by the Organization. Mutual of America Life Insurance Company (Mutual of America) is the custodian of the Plan's assets. Mutual of America also serves as the record-keeper of the Plan information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to begin salary deferrals after the attainment of age 18. Employees are automatically enrolled in the Plan at 1% with a choice to opt out. Automatically enrolled employee's deferrals escalate 1% a year for a total of 3 years. Contributions may be made in the first pay period following the month employment began. Eligibility for the employer's match begins after one year of service, defined as 6 months of service. In addition to the above requirement, the discretionary feature of the Plan requires employees to be employed with the Organization as of the last day of the Plan year.

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Organization's Board of Directors establishes the matching contribution. The Organization matched each participant's elective deferrals by contributing 100% of the first 3% of compensation deferred in 2024 and 2023.

Discretionary contributions may be made at the option of the Organization's Board of Directors. These contributions are allocated based on each participant's compensation. Contributions are subject to certain limitations. There were no discretionary contributions in 2024 or 2023.

Other Receivables and Revenue

Other receivables and revenue consist of lost earnings owed to participants for errors identified by the Plan and corrected in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocation of the Organization's contributions and Plan earnings/losses and expenses. Allocations are based on participant earnings/losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings/losses thereon. Vesting in the Organization's matching and discretionary contribution portion of their accounts plus earnings thereon is based on years of continuous service. Participants are 20% vested in the Organization's contributions after completion of one year of service, then an additional 20% vested each subsequent year until fully vested after five years of credited service. The vesting requirements also include an early retirement age at which an active participant will become 100% vested in all contributions, plus actual earnings/losses thereon, upon attainment of 59 ½.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or in the form of an annuity.

Forfeited Accounts

Forfeitures of non-vested account balances will be used for either payment of Plan administrative expenses or as a reduction of employer matching contribution. The Plan had unused forfeitures of \$11,799 and \$44,240 during 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investments

Investments, except for fully benefit-responsive investment contracts, are reported at fair value. The Plan's investments in pooled separate accounts are valued at fair value using the net asset value (NAV) per share practical expedient based on the value of underlying investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

Fully Benefit-Responsive Fixed Annuity Contract

All amounts allocated to the Interest Accumulation Account become part of Mutual of America's general account. The amount in the Interest Accumulation Account at any time will be equal to the sum of all amounts that have been allocated to such account, including interest credited to the account, less the sum of all amounts that have been withdrawn from such account. Participants' principal and previously credited interest are guaranteed. Mutual of America assumes the investment risk of the underlying investments of the Interest Accumulation Account. This guarantee is subject to Mutual of America's financial strength and claims-paying ability. Mutual of America's general account investment strategy is to maintain high-quality assets with excellent liquidity, strong capital adequacy and a proper matching of assets and liabilities.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fully Benefit-Responsive Fixed Annuity Contract (Continued)

The general account is credited with interest at a rate determined by Mutual of America from time to time, and Mutual of America reserves the right to change the interest rates applicable to amounts held in this account at their discretion, but not below the minimum guaranteed interest rate (3.0% for 2024 and 2023).

The interest rate credited to amounts in the general account is a current rate and is not dependent upon the length of time the assets are invested with Mutual of America. Further, requests for withdrawal (subject to Plan provisions) can be made at any time and are processed on the day that they are received; they are not dependent on Mutual of America having to liquidate securities in order to generate a payment. The contract value is the redeemable value of the fund; there are no deferred sales charges, load assessments, interest rate adjustments, or surrender charges that would affect the value as a result of a withdrawal request. Therefore, the amounts held in the general account is considered fully benefit-responsive.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents, including complete or partial Plan termination or merger with another plan, or (2) bankruptcy of the Plan Sponsor. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Allowance for Credit Losses

The Plan records receivables for employee and employer contributions that are remitted to the Plan subsequent to the Plan's year end. The Plan recognizes an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. No significant deteriorations are expected in the future economic conditions; therefore management has determined that no allowance for credit losses is necessary for the year ended December 31, 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses incurred in connection with the purchase or sale of securities are charged against the investment funds whose assets are involved in such transactions. Certain administrative expenses of the Plan are paid by the Organization. All other expenses relating to participant transactions are deducted from those participant accounts as transactions occur.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, currency, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the accompanying financial statements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

3. INVESTMENTS

The Plan administrator has received a certification from Mutual of America Life Insurance Company, the custodian of the Plan, which states that the following information is complete and accurate as of and for the years ended December 31:

4. POOLED SEPARATE ACCOUNTS

The pooled separate accounts assets are invested in domestic stocks, international stocks, and fixed securities, such as asset or mortgage-backed securities and corporate bonds, and in mutual funds that hold such investments. The net asset value of the pooled separate accounts are not publicly quoted. The values of the underlying investments are used in determining the net asset value of the pooled separate accounts. Underlying equity securities have observable quoted pricing inputs. Underlying fixed securities have observable pricing inputs, including quoted prices for similar assets in the active or non-active markets. Underlying mutual funds are valued at publicly quoted pricing inputs.

There are no restrictions in connection with the transfer among or withdrawal from any of the investment alternatives in the pooled separate accounts, other than that excessively frequent transfers or redemptions might be rejected. Each underlying fund has reserved the right to reject any aggregate purchase of fund shares that it determines to be inconsistent with their fund's policies and procedures relating to market timing.

The pooled separate accounts invest in underlying funds, which have different investment objectives, investments policies, and risks. The investment strategies of these funds will vary based on the participant's chosen risk preferences. The pooled separate accounts do not have any unfunded commitments.

5. PARTY-IN-INTEREST TRANSACTIONS

Plan investments include pooled separate accounts managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the Plan's custodian and third-party administrator; therefore, these transactions qualify as party-in-interest transactions.

6. INCOME TAX STATUS

The Plan is operating under the Mutual of America Financial Group Defined Contribution Pre-Approved Plan. The pre-approved plan obtained its latest opinion letter on June 30, 2020, which the Internal Revenue Service stated that the pre-approved plan as then designated, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. RECONCILIATION TO FORM 5500

The classification of changes in net assets available for benefits for the periods ended December 31, 2024 and 2023 differs between these financial statements and Form 5500. However, the total change in net assets available for benefits for the periods then ended agrees between these financial statements and Form 5500.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 13, 2025, the date the financial statements were available to be issued.
