As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report, dated October 14, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

1. Description of the Plan

The following description of the Pritchett Trucking, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan maintained by Pritchett Trucking, Inc. (the Company or Employer) for the benefit of its eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was effective January 1, 2023, and restated December 28, 2023.

Eligibility

All employees, excluding those who are leased, temporary, or non-resident aliens, who complete 6 months of service are eligible to participate in the Plan as of the first day of the quarter coincident with or subsequent to the eligibility conditions being met.

Contributions

Participants may elect to make pre-tax contributions and/or after-tax (Roth) contributions up to the dollar limitation of the Internal Revenue Code (IRC). In addition, eligible Participants are permitted to make catch-up contributions. Participants may also contribute, on a pre-tax basis, amounts representing distributions from other qualified plans (rollovers). The Employer may make a discretionary matching contribution (Employer matching contribution) on a per pay period basis. The Company has elected to match 50% of the Participant's contribution to up to 4% of the Participant's compensation. Contributions are invested in various investment options at the direction of the Participants.

Participant Accounts

Each Participant's account is credited with the Participant's contributions, Employer matching contributions, and each Participant's share of the Plan's income (loss). The Plan's income (loss), with respect to each investment fund, is allocated based on the proportion that each Participant's account balance invested in such fund has to the total of all Participants' account balances invested in such fund.

Vesting

Participants are always 100% vested in their contributions and related earnings thereon. Employer matching contributions, and the related earnings thereon, are vested in accordance with the following schedule:

Forfeitures

The Plan allows forfeitures to be used to reduce Employer matching contributions, to reduce administrative expenses, or to be allocated to Participants. During the year ended December 31, 2024, the Company utilized forfeitures of \$202 to reduce administrative expenses. The unused forfeiture account balance was \$10,145 and \$6,485, at December 31, 2024 and 2023, respectively.

Participants' Notes Receivable

A Participant may borrow up to a maximum equal to the lesser of \$50,000 or 50% of the Participant's vested account balance. Notes are secured by the Participant's account balance and bear interest at a reasonable rate of interest as determined by the trustee based on prevailing interest rates charged for similar loans in the loan market. Notes are repaid through payroll deductions over a period not to exceed five years, with exceptions for the purchase of a primary residence.

Benefit Payments

Participant accounts may be withdrawn upon attaining age 59½, termination of employment, death, or disability. The Plan also allows for in-service withdrawals in the event of a financial hardship. Vested account balances at the time of termination that are \$5,000 or less, will also be distributed. A Participant may elect to receive the benefits in the form of cash or an in-kind distribution and as either a lump-sum distribution or installment payments over a specified period of time.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income (Loss) Recognition

The investments of the Plan are reported at fair value, except for the fully-benefit responsive investment contract, which is reported at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits because contract value is the amount Participants normally would receive if they initiated permitted transactions under the terms of the Plan.

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date (the exit price). See Note 4 for information on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies (cont.)

Contributions

Contributions from Plan Participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a Participant ceases to make loan repayments and the Plan administrator deems the Participant loan to be in default, the Participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments

Benefit payments to Participants are recorded upon distribution.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan agreement. Certain other administrative expenses of the Plan are paid by the Company at their discretion.

Expense Budget Account

The Plan holds an expense budget account. Income from the program can be used to pay Plan expenses or may be allocated to Participants. The expense budget account balance was \$27,894 and \$36,758 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, expense budget account funds of \$15,004 were used to pay Plan expenses.

3. Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, State Street Bank and Trust Company (State Street) and Transamerica Life Insurance Company (TLIC), the Custodians of the Plan, have certified to the completeness and accuracy of all investments and notes receivable from Participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from Participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

4. Fair Value Measurement

The Plan follows Accounting Standards Codification (ASC) topic 820, Fair Value Measurement, which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below.

4. Fair Value Measurement (cont.)

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds - Valued at the quoted market prices of shares held by the Plan at year-end. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value (NAV) as of December 31, 2024. It is not probable that the mutual funds will be sold at amounts that differ materially from the NAV of shares held.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation method is appropriate and consistent with other market Participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment in Insurance Contract

Transamerica Guaranteed Investment Option is a fully benefit-responsive guaranteed investment contract with TLIC. TLIC maintains the contributions in a general account. The account is credited with earnings (losses) on the underlying investments and charged for Participant withdrawals and administrative expenses. TLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. TLIC makes this guarantee, and although TLIC may credit a higher interest rate, the credited interest rate will not fall below the lifetime guaranteed minimum of 0.00%.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by TLIC, represents contributions made under the contract, plus credited interest, less Participant withdrawals and fees. Participants ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with TLIC. Such events include the following: (1) the Plan no longer meets applicable requirements of the Internal Revenue Code and/or ERISA, (2) deposits are not received by TLIC on a timely basis, (3) TLIC determines that it can no longer continue to provide benefits under this Contract because of a change in the Plan, (4) the Company files or has filed against it a petition for bankruptcy. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with Plan Participants, is probable.

6. Income Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan With CODA (Pre-Approved Plan) sponsored by Transamerica Retirement Solutions LLC (TRS). The Internal Revenue Service (IRS) has opined and informed TRS by a letter dated June 30, 2020, stating that the form of the Pre-Approved Plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the Pre-Approved Plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-In-Interest Transaction

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others. State Street and TLIC perform services, maintain certain investments of the Plan for which fees are charged to the Plan. Party-in-interest transactions also include notes receivable from Participants. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions.

8. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, Participants will become 100% vested in their accounts, and the Plan administrator will facilitate the distribution of account balances under the provision of the Plan and trust agreement until all assets have been distributed.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

At December 31, 2024 and 2023, approximately 46% and 56%, respectively, of the Plan's investments were invested in the JP Morgan US Equity R6 Fund.

10. SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

11. Delinquent Participant Contributions

During 2023, employee loan repayment withholdings of \$290 were not remitted within the appropriate time period by the Company. The Company remitted delinquent contributions of \$290 to the Plan during 2024 and will remit lost earnings to the Plan during 2025. These transactions constituted prohibited transactions as defined by ERISA.

12. Subsequent Events

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, October 10, 2025, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.
