As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section-

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Driscoll Children's Health Employer Matching and Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 9, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1 – SIGNIFICANT ACCOUNTING POLICIES

Driscoll Children's Hospital (Hospital) is the sponsor for the Plan and the Board of Trustees of the Hospital are responsible for all administrative duties of the Plan. The financial statements of the Driscoll Children's Health Employer Matching and Retirement Plan (the "Plan") have been prepared in conformity with accounting principles generally accepted in the United States of America as applied to employee retirement Plans and in accordance with the terms of the trust agreement. The Plan is designed to hold assets for retirement benefits of the Plan Participants.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. The accounting records of the Plan are maintained on the cash basis.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

The John Hancock Guaranteed Investment Account is fully-benefit responsive and participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. For this Guaranteed Investment Contract (GIC), contract value is the same as fair value. The Statement of Changes in Net Assets Available for Benefits is prepared on a fair value basis, which equals contract value.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investments advisors, custodians and insurance company.

Note 1 – SIGNIFICANT ACCOUNTING POLICIES – (Continuation)

Investments Valuation and Income Recognition – (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net Appreciation (Depreciation) in the Fair Value of investments includes realized gains or losses and unrealized appreciation or depreciation on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Date of Management’s Review

The Plan has evaluated subsequent events through the date of the independent auditor’s report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

Note 2 – DESCRIPTION OF PLAN

The following description of Driscoll Children’s Health Employer Matching and Retirement Plan (Plan) provides only general information. The Plan is the Employers’ matching contributions and additional discretionary employer contributions. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a non-contributory defined contribution plan, covering substantially all employees of Driscoll Children's Hospital and its subsidiaries (collectively, the Employers). Employees are eligible to enter the matching portion of the Plan on January 1 or July 1 after attaining eighteen years of age and completing 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Payment of Benefits

Benefits are distributed following retirement or other termination of employment, or by April of the year after the participant attain the age of 70½, if elected. Normal retirement age under the Plan is 65. Benefits are normally paid in a lump sum if your vested account balance does not exceed \$1,000. Vested account balances between \$1,000 and \$5,000 are automatically rolled over to the *John Hancock Transition* IRA unless the participant elects an alternative form of payment.

Note 2 – DESCRIPTION OF PLAN – (Continuation)

Contributions

Matching Contributions

The Employers have agreed to voluntarily contribute a specified matching percentage of employee contributions made to the Driscoll Children’s Health 403(b) Plan under salary modification agreements executed by participants. The Employers contribution is a percentage of the first 5% of compensation contributed to the 403(b) Plan as pre-tax and Roth (after-tax) by the participant. The matching percentage will be determined by "years of participation" as set forth in the following schedule.

Additional Employer Contributions

The employers can make an additional discretionary contribution to the Plan. To be eligible to participate in the additional contribution, participants must have completed 1,000 hours of service and be employed on the last day of the Plan year. This contribution is allocated to each participant’s account based on a ratio of the participant’s compensation to total compensation of all participants.

Administrative Costs

The Employers have voluntarily agreed to pay most of the administrative costs of the Plan.

Participant Accounts

Each participant's account is credited with an allocation of; (a) the employer contribution and (b) Plan earnings. Forfeitures of employer contributions and earnings may be used to reduce required employer contributions. Allocations of Plan earnings are based upon the ratio of each participant's account balance to Plan assets in each of the Plan's investment programs. A participant is entitled to the benefits that can be provided from his or her account.

Note 2 – DESCRIPTION OF PLAN – (Continuation)

Vesting

The employer's contributions will vest as follows:

Participants become 100% vested after five years of credit service of at least 1,000 hours per year or upon death or disability, or attainment of age 65.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,107,331 and \$54,858, respectively. These accounts will be used to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced from forfeited non-vested accounts by \$1,428,125 and \$271,292, respectively.

Note 3 – INFORMATION CERTIFIED BY TRUSTEE

All investment assets and money market funds of the Plan are held by John Hancock Trust Company. All assets and changes in net assets available for benefits included in these financial statements, except for receivables, have been certified by the insurance company as to their completeness and accuracy. Certain reclassifications and adjustments representing accruals for receivables have been made to the certified amounts to conform to accounting principles generally accepted in the United States of America.

Note 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology is unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from, or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are inputs that are unobservable and significant to the fair value measurement.

Valuation Methodology

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at the end of the year. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 4 – FAIR VALUE MEASUREMENTS – (Continuation)

The preceding valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has a fully benefit-responsive traditional group annuity investment contract with John Hancock Trust Company. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Note 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

As described in Note 1, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by John Hancock Trust Company, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. For example, distributions resulting from employer-initiated events such as Plan termination, merger, spin-off, lay-off and early retirement may be subject to a market value adjustment. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants is probable of occurring. The issuer may not terminate the contract at any amount less than contract value.

Note 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY – (Continuation)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the Guaranteed Investment Contract was equal to the contract value and amounted to \$22,444,561 and \$21,202,383 at December 31, 2024 and 2023, respectively. The crediting interest rate is based on an agreed-upon formula with the issuer, but it may not be less than zero percent. Such interest rate may be reset not more frequently than daily and not less frequently than quarterly.

Note 6 – INVESTMENT PROGRAMS

All investments of the Plan are participant-directed. The Plan sponsors approximately twenty-five investment options for participants. Participants are allowed to change their investment election at any time.

Note 7 – TRANSACTIONS WITH RELATED PARTIES AND PARTIES-IN-INTEREST

Certain Plan investments are insurance contracts managed by John Hancock Trust Company (JHA). JHA is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services for the years ended December 31, 2024 and 2023 amounted to \$10,295 and \$9,905, respectively and are included in Net Appreciation in Fair Value of Investments. JHA also serves as the third party administrator for the Plan. Fees paid by the Plan for the administration and management services for the years ended December 31, 2024 and 2023 amounted to \$11,743 and \$9,459, respectively and are included in administrative expenses on the statement of changes in net assets for benefits.

Note 8 – PLAN TERMINATION

Although they have not expressed any intent to do so, the Employers have the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination or complete discontinuance of contributions, participants will become 100% vested in their accounts.

Note 9 – TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service, and the Plan sponsor believes that the Plan continues to qualify and to operate as designated and, accordingly, the Plan's net investment income is exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's evaluation was performed for the tax periods ended December 31, 2022 through December 31, 2024, the tax years which principally remain subject to examination by major tax jurisdictions as of December 31, 2024.

Note 11 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

SUPPLEMENTAL SCHEDULES
