Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of JusticeWorks YouthCare, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN AND SIGNIFICANT ACCOUNTING POLICIES

The following description of JusticeWorks YouthCare, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan, established effective January 1, 2005 and restated effective January 1, 2021, is a defined contribution retirement plan covering substantially all employees who are 18 years of age or older and have completed at least one year of service, defined as 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA). Participation in the Plan is open to employees of JusticeWorks YouthCare, Inc.; JusticeWorks Behavioral Care, Inc.; JusticeWorks FL, LLC; JusticeWorks OH, LLC; JusticeWorks TX, LLC; JusticeWorks FL, Inc.; JusticeWorks CO, LLC; Alexander Morgan and Company, LLC; and Merlin Fiorano, LLC (the "Companies").

Basis of Accounting - The Plan's financial statements are prepared under the accrual basis of accounting in conformity with generally accepted accounting principles in the United States (U.S. GAAP).

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in assets and liabilities at the dates of the financial statements. Actual results could differ from these estimates.

Contributions - Eligible participants may contribute a portion of their pre-tax and/or after-tax compensation each year to the Plan, subject to annual limits prescribed by the Internal Revenue Code. Employee contributions are recorded in the period during which the Companies make payroll deductions from the Plan participants' earnings. Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions. Effective January 1, 2025, the Plan adopted a provision of the SECURE 2.0 Act which provides for an increase to the annual catch-up contributions limit established by the Internal Revenue Services (IRS) for participants who have attained ages 60 to 63 to the greater of \$10,000 or 50% more than the limit established by the IRS. The Plan has not been formally amended for the adoption of this provision; however, management expects that the Plan will be amended prior to the December 31, 2026 deadline.

The Plan was established as a safe harbor plan, providing for an employer funded safe harbor match, which is funded each pay period. The matching contribution is equal to 100% of the participant's contribution that is not in excess of 3% of the participant's eligible

compensation plus 50% of the contributions that exceed 3% of the participant's eligible compensation but do not exceed 5% of the participant's compensation.

The Plan also allows for discretionary non-elective employer contributions. There were no discretionary non-elective profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts - Participants direct the investment of their account balances and contributions. Each participant's account is credited with the participant's contribution, employer contributions and an allocation of the Plan's earnings on a daily basis. Allocations of Plan earnings are based on a participant's account balance as a percentage of the total account balances for the applicable investment option. The benefit to which a participant is entitled is the vested portion of the participant's account.

Vesting - Participants are immediately vested in their voluntary contributions and employer safe harbor matching contributions.

Vesting of employer discretionary non-elective contributions and earnings thereon is according to the following schedule:

Forfeitures - When a participant withdraws from the Plan prior to becoming fully vested, the nonvested portion of the participant's account is used to pay for Plan expenses. There were no forfeitures as of December 31, 2024 and 2023.

Notes Receivable from Participants - Participants may borrow a minimum of \$1,000 up to the lesser of 50% of their account balance or \$50,000 from their account. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Interest rates on outstanding loans at December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Repayment is required within five years unless the purpose of the loan is to purchase a principal residence.

Benefit Payments - Benefits are reflected when they have been approved for payment and are paid by the Plan. On termination of service or upon attainment of age 59½, and subject to certain restrictions, a participant may elect to receive an amount equal to, or less than, the value of the participant's vested interest in his or her account in the form of a lump-sum payment, subject to tax withholding requirements, or a qualified rollover. After termination, if a participant's vested balance is less than or equal to \$1,000 the vested account may be distributed to the participant in cash. If the terminated participant's vested balance is greater than

\$1,000, but does not exceed \$5,000 (or \$7,000, effectively January 1, 2024), the vested balance may be transferred to an individual retirement account established in the participant's name.

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Investment Valuation and Income Recognition - Investments are carried at their fair value based upon published quotations or, in the absence of readily ascertainable market values, at such values as the trustee determines. The unrealized appreciation (depreciation) of investments is determined by the change in current market value from the beginning of the year (if held for the entire year) to the end of the year, or from the date of purchase to the end of the year. The realized appreciation (depreciation) of investments is determined from the date of purchase to the date of sale. Gain and losses on securities sold or redeemed are determined on the basis of specific identification.

The guaranteed investment contract is reported at contract value, which is the relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 3).

U.S. GAAP establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs that may be used to measure fair value are determined as:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2 Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

This method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate

and consistent with other market participants, the use of certain financial instruments could result in a different fair value measurement at the reporting dates.

Administrative Expenses - Administrative expenses represent charges paid by participants related to distributions, notes receivable and other fees; other Plan expenses are paid by the plan sponsor.

Reclassification - Certain amounts in the December 31, 2023 financial statements have been reclassified to conform with the December 31, 2024 presentation.

Subsequent Events - Management has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.

2. INVESTMENTS

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies at December 31, 2024 and 2023.

Mutual Funds: Investments in mutual funds are valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded (Level 1 measurement).

Collective Investment Trusts (CITs): Each CIT invests in a variety of separate accounts and mutual funds. The fair values of the underlying investments are used to determine the net asset value (NAV) of each CIT. The NAV's are not publicly quoted but are available to current investors and are the basis for current transactions. Therefore, each CIT has a readily determinable fair value (Level 1 measurement).

Self-Directed Brokerage Account - Investments held by the self-directed brokerage account are valued at quoted prices in active markets (Level 1 measurement).

3. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive guaranteed investment contract with Lincoln National Life Insurance Company (LNLIC). LNLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by LNLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with LNLIC. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

4. CERTIFIED FINANCIAL INFORMATION

Lincoln Financial Group Trust Company, Inc., the trustee, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest on notes receivable from participants, as shown in the statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- The accompanying schedule of assets held for investment purposes as of December 31, 2024.

5. PARTIES-IN-INTEREST AND RELATED PARTIES

Lincoln Financial Group Trust Company, Inc. provides access to certain investments and, accordingly, is considered to be a party-in-interest.

None of the employers or their employees involved in the administration of the Plan receive compensation from the Plan.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants shall become 100% vested in their accounts.

7. INCOME TAX STATUS

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved profit sharing plan with a cash or deferred arrangement. The IRS has issued an opinion letter dated July 13, 2021 stating that the form of the pre-approved plan is acceptable for use by employers under Internal Revenue Code (IRC) Section 401. Although the Plan has been amended, the Plan sponsor believes that the Plan is currently being administered in compliance with the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is no longer subject to tax examinations for the years before December 31, 2021.
