NOTE 1 - DESCRIPTION OF PLAN

The following description of the HCAS LLC401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering certain employees of HCAS LLC and any of its sister companies (together from here on referred to as the "Company") who have completed three months of service and are age 21 or older. The Plan was established on January 1, 2020, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may contribute up to an annual limit as allowed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and a group annuity contract as investment options for participants. The Plan also has an after-tax Roth option.

The Company contributes, at its sole discretion, a matching and/or a profit-sharing matching contribution equal to a uniform percentage of participant contributions. Currently, the Company is electing Employee Safe Harbor, whereby they match 100% of contributions on the first 1% of pay and 50% of contributions on the next 5% of pay. Participants are fully vested in Employee Safe Harbor matches after 2 years.

Investment Options - Participants may change their investment options at any time and may direct contributions among various investment options.

Retirement, Death, and Disability Benefits - A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Participant Accounts - Each participant's account is credited with the participant's contribution and an allocation of a) the Company's contribution, b) Plan earnings(losses), and c) forfeitures, and d) charged with any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested balance in the participant's account.

Vesting - Participants are immediately vested in their voluntary contributions and rollover contributions, plus actual earnings thereon. Vesting in the matching contributions of their accounts is based on years of continuous service. Participants are fully vested in the Company's matching and profit-sharing contribution portions of their accounts after three and six years of credited service, respectively.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their vested balance, whichever is less. The loans covered by demand notes, are secured by the participant's account, are repaid through payroll deductions, and bear interest at prime, plus 1%.

Payment of Benefits - Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the vested value of his or her account directly or roll over to another qualified plan. Partial withdrawals or installments can be elected over a period not more than the assumed life expectancy. Active participants may also take distributions from the Plan upon attainment of age 59½.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,428 and \$26,652, respectively. These amounts are used to reduce future employer contributions and/or payment of administrative expenses of the Plan.

Administrative and Investment Management Expenses - The Plan's recordkeeping and contract administrator fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in investment income reported by the Plan. All other expenses of the Plan are paid by the Company and are excluded from these financial statements.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are reported at their unpaid principal balance, plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Risks and Uncertainties - The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Payment of benefits - Benefits are recorded when paid.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's governance determines the Plan's valuation policies utilizing information provided by investment advisers, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The excess contributions for the year ended December 31, 2024 and 2023 were \$0 and \$60,613, respectively.

NOTE 3 - CERTIFIED INVESTMENTS

Substantially all information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian, Voya Retirement Insurance and Annuity Company (Voya). NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies and assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

NOTE 4 - FAIR VALUE MEASUREMENTS (CONTINUED)

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2 - Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 - Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair value of investments.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts is based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and had redemption prices that are determined by the fund’s net asset value per unit.

NOTE 5 - INVESTMENTS AT CONTRACT VALUE

In 2020, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Voya, which totaled \$4,364 and \$3,394 at December 31, 2024 and 2023, respectively. Voya maintains the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than the contract's stated minimum guarantee. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger (with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity, wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA and (5) premature termination of the contract. Plan management believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - TAX STATUS

The Plan is an adoption of a CCH Incorporated non-standardized prototype plan. The Internal Revenue Service (IRS) has issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. There were no uncertain tax positions as of December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in progress for any tax periods.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Voya Retirement Insurance and Annuity Company, which is the custodian and recordkeeper for the Plan. The Aimpoint Group, LLC is the third-party administrator ("TPA") for the Plan. Accordingly, these transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, the custodian paid to third-parties commissions of approximately \$3,823. This amount is included in administrative expenses in the statement of changes in net assets available for benefits.

NOTE 8 - FIDELITY BONDING

The Company maintains a fidelity bond of \$70,000 for Plan fiduciaries and individuals who handle the funds of the Plan, pursuant to the requirements of ERISA.

NOTE 9 - SUBSEQUENT EVENTS

The Plan evaluated subsequent events through October 10, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
