### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Toast, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## Notes to Financial Statements

December 31, 2024

### 1. Description of Plan

The following description of the Toast, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description and the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan, established January 1, 2015, and most recently amended and restated effective April 18, 2022, is a defined contribution plan covering all eligible employees of Toast, Inc. (the Company), except part time/temporary or seasonal employees whose scheduled service is less than 1,000 hours in the eligibility period and other excluded groups as defined in the Plan. However, if these excluded employees complete a year of service, then such employees will no longer be part of this excluded group.

All employees are eligible to participate in the Plan on the date of hire.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions and Funding

Each year, participants may contribute from 1% to 90% of their respective pretax annual compensation, subject to limitations established by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Each year, participants may contribute from 1% to 90% of their respective pretax annual compensation, subject to limitations established by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan permits Roth elective deferrals. Roth elective deferrals are treated in the same manner as participant elective deferrals, except that Roth elective deferrals are not "pre-tax" deferrals as defined in the Internal Revenue Code (Code).

## Toast, Inc. 401(k) Plan

### Notes to Financial Statements (continued)

#### **1. Description of Plan (continued)**

##### **Contributions and Funding (continued)**

The Company may also make a discretionary matching contribution. The matching contribution for the years ended December 31, 2024 and 2023 was 50% of 6% of eligible compensation.

The Plan includes an automatic enrollment feature. Individuals hired by the Company who do not affirmatively elect not to participate are automatically enrolled in the Plan and will have their compensation reduced by 3% and invested in the Qualified Default Investment Alternative fund. In addition, employees who enter the Plan via automatic enrollment will have their deferrals increased by 1% per year, not to exceed 10% of their compensation, unless the employee affirmatively elects not to increase their contributions.

The Company may also make a non-elective contribution each year. The non-elective contribution is made to those participants who complete 1,000 hours of service during the plan year and are employed as of the last day of the plan year. The Company non-elective contribution for the years ended December 31, 2024 and 2023 was \$-0- and \$-0-, respectively.

##### **Participants Accounts**

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, if any, plan earnings (losses), and charged with applicable loan and/or withdrawal charges. Allocations are based on participant salary deferrals or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. The vesting schedule is 50% after one year of service and 100% after two years of service, as defined.

### Notes to Financial Statements (continued)

#### 1. Description of Plan (continued)

##### Forfeitures

Forfeited balances of terminated participants' non-vested accounts can be used to reduce future employer contributions and/or pay plan expenses. The forfeiture balance was \$630,581 and \$202,855 at December 31, 2024 and 2023, respectively.

Forfeitures used to reduce Company contributions amounted to \$-0- and \$167,071 during the years ended December 31, 2024 and 2023, respectively. Forfeitures used to pay plan expenses amounted to \$337,150 and \$216,438 during the years ended December 31, 2024 and 2023, respectively.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms must not exceed five years unless for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the Prime rate plus 1%. Participants are allowed one loan outstanding at any time. Principal and interest is paid ratably through payroll deductions.

##### Payment of Benefits

Upon separation of employment due to termination, death, disability or retirement, a participant may receive the value of the vested interest in his or her account as a lump-sum amount. Prior to termination of employment, a participant can withdraw their deferred compensation balance in the event of certain hardship circumstances or upon reaching 59 1/2 years of age.

##### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

## Toast, Inc. 401(k) Plan

### Notes to Financial Statements (continued)

#### **2. Summary of Accounting Policies**

##### **Basis of Accounting**

The financial statements have been prepared on the accrual basis of accounting.

##### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for the management of investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, certain management fees and operating expenses are reflected as a reduction of investment return for such investments.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

##### **Administrative Expenses/Revenue Credit**

The Plan entered into administrative pricing with Fidelity Workplace Services, LLC. The fees related to recordkeeping services were fixed at 17 basis points effective November 1, 2023 and effective May 1, 2024, the recordkeeping fee will be \$12.50 per participant per quarter for participant accounts, as described, with balances more than \$5,000. The Company continued to pay the administrative fee per quarter until February 1, 2025, at which time the amount will be allocated to participant accounts. Any revenue generated from the various mutual fund investments above this amount is transferred to an ERISA Budget Account. These amounts are not available to reduce Company contributions.

#### **2. Summary of Accounting Policies (continued)**

##### **Administrative Expenses/Revenue Credit (continued)**

The amounts available in the ERISA Budget account at December 31, 2024 and 2023 was \$-0- and \$-0-, respectively. During the years ended December 31, 2024 and 2023, \$-0- and \$-0-, respectively, was used from the ERISA Budget account to offset plan expenses. Net fees of \$17,222 and \$11,963 were charged against the net investment return for the years ended December 31, 2024 and 2023, respectively.

The Plan received a revenue credit of \$-0- and \$-0- for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor may direct the recordkeeper to reimburse the Plan Sponsor for fees and expenses associated with services provided to the Plan and/or the amount may be allocated to participant accounts. During the years ended December 31, 2024 and 2023, the revenue credit amount allocated to plan participant accounts was \$-0- and \$-0-, respectively.

Certain other expenses such as participant loan processing fees, distribution processing fee and other miscellaneous expenses are deducted directly from participant accounts. The amounts deducted from participant accounts amounted to \$29,753 and \$24,473 for the years ended December 31, 2024 and 2023, respectively.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

### Notes to Financial Statements (continued)

#### 4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

## Toast, Inc. 401(k) Plan

### Notes to Financial Statements (continued)

#### 4. Fair Value Measurements (continued)

The following is a description of the valuation methodologies used by the Plan. There have been no changes in the valuation methodologies at December 31, 2024 and 2023.

*Mutual funds* are valued daily at the closing price per share, as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The *common collective trust* (Putnam Stable Value Fund) is based on the redemption value of the fund on the last business day of the plan year. The net asset value is quoted on a private market that is not active; however, the unit price is based on underlying investments which are traded on an active market. Redemptions are processed daily. There are no unfunded commitments.

The average yield based on actual earnings of the underlying investments in the Putnam Stable Value Fund was 3.77% and 3.31% for the years ended December 31, 2024 and 2023, respectively.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **6. Income Tax Status**

The Plan has adopted the non-standardized pre-approved profit sharing plan of Fidelity Management & Research LLC. The non-standardized pre-approved profit sharing plan sponsor received an advisory letter from the IRS dated June 30, 2020 in which the Internal Revenue Service stated that the form of the non-standardized pre-approved profit sharing plan was in compliance with the applicable requirements of the Internal Revenue Code (Code). Although the Plan has been amended since receiving the advisory letter, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting standards require recording uncertain income tax positions that exist in the Plan's financial statements. Plan management has determined there are no uncertain tax positions and believes there is no adjustment or disclosure required in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Parties-In-Interest**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and the management of investments held by the trustee are considered party-in-interest transactions.

Certain plan investments are shares of mutual funds managed by an affiliate of Fidelity Management Trust Company, the plan trustee. In addition, Fidelity Workplace Services, LLC is the plan recordkeeper. These investments and transactions are considered to be party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.
