Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Hayner Hoyt Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTE A--DESCRIPTION OF THE PLAN

The following description of The Hayner Hoyt Corporation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering substantially all employees of The Hayner Hoyt Corporation, Doyner, Inc. and LeMoyne Interiors, Inc. (collectively referred to hereinafter as “the Company” or “the Companies”) who have completed thirty days of service. Any part time, temporary or seasonal employees of the Company must complete 1,000 hours of service to become eligible to participate in the Plan. An employee is eligible to participate in the salary reduction feature and the employer matching portion of the Plan on the first day of the month following the date the eligibility requirements are met. For purposes of wage rate contributions (see description below), an employee is eligible for these contributions on commencement of employment. In addition, employees who meet the Plan’s eligibility requirements and are employed on the last day of the Plan year, are eligible to share in the allocation of discretionary employer contributions. The Plan is subject to the provisions of ERISA. The Board of Directors is responsible for the oversight of the Plan, for determining the appropriateness of the Plan’s investment offerings and for monitoring investment performance.

Contributions: Each year, participants may contribute the lesser of 100% of pretax annual compensation (“elective deferral contributions”), or \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 for the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation and their contributions invested in a designated balanced fund, which is based on the participant’s expected retirement date, until changed by the participant.

NOTE A--DESCRIPTION OF THE PLAN--Continued

Contributions--Continued: The Companies may contribute to the Plan a discretionary matching contribution for all eligible participants. The discretionary matching contributions equaled 25% of employee pre-tax contributions (including catch-up contributions) up to 12% of eligible compensation that a participant contributed to the Plan for 2024 and 2023 and totaled \$235,002 and \$221,573, respectively. The Companies also make contributions (“wage rate contributions”) for participants working on projects covered by prevailing wage rate schedules of the U.S. Department of Labor, New York State Department of Labor and/or any other state department of labor. The wage rate contribution is equal to the fringe benefit pension rate determined for the participant multiplied by the number of hours worked. Wage rate contributions for 2024 and 2023 totaled \$1,624 and \$6,791, respectively. Additional discretionary amounts may be contributed at the option of the Companies’ Boards of Directors. No additional discretionary amounts were contributed in 2024 and 2023. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, the Companies’ discretionary matching and wage rate contributions and allocations of (a) the Companies’ discretionary contributions and (b) Plan earnings and losses. Allocation of discretionary contributions is based on participants’ compensation. However, discretionary contributions allocated to a participant are reduced by the amount of wage rate contributions made for such participant during the Plan year. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of administrative expenses are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants have full and immediate vesting in all of their account balances.

Receivables--Notes From Participants: Participants are permitted to borrow from their accounts. Loans are subject to a minimum of \$1,000 and to a maximum equal to the lesser of \$50,000 or 50 percent of the participant’s account balance. Terms of the loans require repayment over a period not extending beyond five years from the date of the loan. Loans are secured by the balance in the participant’s account and bear reasonable rates of interest as determined by the Plan Administrator. Interest rates are currently 8 percent. Principal and interest are paid ratably through weekly payroll deductions.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's account, one of several forms of annuity options, or a series of installments chosen by the participant. For termination of service for other reasons, a participant may receive the value of his or her account as a lump-sum distribution. If a participant's vested account balance is between \$1,000 and \$5,000, and they fail to make a distribution election, a lump-sum amount will be rolled over to an individual retirement account without their consent. If a participant's vested account balance is \$1,000 or less, and they fail to make a distribution election, a lump-sum amount will be paid to the participant without their consent.

Forfeited Accounts: There are no forfeited accounts in the Plan as all participant account balances are fully vested and nonforfeitable.

NOTE B--SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments in pooled separate accounts and the collective trust are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Directors determines the Plan's valuation policies utilizing information provided by the custodian. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Receivables--Notes From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses to maintain the Plan are paid directly by the Company and are excluded from these financial statements. Fees relating to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Events Occurring After Reporting Date: The Plan's management has evaluated events and transactions that occurred between December 31, 2024 and October 8, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements. There were no such events or transactions identified by Plan management.

NOTE C--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, "Fair Value Measurements and Disclosures", are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) of the pooled separate accounts. Pooled separate accounts invest primarily in domestic and international long-term bonds, domestic and international stocks, or single mutual funds. The NAV is used as a practical expedient to determine the fair value for these accounts.

Collective trust: Valued at the NAV of units of the collective trust. The NAV, as provided by Principal Life Insurance Company ("Principal"), the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the custodian reserves the right to temporarily withdraw from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table summarizes the investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

NOTE E--RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan issues loans to participants, which are secured by the balances in the participants’ accounts. Therefore, related transactions qualify as party in interest transactions. Principal is the Plan service provider and custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions and are exempt from the prohibited transaction rules. Fees paid by the Plan for the investment management and contract administrative services amounted to \$8,443 and \$4,376 for the years ended December 31, 2024 and 2023, respectively, and are included in administrative expenses on the statements of changes in net assets for the years ended December 31, 2024 and 2023, respectively. Administrative expenses for auditing services is provided by a party in interest and is paid directly by the Company.

Principal provides certain administrative services to the Plan pursuant to a Service and Expense Agreement between the Company and Principal. Principal receives revenue from the pooled separate accounts and collective trust service providers for services Principal provides to these funds. This revenue is used to offset certain amounts owed to Principal for its administrative services to the Plan.

The Plan Administrator believes all party in interest transactions qualify for either statutory or administrative exemption from the prohibited transaction rules under ERISA.

NOTE F--PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies' have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants maintain their 100% nonforfeitable interest in their account balances.

NOTE G--TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by Principal. The IRS has determined and informed the prototype plan sponsor by a letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE H--RISKS AND UNCERTAINTIES

The Plan invests in pooled separate accounts and a collective trust. The investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
