

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator, Trustee and Management of  
Traylor Porter Health Care Management, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## **Traylor Porter Health Care Management, Inc. 401(k) Plan Notes to Financial Statements**

### **Note 1: DESCRIPTION OF THE PLAN**

The following description of the Traylor Porter Health Care Management, Inc. 401(k) Plan (the "Plan") provides only general information. Refer to Plan documents for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan that covers substantially all hourly and salaried employees of Traylor Porter Health Care Management, Inc., (the "Company", "Sponsor", "Employer", or "Plan Administrator") and its affiliates (the Plan employers). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan's trustee and management determines the appropriateness of the Plan's investment offerings and monitors investment performance. Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

The Plan assets are held and managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC ("Empower"), the custodians and the qualified institutions for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the participants. Azalea Administrator, LLC acts as the third-party administrator, which performs certain plan Administrator and annual ERISA compliance testing.

#### ***Eligibility***

The Plan covers substantially all full-time employees of the Plan Sponsor and the related control group excluding union employees, lease employees, and non-resident aliens. The employees must also meet other requirements such as reaching twenty-one years of age and completing three months of eligibility service. An eligible employee may enter the Plan on the first day of the first month and the seventh month of the Plan year.

#### ***Contributions***

Each year, participants may contribute up to 100 percent (%) of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows elective deferral contributions to be made as Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. In addition, for each participant who made contributions during the plan year, the employer made a discretionary matching contribution with the current year discretionary match to be 75% of employee deferrals, up to 6% of compensation that a participant contributes to the Plan. Additional non-elective contribution amounts may be contribution at the option of the Trustee and management, none of which were made during the ended December 31, 2024.

## Traylor Porter Health Care Management, Inc. 401(k) Plan Notes to Financial Statements

### **Note 1: DESCRIPTION OF THE PLAN (Continued)**

#### ***Contributions (continued)***

During the year ended December 31, 2024, the Company contributed \$190,360 in accrual based employer matching contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer's discretionary matching and non-elective contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. In order to obtain a year of vesting service, a participant is required to work at least 1,000 hours. A participant is 100% vested after three years of credited service. A participant's account becomes fully vested upon the participant's death, total disability, or attaining normal retirement age.

#### ***Benefit Payments***

On termination of service due to death, distribution of the participant's account must be completed by December 31 of the calendar year containing the fifth anniversary of death or the beneficiary will be entitled to a distribution in any form that was available prior to death. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or as permitted to satisfy required minimum distribution rules.

#### ***Forfeitures***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,426 and \$52, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses. In 2024, administrative expenses were reduced by \$1,476 from forfeited nonvested accounts.

### **Note 1: DESCRIPTION OF THE PLAN (Continued)**

#### ***Hardship Withdrawals***

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

### **Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### ***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments generally are reported at fair value, but may also be reported at net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and NAV. The Plan's trustee and management determines the Plan's valuation policies utilizing information provided by the third-party administrator and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Payments of Benefits***

Distributions to participants are recorded when paid.

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

#### ***Risk and Uncertainties***

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

#### ***Subsequent Events***

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 13, 2025, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Fixed annuity:* The reported values for the fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider. The contract is not considered to be fully benefit responsive. The inputs of the fixed annuity are generally considered obtainable/observable through the review of existing contracts and readily available financial information through the issuing financial institutions.

*Common collective trusts ("CCTs"):* The Plan's CCTs are valued based on NAV per share or unit as a practical expedient as reported by the fund manager, multiplied by the number of shares or units held as of the measurement date. Accordingly, these NAV based investments have been excluded from the fair value hierarchy leveling.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

### Note 5: TAX STATUS

On June 30, 2020, the IRS stated in an opinion letter that the preapproved profit-sharing plan adopted by the Plan, as then designed, qualifies under IRC Section 401. The preapproved profit-sharing plan has been amended since receiving the opinion letter and the Plan has not received a determination letter specific to the Plan itself. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC ("Empower"), as the custodians of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

The Plan paid certain expenses related to plan operations and investment activity to various service providers, as described in Note 1 and 2. These transactions qualify as party in interest transactions under ERISA.

### Note 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

### NOTE 9: NON-EXEMPT TRANSACTION

In eight instances during 2024, the Company experienced unintentional delays in the remittance of withheld participant contributions to the Plan which was not considered timely in accordance with the plan asset provisions of the Department of Labor (DOL) Regulation 2510.3-102, resulting in a prohibited (or a non-exempt) transaction. The aggregate amount of participant contributions in the late remittances was \$16,764. The accompanying Schedule of Delinquent Participant Contributions discloses this non-exempt transaction in accordance with DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Company is evaluating this non-exempt transaction during the year ending December 31, 2025, with consideration being given to the DOL's Voluntary Fiduciary Correction Program and funding the impacted Plan participants' accounts for earnings that would have been credited to the participants' accounts if the late remittance had been made on a timely basis.
