**NOTE 1 – DESCRIPTION OF PLAN**

CIMA 401(k) Plan (the Plan) is a qualified retirement plan covering employees of CIMA Services Management, Inc. (the Company or Sponsor), and Peak Industrial Construction Management, Inc. (Participating Employer) to provide them with the opportunity to save for retirement on a tax-advantaged basis. The Plan was originally effective on January 1, 2015, and most recently amended and restated on January 1, 2022, to conform to tax laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The summary of significant provisions of the Plan presented below provides general information. Participants should refer to the terms of the plan document for a more complete description of the Plan's provisions.

Eligibility: Employees (except for union employees and certain nonresident aliens) who have attained the age of 18 and completed 60 days of service are eligible to participate in the Plan. The entry date is the first day of the month coinciding with or next following the date eligibility requirements are satisfied.

Contributions: Participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as a salary deferral. There are two types of salary deferrals: pre-tax 401(k) deferrals, and Roth 401(k) deferrals. Total deferrals in any taxable year may not exceed the dollar limit which is set by law. Participants who are at least 50 or will attain age 50 before the end of a calendar year may defer additional amounts as catch-up contributions. Participants may modify or revoke their salary deferrals at any time.

The Company may make a discretionary matching contribution equal to a uniform percentage of participants' salary deferrals. During 2024, the Company made a matching contribution equal to 50% of a participant's deferral contribution up to 6% of a participant's compensation.

Participants are also permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs as rollover contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions, Plan earnings and losses, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Investment Options: Participants direct the investment of their entire interest in the Plan into various investments offered by the Plan. The Plan currently offers pooled separate accounts and an investment contract as investment options for its participants.

Notes Receivable from Participants: A participant may borrow from their retirement account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account. The loan is charged a reasonable rate of. Principal and interest is paid ratably through payroll deduction.

Payment of Benefits: Participants may receive a distribution of the vested portion of some or all of their accounts in the Plan upon termination of employment, normal retirement, disability, or death. If the vested account does not exceed \$7,000, then the vested account balance is distributed to the participant in a single lump-sum payment. If the vested account balance exceeds \$7,000, the participant must consent to any distribution before it is made and elect to receive the distribution in a single lump-sum payment or partial withdrawals.

Participants may also receive a distribution from the Plan from certain accounts prior to termination of employment provided they have attained age 59½. A hardship distribution may also be made to satisfy certain immediate and heavy financial needs that a participant has.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants will become 100% vested. The Company will direct the distributions of participants' accounts in a manner permitted by the Plan as soon as practicable.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Vesting: Participants are immediately vested in their contributions, rollovers, and actual investment earnings thereon. Vesting in the employer discretionary matching contribution portion of their accounts plus actual investment earnings thereon is based on vesting years of service. Participants vest as follows:

Forfeited Accounts: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. The Company may use forfeitures to pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$59,660 and \$53,241, respectively. During 2024, forfeitures of \$7,970 were used to pay Plan expenses.

Subsequent Events: The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts and disclosures, and actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments other than the fully benefit-responsive investment contract are reported at fair value as further described in Notes 3 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Notes receivable from participants have maturity dates ranging from 2024 to 2029. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and global event risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- *Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- *Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of relevant unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: The fair values of participation units held in pooled separate account subaccount are based on net asset values reported by the fund managers as of the financial statement date and recent transaction prices. Each of the pooled separate accounts held by the Plan is a passively managed fund that invests in a single, open-ended mutual fund. The underlying investment composition of the pooled separate accounts as of December 31, 2024 and 2023, was approximately 95% and 96% equity security funds and 5% and 4% fixed income security funds, respectively. Each pooled separate account sub-account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

\*Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the financial statements of net assets available for benefits.

**NOTE 4 – CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements, ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (Voya).

**NOTE 5 – GROUP ANNUITY CONTRACT**

The Plan holds a fully benefit-responsive investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with interest credited on amounts held and charged for participant withdrawals and administrative expenses. The account is also credited with declared rates of interest and is subject to a minimum rate described in the contract. The interest credit rate may be subject to change periodically based upon contract provisions, and it may not be less than 1%.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The plan's ability to receive amounts due is dependent on Voya's ability to meet its financial obligations. Voya's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Voya. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Voya and that also would limit the ability of the Plan to transact at contract value with participants. In addition, certain events allow Voya to terminate the contract with the Plan and settle at an amount different from contract value. The Company believes that any such events that would allow Voya to settle at an amount different than contract value are probable of not occurring.

**NOTE 6 – TAX STATUS**

On June 30, 2020, the Internal Revenue Service (IRS) stated the volume submitter profit sharing plan with CODA adopted by the Plan, as then designed, qualified under Internal Revenue Code (IRC) section 401. Although the Plan has been amended from the original pre-approved document, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no other audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

**NOTE 7 – PARTY IN INTEREST TRANSACTIONS**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan held investments managed by Voya. Certain professional fees for the administration and audit of the Plan were paid by the Company. Various administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Notes receivable from participants reflect party in interest transactions.
