### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Advisors Excel, LLC 401(k) P/S Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

### (1) Description of the Plan

#### (a) *General*

The following description of the Advisors Excel, LLC 401(k) P/S Plan (the Plan) is provided for general informational purposes only. Terms of the Plan are more fully described in the Plan document, which is available to each participant. The Plan is a defined contribution plan that is qualified under Section 401 of the Internal Revenue Code (IRC) and covers employees of Advisors Excel, LLC (the Company) or a participating employer who are 21 years or older. Employees are eligible to participate on the date of hire and plan entry is available on the first day of each calendar month coinciding with or next following that date. Employees are eligible for employer matching and profit sharing contributions on the first day of the calendar month coinciding with or next following the date on which three months of service are completed. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

The Company is the plan sponsor. The plan is administered and assets are held by Empower Annuity Insurance Company of America and Empower Trust Company (Empower Retirement). The trustee and custodian is Empower Retirement.

#### (b) *Contributions*

Participating employees may elect to contribute to the Plan a maximum of 100% of their eligible compensation, as defined by the Plan, and subject to certain limitations under the IRC. These participant contributions are made on a pretax basis. The Company also offered employees the option to make Roth contributions. The Roth contributions made by the employee are included in the employee's income at the time of deferral and are segregated with a separate Roth account within the Plan. The participant's total combined Roth and pretax contributions are subject to the IRC limitations noted above. Additionally, participants who attained the age of 50 could contribute additional amounts. These catch-up contributions are not subject to the employer matching contribution.

Employee contributions are matched 100% up to 3% and then 50% up to 8%, with a maximum employer matching contribution of \$8,000. Additionally, the Company may make a discretionary contribution. In 2024 and 2023, the Company made no discretionary contributions. Discretionary contributions would be included in Employer Contributions in the statement of changes in net assets available for benefits.

Participants have the option to direct the investment of their contributions, rollover contributions, and the matching employer's contributions in any combination of the investment options offered by the Plan.

Participants may rollover funds into the Plan from any qualified plan, subject to the approval of the plan administrator. Rollover contributions earn investment income and share in investment gains or losses. Participants are 100% vested in rollover contributions. Participants may rollover Roth funds into a segregated Roth account within the Plan.

#### (c) *Participant Accounts*

Each participant's account is credited with the participant's contribution, the Company's matching and discretionary contributions, and an allocation of Plan earnings and administrative expenses. The earnings allocation is based on the performance of the participant's allocated investment fund

balances. The benefit to which a participant is entitled is the vested portion of the participant's account.

Participants may make transfers between existing fund balances at any time. Participating employees may change future investment elections at any time upon notification to the Plan.

**(d) Participant Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Current Company matching contributions and Company discretionary contributions are subject to the following vesting schedule:

<u>Years of vesting service</u>	<u>Percentage vested</u>
Less than 2 years	—%
2 years but less than 3 years	20
3 years but less than 4 years	40
4 years but less than 5 years	60
5 years but less than 6 years	80
6 or more years	100

A participant will become fully vested in the value of all Company contributions in the event of death, permanent and total disability, or attainment of Normal Retirement Age, regardless of the participant's years of vesting service. A year of vesting service generally is each Plan year during which the participant earns at least 1,000 hours of service and is over the age of 21.

**(e) Forfeitures**

Forfeitures are based on the nonvested portion of the Company's contribution upon employee termination. Forfeited amounts are applied as a reduction of contributions by the Company or by participating employers. Forfeitures were used to reduce the Company's contribution by \$210,961 in 2024 and \$192,594 in 2023. The balance of unallocated forfeitures available to offset future Company contributions amounted to \$12,988 and \$24,472 at December 31, 2024 and 2023, respectively.

**(f) Notes Receivable from Participants**

An active participant may borrow from the Plan amounts collateralized by the vested portion of his or her Plan account. The participant must have a minimum vested account balance of \$2,000. The maximum loan amount that a participant may request is \$50,000 or 50% of the vested account balance, whichever is less. The loans are repaid through payroll deductions over terms, which are based upon the amounts borrowed and the term of the loan. There are two types of loans available from the Plan, General Purpose Loans and Principal Residence Loans. General purpose loans have a term of 12-60 months. Principal Residence Loans have a term of 61-120 months and must be utilized for the purchase of a primary residence. The interest rate is 1.5% over the Prime Rate published in the Wall Street Journal on the first business day of the month the loan is originated. The interest rate is fixed throughout the life of the loan. The participant may continue to make contributions to the Plan throughout the term of the loan. A setup fee for new loans is deducted from the respective participant's account.

**(g) Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses incidental to the administration of the Plan may be paid by the Company, and, if not paid by the Company, shall be paid by the Plan.

**(h) Distributions**

Distributions of vested account balances are available upon termination, retirement, death, or permanent and total disability. Distributions are made in lump-sum amounts or annual installments to the participant or designated beneficiaries.

**(2) Summary of Significant Accounting Policies**

**(a) Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America.

**(b) Investments**

The Plan's investments are held in an account at Empower Retirement. On each valuation date, as defined by the Plan, securities held by the Plan are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The increase or decrease in the value of securities held, plus any net income or loss of the Plan, is allocated to the participant's accounts. Refer to the Fair Value Measurements note for additional valuation information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**(c) Notes Receivable from Participants**

Notes receivable from participants are carried at amortized cost and are measured as the unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions, based upon the terms of the Plan document.

**(d) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**(e) Payment of Benefits**

Distributions to the participants of the Plan are recorded when paid.

### (3) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### (4) Certification of Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### (5) Federal Income Taxes

Effective March 2, 2015, the Plan adopted a nonstandardized form of a prototype plan sponsored by Empower Trust Company, LLC. The prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, as to the prototype's qualified status. The prototype plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (6) Fair Value Measurements

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or

liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2 – Inputs to the valuation methodology include:
  - Quoted prices for similar assets and liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**(a) Mutual Funds**

The fair value of the mutual funds is valued at the quoted net asset value of shares held by the Plan at year-end.

**(b) Common Collective Trust – Putnam Stable Value Fund**

The fund invests in benefit-responsive investment contracts issued by insurance companies and other financial institutions, fixed income securities, and money market funds and is valued at the net asset value of units. The fund seeks to maintain a stable net asset value of \$1 per share. The net asset value is used as a readily determinable fair value to estimate fair value.

Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

**(c) Common Collective Trust – Other**

Funds are valued at the net asset value of units as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the trust less its liabilities. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of a collective trust, the issuer generally reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.
