### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of University of Maryland Capital Region Health Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of University of Maryland Capital Region Health Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion—Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the University of Maryland Capital Region Health Retirement Savings Plan (the Plan) provides only general information about the Plan's provisions. Dimensions Health Corporation dba: University of Maryland Capital Region Health (the Corporation) is the Plan Sponsor. Participants should refer to the Plan Document and Summary Plan Description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

**General**

The Plan is a defined contribution plan. The Plan covers eligible employees of the Corporation excluding leased employees, employees of affiliated employers, and independent contractors. The Corporation contribution component of the Plan excludes resident physicians and common law employees. Effective December 31, 2022, employees eligible for another 403(b) plan sponsored by the Corporation and non-union employees are no longer eligible for the Plan. The Plan also permits employees of Dimensions Health Associates, who meet the same eligibility requirements of the Corporation, to participate in the Plan.

Effective December 31, 2022, accounts of non-union participants were spun off and merged into the University of Maryland Medical System 403(b) Retirement Savings Plan. During 2024, the forfeiture balance of \$429,589 that was determined to be related to non-union employees was transferred to the University of Maryland Medical System 403(b) Retirement Savings Plan. Assets and has been reflected as a payable to University of Maryland Medical System 403(b) Retirement Savings Plan as of December 31, 2023.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Eligibility**

Employees of the Corporation are eligible to participate in the deferral component of the Plan immediately upon their date of hire. Effective January 1, 2024, participants will be allowed to elect to make Roth contributions to the Plan. Employees other than resident physicians and individuals not treated as common law employees are eligible to participate in the employer contribution features of the Plan if they are at least 18 years of age. Full-time employees are eligible to receive the Corporation's base and matching contributions upon turning 18 years of age. Part-time employees are eligible to receive the Corporation's base and matching contributions upon turning 18 years of age and completing 1,000 or more hours of service during a consecutive 12-month period and being employed on the last day of the Plan year. Participants are eligible to participate in the Corporation's base and matching contributions on the first day of the month immediately following satisfying the eligibility requirements.

**Contributions**

Participants may elect to contribute to the Plan an amount up to 100% of pre-tax compensation, as defined by the Plan, subject to Internal Revenue Service (IRS) limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. Their automatic deferral percentage will increase by 1% on July 1 of each year until the Plan participant has a 10% deferral rate, unless opted out by the participant.

The Corporation makes a matching contribution equal to 50% of the first 4% of the base compensation/gross pay that a participant contributes (thereby receiving an employer maximum match of 2%) to the Plan. Employees who are budgeted to work 40 or more hours per bi-weekly pay period are considered full-time employees and receive their matching contribution on a biweekly basis. Part-time employees who are budgeted less than 40 hours per pay period but who actually work 1,000 or more hours in the Plan year and are employed on the last day of the Plan year, receive their matching contribution in an annual payment in the subsequent year.

The Corporation makes a discretionary base contribution at a rate of 2% of the employees budgeted salary. Full-time employees receive their discretionary contribution on a biweekly basis. Part-time employees who actually work 1,000 or more hours in the Plan year and are employed on the last day of the Plan year, receive their discretionary contribution in an annual payment early in the subsequent year.

In accordance with the collective bargaining agreement with 1199 SEIU Health Care Workers East – Registered Nurses Chapter, represented employees with 15 years of service receive an additional matching contribution of \$25 for each pay period in which they defer \$25 or more. This matching contribution is paid quarterly.

Employees represented by 1199 SEIU Health Care Workers East – Registered Nurses Chapter, who as of January 1, 2008, were both 55 years or older and had 15 years of vesting service, receive an additional 6.5% biweekly contribution from the Corporation. To be eligible for the supplemental grandfathering contributions, the participant must continue to work in positions budgeted for at least 40 hours per pay period.

Participants direct the investment of contributions into various investment options offered by the Plan and can change their investment options on a daily basis. All contributions are subject to certain limitations of the Internal Revenue Code (IRC).

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Corporation's matching contribution, an allocation of the Corporation's base contribution, and an allocation of Plan earnings or losses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. A participant is 100% vested in the Corporation's contributions after three years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance for terms up to five years unless the loan is for the purchase of a primary residence which can have terms up to fifteen years. A participant may not have more than one loan outstanding at any point in time. If a participant terminates employment with the Corporation, they may continue to make loan payments through a pre-authorized check agreement. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest are paid ratably through payroll deductions.

**Benefit Payments**

Upon termination of employment with the Corporation due to death, disability, retirement, or termination, a participant whose vested account balance exceeds \$5,000 may elect to receive either a lump-sum or may elect installment payments on a quarterly or annual basis. The Plan allows for in-service distributions if a participant reaches age 59½, becomes disabled, and hardship distributions subject to Plan provisions. A participant whose vested account balance is \$5,000 or less upon termination of employment will automatically receive an immediate lump-sum distribution equal to their vested account balance. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Corporation will authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Forfeited Accounts**

Forfeited nonvested accounts are first used to reduce administrative expenses and then are used to reduce future Corporation contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$330,645 and \$950,240, respectively. There were \$26,956 and \$8,773 of forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023, respectively. There were forfeitures of \$338,289 and \$0 used to reduce Corporation contributions for the years ended December 31, 2024 and 2023, respectively. During 2024, the forfeiture balance of \$429,589 that was determined to be related to non-union employees was transferred to the University of Maryland Medical System 403(b) Retirement Savings Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Contributions**

Contributions from participants and Corporation contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Corporation and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing benefit payments are charged directly to the participant's account and are included in administrative expense. Investment adviser and audit expenses are paid by the Plan and are included in administrative expenses. The investment management expenses paid by the Plan are included in net appreciation in fair value of the investment. The Plan received \$17,620 of shared revenue, for which \$17,635 was used to pay Plan expenses during the year ended December 31, 2023. There was no activity in the shared revenue account during the year ended December 31, 2024. As of December 31, 2024 and 2023, the shared revenue account totaled \$-0-

**Subsequent Events**

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively referred to as Empower), the qualified institutions of the Plan, have supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued and traded on an active market at stable \$1.00 NAV.

**NOTE 5 INVESTMENT CONTRACT (GUARANTEED INTEREST ACCOUNT)**

The Plan entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged with participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer subject to a maximum of 3.00% and a minimum of 1.00%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE 5 INVESTMENT CONTRACT (GUARANTEED INTEREST ACCOUNT) (CONTINUED)**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) the investor provides communication that the contract will be terminated as of a date at least thirty days after the communication, (2) a breach of material provision under the contract and such breach is not cured by the Plan within ten business days, (3) the Plan provides written notification the agreement will be terminated, (4) the portion of the market value account attributable to the Plan is not more than \$1,000 or the contract value is zero, (5) the issuer determines that it will not be able to continue to operate the agreement under the current terms following the Plan's establishment, activation, or material change to any Plan investment, and (6) the Plan fails to make contributions as set forth in the contract.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Corporation has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in the Corporation's contributions.

**NOTE 8 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter from the IRS on the pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 PARTY-IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by the qualified institution and record-keeper as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 10 NONEXEMPT TRANSACTION**

The Corporation failed to remit employee deferral contributions for one payroll for the year ended December 31, 2022 and for certain participants on various payrolls for the year ended December 31, 2023 within the timeframe prescribed by the Department of Labor. These are deemed to be prohibited transactions in accordance with ERISA and the IRC. The Corporation corrected the prohibited transactions for the years ended December 31, 2023 and 2022 by depositing the lost earnings.
