### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Anco Insurance Managers, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Anco Insurance Managers, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Anco Insurance Managers, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 7 to the financial statements, the Board of Directors of Anco Insurance Managers, Inc. approved a plan of liquidation on November 1, 2024, and management determined liquidation is imminent. As a result, Anco Insurance Managers, Inc. 401(k) Plan changed its basis of accounting from the going concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

1. Description of Plan

The following description of the Anco Insurance Managers, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions. See Note 7 regarding Plan termination.

- (a) *General.* The Plan, adopted March 1, 1993, is a defined contribution plan covering all employees of the Company who have completed six months of service, 500 hours, and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2003, the Plan is referred to as a “safe harbor 401(k) plan.” The Administrative Committee is responsible for oversight of the Plan. In addition, the Administrative Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Company’s Board of Directors.
- (b) *Contributions.* Participants may contribute 100% of pretax annual compensation up to limits specified by the Internal Revenue Code as a salary deferral election. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers 28 funds with varying degrees of risk as investment options for participants. Beginning January 1, 2017, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated target fund until changed by the participant. In order to maintain “safe harbor” status, the Company began making safe harbor matching contributions beginning January 1, 2003, by contributing an amount equal to 100% of the first 4% of each participant’s contribution. Prior to this, the Company made matching contributions by contributing an amount equal to 50% of the first 6% of each participant's contribution. Contributions are subject to certain IRS limitations.
- (c) *Participant Accounts.* Each participant's account is credited with the participant's contributions and Company safe harbor matching contributions and allocations of the Company's discretionary contribution and Plan investment earnings. Participant accounts are charged with an allocation of plan expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- (d) *Vesting.* Participants are immediately vested in their voluntary contributions, rollover contributions, and safe harbor matching contributions plus actual earnings thereon. Prior to Plan termination, vesting in the remainder of their accounts plus actual earnings thereon was based on years of continuous service as follows:

- (e) *Notes Receivable from Participants.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 3.25% to 9.25%. Loan terms may not exceed 5 years, or 15 years for the purchase of a primary residence. Principal and interest is paid ratably through semi-monthly payroll deductions.
- (f) *Payment of Benefits.* On termination of service, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant at age 59 ½ may obtain an in-service distribution from all fully vested accounts.
- (g) *Forfeited Accounts.* At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$195 and \$162, respectively. These accounts will be reallocated to participants, used to pay plan expenses, or used to offset employer contributions in a future year. However, the Board resolution to terminate the Plan effective November 1, 2024, specified that forfeitures were to be allocated to participant accounts as of the termination date. This allocation was not completed. Instead, the funds will now be used to pay Plan expenses prior to final liquidation.

2. Summary of Accounting Policies

*Basis of Accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates.* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition.* Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Voya.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

*Payment of Benefits.* Benefits are recorded when paid.

*Expenses.* Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) of fair value of investments.

*Subsequent Events.* The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

3. Information Prepared and Certified By Custodian

The following information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023 and net appreciation/(depreciation) in fair value of investments, interest and dividends, for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company (the custodian of the Plan).

4. Group Annuity Contract with Insurance Company

In 2004, the Plan entered into a traditional fully benefit-responsive investment contract with ING Life Insurance and Annuity Company which became Voya Retirement Insurance and Annuity Company in 2014. The contract totaled \$431,792 at December 31, 2024, and \$2,292,595 at December 31, 2023. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 3.00% for both 2024 and 2023 for the Voya Fixed Account. The custodian guarantees the credited rate for this account will never fall below the lifetime guaranteed minimum of 3.00%. In October 2017, the Voya Fixed Account A was added to the portfolio. The crediting interest rate was 1.60% for 2024. The crediting interest rate was 1.35% for the first quarter of 2023, 1.50% for the second quarter of 2023, and 1.60% for the third and fourth quarters of 2023. This account will never fall below the lifetime guaranteed minimum of 1.00%. All new deposits are posted to Voya Fixed Account A. Funds that are currently in the Voya Fixed Account earning 3.00% will remain in the account until withdrawn by the participant. Such interest rates are reviewed on an annual basis for resetting. The contract does not permit Voya to terminate the agreement without notice.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under

the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. Plan termination did not limit the ability of the Plan to transact at contract value.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- (a) *Level 1.* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- (b) *Level 2.* Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- (c) *Level 3.* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds.* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust, under the provisions of the CCH Incorporated non-standardized pre-approved profit sharing plan with CODA, are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

On November 1, 2024, the Board of Directors of Anco Insurance Managers, Inc., the Plan's sponsor, resolved to terminate the Plan as a result of the acquisition of the Company by HUB International Texas, Inc. The effective date of the termination was November 1, 2024. Pursuant to the termination of the Plan, all affected participants were 100% vested in their respective account balances. Employee and employer contributions into the Plan ceased, as did new participant loans from the Plan. The liquidation of the Plan was deemed imminent upon the Board of Directors' resolution to terminate it. As such, in accordance with generally accepted accounting principles, the Plan has changed its basis of accounting used to value Plan assets from the ongoing plan basis to the liquidation basis for periods after December 31, 2023. In both 2024 and 2023, Plan assets were valued based on the certified investment information provided by the custodian. The final distribution of all Plan assets to participants and beneficiaries is expected to be completed by November 15, 2025. A final Form 5500 will be filed with the Department of Labor after all distributions are made.

8. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by the Plan's custodian, Voya Retirement Insurance and Annuity Company. These transactions qualify as exempt party in interest transactions.

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan.

Administrative expenses paid for the Plan by the Company, for the year ended December 31, 2024 were \$12,700.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Plan Amendment

In March 2023, Anco amended the plan to increase the initial automatic enrollment percentage by 1% on the first day of the second Plan Year following the Plan Year during which the initial automatic enrollment became effective. Subsequent deferral increases will occur on the first day of each Plan Year. The maximum automatic enrollment deferral percentage is 10%. This amendment is effective January 1, 2024.
