### **Emphasis-of-Matter**

The accompanying financial statements have been prepared assuming that Carpenters Local No. 491 Training Fund will continue as a going concern. As described in Note A to the financial statements, the Trustees of the Fund have approved a merger with the Eastern Atlantic States Carpenters Technical Centers effective December 31, 2024. The purpose of the Carpenters Local No. 491 Training Fund is the same as the Eastern Atlantic States Carpenters Technical Centers. The Carpenters Local No. 491 Training Fund operations are expected to continue, but the Carpenters Local No. 491 Training Fund is no longer considered a standalone going concern. The financial statements do not include any adjustments that might result from the outcome of this change. Our report is not modified with respect to this matter.

### **Supplemental Schedules Required by ERISA**

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets held for investment purposes, together referred to as "supplemental information," are presented for the purpose of additional analysis and are not a required part of the financial statements but are supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE A – DESCRIPTION OF FUND**

The Fund provides for the training of apprentice and journeymen carpenters as determined by the Trustees under their authority under the Trust Agreement; said Trust Agreement having been established under the terms of the collective bargaining agreement between Carpenters Local Union No. 491 and the participating employers. Each participating employer is required under the collective bargaining agreement to contribute a collectively bargained rate per employee member hour worked (50 cents per hour effective May 1, 2019 through April 30, 2025 and 50 cents per hour effective March 1, 2018 through April 30, 2019) into the Training Fund. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees of Carpenters Local Union No. 491 Training Fund have approved a merger with the Eastern Atlantic States Carpenters Technical Centers as of December 31, 2024. Although the purpose of the Carpenters Local No. 491 Training Fund is the same as the Eastern Atlantic States Carpenters Technical Centers, and the operations of the Carpenters Local No. 491 Training Fund are expected to continue, the Carpenters Local No. 491 Training Fund is no longer considered a standalone going concern.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICES**

- A. Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting which is in accordance with accounting principles generally accepted in the United States of America.

The Fund prepares its annual information returns on the same basis as the financial statements.

In connection with the Carpenters Local No. 491 Training Fund merging with and into the Eastern States Carpenters Technical Centers, the assets and liabilities as of December 31, 2024 have been transferred and assumed by the Eastern Atlantic States Carpenters Technical Centers as well as the operating activities of Carpenters Local No. 491 Training Fund. Accordingly, the financial statements of Carpenters Local No. 491 Training Fund have been presented as a going concern. There have been no adjustments to the financial statements, as presented, as a result of this merger.

- B. Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Fund administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

- C. Expenses – All operating expenses of the Fund are paid by the Fund.

**NOTE C – TAX EXEMPT STATUS**

The Internal Revenue Service (IRS) has determined and informed the Carpenters Local Union No. 491 Training Fund by a letter dated April 1, 1994, that the Fund is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Fund has been amended since receiving the determination letter. However, the Fund Administrator and the Fund’s tax counsel

believe that the Fund is designed and is currently being operated in compliance with the applicable requirements of IRC.

Accounting principles generally accepted in the United States of America require the Fund administrator to evaluate tax positions taken by the Fund and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Fund is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Fund administrator believes the Fund is no longer subject to income tax examinations for years prior to December 31, 2021.

**NOTE D – FUND TERMINATION**

In the event the Fund terminates, net assets are to be used to provide for the payment of any and all obligations of the Fund. Such payment shall be for the exclusive benefit of the employees, their families, dependents or beneficiaries, and the administrative expenses of the Fund. Effective December 31, 2024, the Carpenters Local No. 491 Training Fund was merged with the Eastern Atlantic States Carpenters Technical Centers.

**NOTE E – PLAN NAME CHANGE**

The name of the Fund and Trust was changed to the Carpenters Local Union No. 491 Training Fund and Carpenters Local Union No. 491 Training Trust effective January 1, 2004. The previous name of the Fund and Trust was Cabinetmakers Local No. 974 and Carpenters Local No. 1110 Training Fund or Trust.

**NOTE F – PARTY IN INTEREST TRANSACTIONS**

Party in interest transactions consist of audit and accounting fees of \$6,975 and contract administrator fees of \$18,211 and are reflected on the Statements of Changes in Net Assets Available for Benefits.

**NOTE G – RISKS AND UNCERTAINTIES**

Cash is held at banking institutions which are insured up to \$250,000 by the Federal Deposit Insurance Corporation (FDIC). The Plan had no uninsured balances as of December 31, 2024 and 2023, respectively.

**NOTE H – DATE OF MANAGEMENT’S REVIEW OF SUBSEQUENT EVENTS**

Events that occur after the date of the financial statements, but before the financial statements were available to be issued must be evaluated for recognition or disclosure. The effects of subsequent events that provide evidence about conditions that existed at the date of the statement of net assets available for benefits are recognized in the accompanying financial statements and notes. Management evaluated the activity of the Fund through September 25, 2025 and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements.
