Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Graco Interests, Inc. Note 1 – Plan Description

The following brief description of the Graco Interests, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description and the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution benefit plan covering substantially all employees of Graco Interests, Inc., Graco Mechanical, Inc., Graves Mechanical, Inc., and Graco Metals, Inc. (collectively, the “Company” or “Employer”). The Plan commenced effective January 1, 1973, and was amended and restated effective January 27, 2022, to comply with the latest rules and regulations. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodians and Trustee

Effective August 1, 2022, Empower companies changed the legal name of Great-West companies to Empower. Empower Trust Company, LLC (“Empower”) and Empower Annuity Insurance Company of America (collectively, the “Custodians”) are the Custodians maintaining custody of all investments held by the Plan. Empower Retirement, LLC (the “Recordkeeper”) maintains the Plan’s participant account balances and provides recordkeeping services to the Plan. Among other duties, the Recordkeeper receives contributions, holds and invests the fund assets in accordance with the direction of participants, and makes distributions as directed by the Plan Administrator. Certain officers of the Company serve as Trustees of the Plan.

Eligibility and Plan Entrance Date

Certain employees are not eligible to participate in the Plan, including union employees covered by a collective bargaining agreement. All other employees become eligible to participate in the Plan reaching 20½ years of age and completing one year of service. A year of service is defined as completion of at least 1,000 hours of service during the computation period, which is the anniversary date of the first hour completed by the employee. Eligible employees are permitted to enter the Plan quarterly, upon the first day of each quarter coincident with or next following satisfaction of the eligibility requirements.

Contributions

Participants may elect to contribute, on a pre-tax basis, a certain percentage or dollar amount of up to 50% of their eligible compensation, subject to the maximum amount permitted for deferral annually by the IRC, which was \$23,000 for 2024. Participants who have reached the age of 50 before the end of the Plan year are eligible to make additional catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified benefit plans (“rollovers”), provided such contributions are approved by the Plan’s Administrator.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation.

The Employer may make discretionary matching contributions on behalf of eligible participants who contribute to the Plan. For the Plan year ended December 31, 2024, the Employer made matching contributions to the Plan on behalf of participants in an amount equal to 25% of each participant’s contribution, up to 5% of the participant’s eligible compensation.

Note 1 – Plan Description (continued)

Contributions (continued)

Additionally, the Employer may make discretionary profit-sharing contributions, as determined by the Employer. The profit-sharing contributions are allocated to all eligible employees based on designated job classification, as determined by the Plan Sponsor. All employees within each job classification receive a pro-rata share of the job classification's contribution, based on compensation. Participants may share in the Employer profit-sharing contribution if the employee is employed on the last day of the Plan year, or such employee has completed more than 500 hours of service during the Plan year.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. Participants may direct their account balances to one or more of these investment options, which vary in types of investments, rates of return, and investment risk.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer matching and profit-sharing contribution, and earnings thereon, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested with respect to their own contributions and actual earnings thereon. Vesting in Employer contributions and related earnings is based upon years of service. Such contributions vest at a rate of 20% each year following the participant's first year of service, provided the participant completes 1,000 hours of service each year. A participant becomes 100% vested after 6 years of service, or upon death or total and permanent disability.

Payment of Benefits

The payment of benefits to a participant may occur upon such participant reaching the age of 59½, retirement, disability, death, or other termination of employment. Upon normal retirement (defined as age 65), disability, or death, a participant or their beneficiary is entitled to receive 100% of the participant's account balance. For all other terminations, a participant or their beneficiary is entitled to receive the vested portion of the participant's account balance. Benefits may be paid in a lump sum, annuity, or installments equal to the vested value of the participant's account. Terminated participants whose vested account balances are less than \$5,000 receive automatic distributions as a single lump sum payment. In addition, financial hardship withdrawals are permitted by the Plan for those participants who have incurred a substantial financial hardship.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$99,079 and \$41,908 respectively. These accounts will be used to reduce future Employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as those held during the year.

Payment of Benefits

Benefits payments are recorded when paid.

Administrative Expenses

Charges for withdrawals for payment of benefits to participants and the Plan's recordkeeping fees are paid by the Plan and are reflected in these financial statements as Plan administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and are included in net appreciation of fair value of investments. All other expenses of the Plan are paid by the Employer.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements presented herein were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.
- **Common Collective Trusts** – The Blackrock Common Collective Trusts and Franklin Common Collective Trust (“CCTs”) are determined by the NAV provided by the fund administrator. Although the NAV unit prices are quoted on a private market that is not active, the unit prices are based on underlying investments which are traded on an active market (“market approach”). There are no restrictions on the NAV price or its equivalent, participant transactions (purchases and sales) may occur daily, and there are no unfunded commitments. There are no significant restrictions on participant redemptions; however, if the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require up to 60 days’ notification in order to ensure that securities liquidations will be carried out in an orderly manner.

Note 5 – Guaranteed Investment Contract with Insurance Company

As of December 31, 2022, the Plan held a fully benefit-responsive group annuity contract, Empower Investments Fixed Account - Series Class IV, with Empower Annuity Insurance Company of America. The Empower Investments Fixed Account - Series Class IV is a general account product of Empower Annuity Insurance Company of America. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, and prevailing market conditions. The interest crediting rate is reset quarterly.

The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount which would be received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with Empower Annuity Insurance Company of America. Such events include premature termination of the contracts by the Plan, layoffs, Plan termination, bankruptcy, mergers, and early retirement incentives. The Plan does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable. There are no reserves against contract value for credit risk of Empower Annuity Insurance Company of America or otherwise.

Note 6 – Related Party Transactions and Party-in-Interest Transactions

Plan investments are managed by the Custodians; as such, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 8 – Tax Status

The Plan adopted a non-standardized, preapproved profit-sharing plan sponsored by Empower. The Internal Revenue Service ("IRS") has determined and informed Empower, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
