Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Convergenz 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Convergencz 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2008, as a defined contribution plan under the provisions of Internal Revenue Code (IRC) Section 401(k). The Plan provides employees eligible to participate an opportunity to accumulate funds for retirement, death and disability benefits. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). For the Plan years ended December 31, 2024 and 2023, any employee of Convergencz, LLC (the Company) who completed three months of service and attained 21 years of age, was eligible to participate in the Plan. Plan entry dates are the first day of each month. The management of the Company has the authority and responsibility for the general administration of the Plan. Principal Life Insurance Company, the custodian and trustee of the Plan (the trustee), has the authority and responsibility to hold, manage, and protect the assets of the Plan in accordance with the provisions of the Plan and the separate trust agreement. Principal Trust Company provides record-keeping services to the Plan and to individual participants.

Contributions

Effective January 1, 2020, the Plan amended enrollment to automatically enroll eligible participants at a pre-tax deferral rate of five percent to the Plan. Participants are allowed the option to elect voluntarily not to participate or change the pre-tax deferral rate in the Plan. Eligible participants who have attained age 50 before the end of the Plan year are also entitled to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a common collective trust, pooled separate accounts, and a guaranteed investment contract as investment options for participants. The Company does not make matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Plan earnings (losses) and charged with an allocation of administrative expenses. Administrative expenses allocated to participant's accounts are based on formulas determined by the individual investment fund manager and are netted against the Plan earnings. Allocations are based on participant account balances or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

The Plan does not allow participants to borrow from their fund accounts.

Vesting of Accrued Benefits

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon.

Benefits and Withdrawals

Participants may receive benefit payments based on their account balance, in either a lump sum or in installments, upon attaining the age of 59½. However, distributions of the participant's account balance must begin no later than age 72. Participants or beneficiaries may make withdrawals of their vested account balance prior to attaining age 59½ only in the event of death, disability, termination of employment, or reasons of proven financial hardship. Participants may make hardship withdrawals if they have an immediate and heavy financial need and other resources are not available to meet the need. Using the "deemed hardship" rules of Reg. 1.401(k)-1(d)(3)(iii)(B), such needs include medical, tuition, and funeral expenses of the primary beneficiary. Terminated participants with vested account balances equal to or less than \$1,000 are automatically distributed to the participant. Corrective distributions are made to participants whose contributions for the year exceed the maximum allowed under the Plan.

Investment Options

The Plan maintains a contract with the trustee which provides for investment of contributions, at participants' direction, in various mutual funds, common collective trusts, pooled separate accounts, and a guaranteed investment contract.

Fidelity Bond

The Plan was covered by a \$1,000,000 fidelity bond during 2024 and 2023.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accounting records are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of the defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition (continued)

Sales and purchases of investments are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of its investments includes the Plan's realized gains or losses and the unrealized appreciation (depreciation) on investments bought and sold as well as held during the year.

Administrative Expenses

All administrative expenses of the Plan, except for processing fees, were paid by the Company.

Benefits Paid

Benefits are recorded upon distribution. As of December 31, 2024 and 2023, there were no amounts allocated to withdrawing participants for benefit claims that have been processed and approved for payment, but not yet paid.

Withdrawals

Subject to certain terms and conditions, active participants may withdraw from the amount of their account.

Custodian

All of the Plan assets are held by Principal Life Insurance Company as of December 31, 2024 and 2023.

Subsequent Events

The Plan administrator has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - TAX STATUS

The Plan and related trust were established using a volume submitter defined contribution plan and the Internal Revenue Service has determined by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC.

The Plan is required to measure, recognize, present, and disclose in its financial statements uncertain income tax positions the Plan has taken in the tax years that remain subject to examination or expects to take on an income tax return. The Plan recognizes the tax benefits from uncertain income tax positions only if it is more likely than not that the tax position will be sustained on examination by tax authorities. Prior year tax returns may be subject to examination in various tax jurisdictions, most of which define open tax years as three years from the later of the due date or the date the return was filed. The Plan has not recorded a liability for uncertain income tax positions for any open tax years.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balance.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others.

The Plan holds units of mutual funds managed by the trustee, therefore, these transactions and the Plan's payment of trustee fees to Principal Life Insurance Company qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

NOTE 7 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan's investments are held in a trust fund by the trustee. The trustee of the Plan holds investment assets and executes transactions therein, and all investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the accompanying financial statements, footnotes, and the supplemental schedule, have been derived from statements prepared and certified as being complete and accurate by the trustee. This information has not been audited by independent accountants.

NOTE 8 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

GAAP establishes a three-level disclosure hierarchy to indicate the level of judgment used to estimate fair value measurements:

- Level 1 - Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.
- Level 2 - Inputs consist of observable inputs other than quoted prices for identical assets.
- Level 3 - Inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. As of December 31, 2024 and 2023, the Plan held no mutual fund investments requiring the use of Level 2 or Level 3 inputs.

The fair value of mutual funds are based on the closing price reported on the active market where the funds are traded regularly. The fair value of money market funds are based on the original cost of the underlying securities.

Common collective trust (CCT): The Great Gray Collective Investment Trust Company (the Trust) is a common collective trust managed and distributed by Great Gray Trust Company, LLC. The Trust is only available for investment by eligible, qualified retirement plan trusts.

NOTE 8 - FAIR VALUE MEASUREMENTS (continued)

The CCT fund primarily invests in mutual funds authorized under the Trust. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Trust is valued at net asset value (NAV) of the units held by the Plan. The NAV is not a publicly quoted price in an active market but is available to current investors via the Plan custodian website or when Plan participants access their account values. Participant transactions (purchases and sales) may occur daily. Therefore, those investments are considered to have a readily determinable fair value.

Pooled separate accounts: These investments are held by the trustee and are valued using the NAV provided by the custodian of the fund. They can be redeemed daily and are not subject to withdrawal limitations. The NAV is based on the value of the underlying assets owned by the fund, which was obtained utilizing observable market information, minus its liabilities and then divided by the number of shares outstanding. Therefore, those investments are considered to have a readily determinable fair value. The following tables set forth, by level within the fair value hierarchy, the Plan's investments at fair value:

NOTE 9 - GUARANTEED INVESTMENT CONTRACT

The Principal Fixed Income Guaranteed Option is a benefit-responsive group annuity contract issued by Principal Life Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value represents contributions made, plus earnings, less participant withdrawals, and administrative expenses.

Under the terms of the existing contract, the composite crediting rate is currently reset on a semiannual basis and will never be less than the guaranteed minimum interest rate. The methodologies for calculating the interest crediting rate and guaranteed minimum interest rate are defined in the contract. It is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets. As a result, the average yield earned by the Plan is the yield earned on the group annuity contract.

Certain events limit the ability of the Plan to transact at contract value. Such events include an employer-level liquidation of this option and will be subject to a 12-month irrevocable advance notice or a five percent surrender charge. Also, the surrender charge will apply if the cumulative percentage of participant transfers from this option exceed 25 percent of the Plan's interest during the 12 preceding months prior to an employer-level surrender. This charge will be billed to the Company. Finally, to avoid an equity wash, transfers from this option must be directed to any non-competing investment option under the Plan for 90 days prior to transfer to a competing option.
