### INDEPENDENT AUDITOR'S REPORT

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Rice Companies Profit Sharing Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by a bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

The Plan is a defined contribution plan which provides for the participation of all employees of D.E. Rice Construction Co., Inc., and related participating employers (the Company) who have completed one year of service. Under the Plan, each participant has an account for his/her salary deferral contributions, any rollover contributions and employer matching and discretionary contributions, if any. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended, and is intended to qualify under Section 401(k) of the Internal Revenue Code.

**American United Life Insurance Company** serves as the Plan's investment custodian and record keeper, and is responsible for executing all investment transactions.

##### **Contributions**

Participants may make salary deferral contributions on a tax-deferred basis through payroll deductions (limited to certain amounts allowed under the Internal Revenue Code). Participants who have attained age 50 before the end of the plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make discretionary matching contributions. During 2024, the Company matched 50% of each participant's contribution up to 6% deferral. Participant and Company contributions are subject to the provisions of the Internal Revenue Code and related regulations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of (a) Company contributions, (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Notes Receivable from Participants**

Participants may borrow the lesser of one-half of their vested account balance or \$50,000. The minimum loan available is \$1,000. Loan terms range from one to five years. Participant's loans are secured by the balance in the participant's account and are repaid through payroll deductions. Interest rates on the participant loans are set annually by the Plan administrator at a rate determined to be reasonable. Rates of interest on outstanding loans ranged from 5.25% to 7.25% during the plan year.

##### **Vesting**

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Participants vest in the employer matching and any discretionary contributions plus actual earnings thereon gradually between their 2<sup>nd</sup> year of service (20%) and their 6<sup>th</sup> year of service (100%). Participants' accounts become fully vested upon attainment of the normal retirement age of 65 or in the event of death or total disability.

#### NOTE 1 - DESCRIPTION OF THE PLAN (continued)

##### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. These accounts are utilized to reduce the Company matching contributions. During 2024, forfeitures of approximately \$16,200 were used to reduce employer matching contributions.

##### **Payment of Benefits**

Benefits are recorded when paid. Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum distribution. Distributions may be deferred until the participant reaches the age of 70 ½ if the value of the distribution is not less than \$1,000. However, the Plan agreement stipulates that distributions must commence no later than April 1 of the year following the year in which the participant reaches the age of 70 ½, with the exception of deferment until retirement.

In certain hardship situations, as described in the Plan agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship. Participants' withdrawals are limited to deferred account balances and may not include any earnings thereon.

##### **Investment Options**

Upon enrollment in the Plan, a participant may direct his/her contributions in any of the investment options currently available as determined and selected by the Plan's management. Participants may change their investment allocations daily, via phone or internet access to the Plan's investment custodian.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Basis of Presentation**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

##### **Subsequent Events**

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

##### **Contributions**

Participant contributions and employer matching contributions are recognized during the period in which the respective payroll deductions are made.

##### **Payment of Benefits**

Benefit payments are recorded when paid.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

##### **Investment Valuation and Income Recognition**

Investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value), as determined by the investment custodian. Quoted market prices are used to determine the fair value of shares in registered investment companies. Pooled separate accounts are valued based on the net asset value of the shares of the underlying investment adjusted for any dividends or distributions received and the daily equivalent of any fee charged by the custodian.

Notes receivable from participants are reported at amortized cost, which approximates fair value. In accordance with stating assets at fair value, net unrealized appreciation or depreciation is reflected for the year on the Statement of Changes in Net Assets Available for Benefits. See Note 6 for disclosure of fair value measurements.

Gains or losses on security transactions are recorded as the difference between proceeds received and the carrying value of the investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Investment dividends and interest are reinvested in the corresponding accounts.

##### **Administrative Expenses**

The Plan pays for trustee, administrator, and investment management fees from Plan assets. All other costs of the Plan are paid by the Company and are not reflected in these financial statements.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosures of contingent assets and liabilities at the date of the financial statements and the changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### NOTE 3 - INFORMATION CERTIFIED BY AMERICAN UNITED LIFE INSURANCE COMPANY

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that the information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets at December 31:

The custodian also certified to the completeness and accuracy of \$635,485 of net appreciation in fair value of investments and \$28,040 of interest income on notes receivable from participants for the year ended December 31, 2024.

#### NOTE 4 - PLAN TERMINATION

Although it has not expressed the intent to do so, The Company reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants will become 100% vested in their accounts and the Plan assets will be distributed in a manner approved by the Internal Revenue Service.

#### NOTE 5 - INCOME TAX STATUS

The Plan has not received a determination letter on their adoption of the non-standardized pre-approved plan. In accordance with Revenue Procedure 2003-6, the Plan administrator has chosen to rely on the opinion letter, dated November 30, 2020, that has been issued to the non-standardized pre-approved plan. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

#### NOTE 6 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at the net asset value of the shares of the underlying investment adjusted for any dividends or distributions and the daily equivalent of any fee charged pursuant to the annuity contract.

**Changes in Fair Value and Related Gains and Losses**

During 2024, the Plan’s investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$635,485, along with \$28,040 of interest income on participant notes receivable.

**NOTE 7 - STABLE VALUE ACCOUNT WITH AMERICAN UNITED LIFE INSURANCE COMPANY**

The Plan maintains a traditional fully benefit-responsive guaranteed investment contract with American United Life Insurance Company (AUL) with an outstanding balance of \$457,127 and \$391,205 as of December 31, 2024 and 2023, respectively. AUL maintains the contributions in a general account. The account earns interest at the higher of the rate guaranteed under the contract or the current rates established and declared in advance by AUL. Interest rates for new contributions are declared prior to the beginning of a calendar quarter and are applicable to all contributions received in that quarter until the end of the calendar year next following the current year.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

The Stable Value Account has no maturity date and continues until all assets have been distributed, or no further payments are due.

#### NOTE 8 - TRANSACTIONS WITH PARTIES IN INTEREST

Certain Plan investments are managed by AUL. AUL is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

AUL provides certain administrative services to the Plan pursuant to a Recordkeeping Agreement (RA) between the Company and AUL. AUL receives revenue from mutual fund service providers for services AUL provides to the funds. This revenue is used to offset certain amounts owed to AUL for its administrative services to the Plan.

If the revenue received by AUL from such mutual fund service providers exceeds the amount owed under the RA, AUL remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there was \$21,470 used to reduce plan expenses. The Plan or Plan Sponsor may make a payment to AUL for administrative expenses not covered by revenue sharing.

At December 31, 2024, the Plan held investments and notes receivable from participants with a current value of \$6,266,282 and \$493,683, respectively, which are managed by AUL. Thus, transactions, within these accounts, and the \$15,544 of net administrative expenses paid to the custodian qualify as party-in-interest transactions as defined by ERISA.

#### NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
