Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The First National Bank of Hutchinson Profit Sharing & 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following description of The First National Bank of Hutchinson Profit Sharing & 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan's provisions. The Profit Sharing & 401(k) Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

General - The Plan is a defined contribution plan that covers all eligible employees of the First National Bank of Hutchinson and First Kansas Bancshares, Inc. (collectively, the Company). Employees of the Company are eligible and can become participants to the salary deferrals, respective matching contributions, and Safe Harbor contributions upon the date that they attain the age of 18 and have completed three months of service. Upon completion of one year of service, employees become eligible for the profit-sharing provisions of the Plan. A year of service shall mean a 12 consecutive month period during which the employee has completed at least 1,000 hours of service. Employees are treated as participants of the Plan on the first day of the month immediately following satisfaction of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year the Plan provides that active participants may make voluntary pre-tax and post-tax contributions to the Plan between 1% and 75% of their eligible compensation up to the maximum allowed by the Internal Revenue Code (\$23,000 for 2024) as adjusted for applicable percentages of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2024). Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. The Company may make matching contributions at a discretionary rate, applied to participants' elective deferrals up to 6% of eligible compensation. Safe Harbor provisions require the Company to match 100% of the first 3% that a participant contributes to the Plan, and 50% of the next 3% that a participant contributes to the Plan. In addition, the Company may make a profit-sharing contribution. Participants direct the investment of their contributions, as well as their portion of the Company's contributions, into various investment options offered by the Plan. Participants may change the level of their contributions monthly.

The Plan utilizes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan within 90 days. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contribution invested in a designated balanced fund until changed by the participant. Deferral rates automatically increase by 1% per year up to a maximum of 10% of compensation. Effective January 2, 2025, the Plan was amended to increase the automatic escalation cap to 75% of eligible compensation.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the Company's contribution, Plan earnings, and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions and the Company's Safe Harbor contributions, plus the earnings thereon. Participants shall be fully vested with respect to Company matches and profit sharing contributions upon early or normal retirement age, death or disability. Otherwise, vesting is based on years of service. A participant is fully vested after six years of credited service.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance (reduced by the highest outstanding loan balance during the 12-month period), whichever is less. The loans, limited to two outstanding at a time, are secured by the balance in the participant's account and bear interest at the Wall Street Prime rate. Principal and interest is paid ratably through payroll deductions. Notes receivable may not exceed five years unless the note is for the purpose of purchasing a personal residence, in which case the term may be up to 15 years.

Retirement Age - Normal retirement age is 62 years of age.

Payment of Benefits - Upon termination of service for any reason, if a participant's balance is less than \$5,000, their benefit equal to the value of the participant's vested interest in his or her account will be distributed in a lump sum payment. For balances greater than \$5,000, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account, in the form of a lump sum payment or installments.

Forfeitures - Forfeitures can be used to pay administrative expenses of the Plan or reduce the Company's profit sharing contribution. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,605 and \$3,275, respectively. In 2024, \$8,205 of forfeitures were used to pay administrative expenses of the Plan, and \$3,654 of forfeitures were used to reduce the Company's profit sharing contribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates - The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition - Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Profit Sharing & 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors. Purchases and sales of securities are recorded on a trade-date

basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance has been recorded as of December 31, 2024 and 2023 for these notes receivable. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of the Plan may be paid directly by the Company and are therefore excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Some investment related expenses may be included in net change in fair value of investments.

Subsequent Events - These financial statements considered subsequent events through October 2, 2025, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY INTRUST BANK, N.A. (UNAUDITED)

The following is a summary of the investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by INTRUST Bank, N.A. (Intrust), a qualified institution, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Intrust that information provided to the Plan Administrator by Intrust related to the following is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information below, the fair values in Note 4, and the values in the supplemental schedule related to the following assets:

Intrust also certified to the completeness and accuracy of \$6,037,118 of net change in fair value of investments and dividends and interest of \$1,014,617 related to the aforementioned Plan assets for the year ended December 31, 2024.

4. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The following are three levels of inputs that may be used to measure fair value:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds (including Money Market Funds) - These investments are valued using quoted prices in an active market.

Collective Trust Fund - The Plan invests in participation units held in a Collective Investment Trust (Trust). The underlying investment contracts in the Trust are valued using other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date.

Below are the Plan's financial instruments carried at fair value on a recurring basis by the fair value hierarchy levels described previously (there are no level 3 investments).

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are managed by Intrust (party-in-interest) and, therefore, these transactions qualify as party-in-interest transactions. The various funds' operating expense ratios ranged from 0.03% to 1.40% as of December 31, 2024. Total fees incurred and paid directly by the Plan for investment management services and other expenses were \$57,715.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions and terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the interests of the participants in the Plan shall be fully vested at the time of termination, and Intrust shall liquidate all assets of the Plan and continue to administer the Plan in accordance with its provisions until all obligations have been satisfied.

7. TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan (Pre-Approved Plan) designed to qualify under Section 401 of the Internal Revenue Code (IRC). The Plan has obtained a copy of a favorable determination letter for the Pre-Approved Plan dated June 30, 2020, upon which it is relying, that the Pre-Approved Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the Pre-Approved Plan's determination letter, the Plan Administrator and the Plan's tax counsel believe

that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that it had taken no uncertain tax positions that require recognition or disclosure in the financial statements. No provision or liability for income taxes has been included in the financial statements.

8. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
